Checks and Balances


The writers of the U.S. Constitution wanted to create a strong national government. But they also wanted to make sure that one person or group did not have too much power. That is why they separated the government's power into three branches: the legislative, executive and judicial. Each branch is given specific responsibilities and specific powers. Let's review:

The legislative branch is **CONGRESS**. This branch has the power to **MAKE LAWS**

The executive branch is THE PRESIDENT. This branch has the power to ENFORCE LAWS

The judicial branch is THE SUPREME COURT. This branch has the power to INTERPRET LAWS (ARE LAWS FAIR?)

To ensure that one branch would not have more power than another, they created a system called *checks and balances*. Each branch is able to "check" the power of another branch. By checking each branch, power is balanced among them.
