Community PARTNERS

Columbus Regional Health Foundation is grateful for our extraordinary community partners who are putting donor gifts to immediate use by actively improving access to good healthcare in Bartholomew and surrounding counties. **In 2020, CRHF awarded \$84,000 from undesignated funds** to support the following community health projects.

ACCESS-ABILITY \$35,000

Health crises or injuries can be overwhelming, and people often have limited resources, forcing some to choose between essential needs and purchasing durable medical equipment (DME) necessary for their recovery or rehabilitation at home. Or some simply may need access to a safe home or work environment due to physical challenges. Fortunately, Access-Ability provides access to those in our community with mobility and home healthcare challenges by assisting them with Medicaid enrollment and by providing them with no-cost DME such as wheel chairs, walkers



and bathroom transfer benches. Additionally, they work closely with CRH to ensure patients in need have these items before being discharged.

Extraordinary COMMUNITY PARTNERS (CONT'D)



JUST FRIENDS ADULT DAY SERVICES \$22,750

As people age their social support system can decline, which can result in poor physical and mental health. Just Friends Adult Day Services offers support for those who want to remain in the community despite health related challenges, and provides caregivers with peace of mind as their loved ones are cared for during the day. Just Friends' support system mitigates the decline of physical and mental capabilities, thus delaying or preventing admission to a nursing facility. Additionally, it provides an engaging and safe place that enhances dignity, uniqueness, and independence for adults aging with challenges. Participants gain healthcare, friendship and hope regardless of income or disability.



VECINAS DE ENLACE PROGRAM \$20,000

Vecinas de Enlace is a program of Su Casa Columbus and Family School Partners offering mobility coaching and basic needs support to local Latino families in pursuit of a better life. Vecinas de Enlace are the first points of contact for Latinos in search of access to educational, healthcare, and economic mobility resources. In 2020 CRHF provided funding for Vecinas to educate their community about COVID-19 prevention and mitigation strategies. Vecinas (neighbors) live in communities with high populations of Latinos and are trained to direct neighbors to the appropriate community resources.



MILL RACE CENTER AGING WELL PROGRAMS \$6,250

Research indicates that social isolation among the elderly is a risk factor for physical and mental health complications. Mill Race Center's Aging Well System focuses on eight dimensions of wellness and is designed to get new and current members connected, engaged and most importantly aging well. It stresses the importance of wellness in all 8 dimensions of our lives; physical, spiritual, intellectual, emotional, vocational, social, environmental and financial. Programming examples include; Best Buy Tech Help, Medicare Bingo, Walking Stick Class, art, dance and fitness classes.



In addition to supporting CRH with funds to innovate or fulfill unanticipated patient care needs, COVID-19 prompted CRHF to become a bridge to our workforce, facilitating the delivery of novel forms of assistance from the community.

NEW PHOTO PRINTER FOR LABOR & DELIVERY \$350

CRHF purchased a new photo printer for the Birthing Center at CRH that is being used to provide families with a remembrance book after they experience the loss of a baby before, during or after childbirth.



ROHO CUSHIONS FOR CRH REHABILITATION SERVICES \$3,512

CRHF purchased 9 ROHO Dry Flotation Cushions for CRH Rehabilitation Services, adding to their 6 existing cushions. ROHO Cushions contain interconnected air cylinders that adjust



to movement and pressure areas and are designed to treat and prevent pressure injuries, including deep tissue injury. "The cushions offer the best level of protection against pressure ulcer issues", according to Lisa Morris, Director of CRH Rehabilitation Services.

LOCAL ENGINEERS RESPOND TO COVID-19

Local philanthropists Bob and Barb Stevens

have unselfishly given to CRHF since 1998 supporting many areas including CRH Flood Recovery, the L. Paul Berman Fund for Patient Care Excellence and the CRH Innovation Center Tecchnology Fund. Their gifts to the Innovation Center Technology Fund made possible the collaboration of approximately 40 local engineers, machinists, supply chain professionals medical professionals, volunteers, students and retirees. The Mission Columbus Team, prototyped ventilators to meet an expected supply shortage in the early days of the COVID-19 pandemic. While the respirators were never needed or used, their efforts provided hope to CRH during the very unncertain and scary early weeks of the first COVID hospitalization peak.

PALLIATIVE CARE AT CRH

SHERRY RISK STARK PROVIDES SUSTAINING SUPPORT FOR PALLIATIVE CARE \$1,052,591

As a long-time resident of Columbus and supporter of our health system, Sherry Risk Stark has served as Deputy Mayor of the City of Columbus, led numerous boards in the arts and for the benefit of our community, and currently serves on the CRH Board of Trustees, which she joined in 2014. It was in her training as a hospital Trustee that she first learned about the concept of Palliative Care. "I was immediately intrigued," she shared, "and recognized what a positive and life changing service it could offer people when they are the most vulnerable. I later was happy to learn that Our Hospice of South Central Indiana had made the commitment to begin a Palliative Care program and would be working closely with Columbus Regional Health. This innovative program struck me as just the kind of thing my parents would have chosen to support."

To honor their memory and the life lessons they taught through their service to others, Sherry established the **James Kirby Risk, Jr. and Caroline Robinson Risk Fund for Palliative Care**. The fund provides sustaining support to Our Hospice of South Central Indiana for palliative care services, a specialized type of care offering relief from symptoms for individuals with a serious illness while they are being treated by their physician. It differs from hospice care in that it can be provided at any age or stage in a serious illness and can be provided together with curative treatment.

Palliative Care is provided at home (in Bartholomew County only), in the Palliative Care Outpatient Clinic located on the main level of Columbus Regional Hospital, and during inpatient stays at CRH. Jim Bickel, CRH President and CEO, shared, "These services are a strong partnership between Our Hospice of South Central Indiana and Columbus Regional Health, and are providing a valuable service to our patients and physicians. Columbus Regional Health is focused on being your health care partner for life and Sherry's generosity is an excellent example of how philanthropy is allowing critical work to go further faster to benefit the health and well-being of our region." The mission of Our Hospice is to make every moment count by surrounding patients and families with respectful and compassionate care for as long as they can. "The generosity of Sherry Risk Stark, in memory of her parents, brings stability for the long-term sustainability of Palliative Care to bringing expert symptom

management to those dealing with an advanced illness," said Laura Leonard, Our Hospice of South Central Indiana President. Palliative Care as a medical specialty supporting patients during a serious illness is necessary and important, but is minimally reimbursed by Medicare, Medicaid or Insurance, making this service difficult to sustain. This gift from Sherry represents a foundation to sustain this type of critical care."



MARK AND WENDY ELWOOD PROVIDE EXTRAORDINARY \$25,000 GIFT TO CRH MENTAL HEALTH SERVICES

Mark and Wendy Elwood have been generous contributors to Columbus Regional Health's Mental Health Services for several years. In 2020, Mark and Wendy supported an important project for its mental health patients. Megan Johnson, RN, Assistant Nurse Manager for the Mental Health Unit shared, "With the Elwood's gift, we

purchased furniture, artwork, and therapeutic materials with a focus on enhancing the Group Programming Rooms within the Mental Health Unit. The enhancement of these rooms and the therapy that will be provided will have a positive and long-lasting impact on the patients' overall mental wellness." The Center for Health Design confirms this in its article *Towards Healing Environment for the Inpatient Unit in Psychiatric Hospital:*



"Since mental health facilities provide care to patients with a wide array of illnesses and other needs, it is increasingly important to understand how certain physical factors within these environments can improve the quality and efficiency of healthcare delivery overall."

Mark and Wendy's connection to mental health is longstanding. In addition to Mark's father being a Psychologist, it has been a lifelong passion for Wendy, who holds a degree in Psychology from Michigan State University. This passion has been a driving force behind their advocacy of local mental health programmatic needs and emerging opportunities. Their commitment is evident through their contributions to local substance abuse prevention and youth development initiatives. CRHF is deeply grateful to Mark and Wendy for their compassionate support of mental health services at CRH and throughout our community. "Health in general is so important and mental health, in particular, because it can be hard to see and sometimes hard to diagnose and treat. Mental health issues like substance abuse can affect all of us - irrespective of factors such as age and social status. Wendy and I are pleased to provide financial support to assist in the detection and treatment of mental health issues in Columbus and Bartholomew County." - Mark Elwood

OUR COMMUNITY OFFERS HOPE FOR THOSE STRUGGLING WITH MENTAL ILLNESS

With approximately 50% of Americans diagnosed with a mental illness or disorder in their lifetime, mental health issues are crippling our community and our country. According to the Kaiser Family Foundation, the rate of U.S. adults experiencing symptoms of anxiety and/or depressive disorder is three times higher now than in 2019, mental illnesses like depression are the third most common cause of U.S. hospitalizations for those aged 18-44, and adults living with serious mental illness die, on average, 25 years earlier than others.

CRH is one of the **few Indiana hospitals with an Adult Acute Mental Health Inpatient Unit** treating adult, acute mental illness. It plays a critical role in providing support to those who need it urgently, regardless of socioeconomic or life stage. Similar to the high level of **uncompensated care** provided to those who cannot afford healthcare, CRH Mental Health services exemplifies again our **community-based, nonprofit hospital** going above and beyond to meet an important, critical community and regional health need.



Rise to the Challenge of Covid-19

CRH CARES EXTRAORDINARILY FOR ITS OWN AND THE COMMUNITY DURING THE COVID -19 PANDEMIC

Generous gifts from the community and from CRH employees made it possible for CRHF to raise over \$60,000 for CRH employees who were financially affected by COVID-19 and who needed assistance with rent, utilities, car payments, and childcare. The fund has supported 38 employees to date.

Jill's Story

Jill's husband was laid off due to the pandemic, with no certainty when he could return. She began working extra shifts at CRH to make up for the income loss. But soon her young son contracted COVID-19, and the necessary self quarantine made it impossible for her to work. With no income at all, her family was struggling to make ends meet. At her manager's suggestion, Jill applied to the CRH Employee Relief Fund, which covered a month's mortgage, and gave them a little breathing room until she and her husband could return to work.

Brenda's Story

Due to health challenges and the pandemic, Brenda had not worked full time or received full pay for many weeks and her husband was not working at all. With school-aged children at home all day their utility bills were rising and their car needed a repair, but there simply wasn't enough money to go around. The Employee Relief Fund lent a hand to pay a couple of bills and get the car repaired. A few months later, the car was totaled in an accident and the Employee Relief Fund was able to help once more by contributing toward the down payment on another vehicle for Brenda's family.



AN Extraordinarily Caring Community GIVES BACK TO CRH

COLUMBUS AREA ARTS COUNCIL engaged local artists and designers to create 7,500 custom fabric patterns for face masks for the community. THE MASK PROJECT was funded by Heritage Fund – the Community Foundation of Bartholomew County, Heathy Communities Proyecto Salud and CRH.



THE CHINESE ASSOCIATION OF COLUMBUS coordinated

shipments from China of approximately 80,000 masks, respirator masks and other protective gear to Bartholomew County to aid efforts in the fight against COVID-19.



Temporarily known as The Heroes House, VOLUNTEERS OF AMERICA loaned its Fresh Start Recovery addiction treatment center for pregnant women and mothers to CRH for its workforce and providers to quarantine after exposure to COVID-19 from a positive patient or employee.



Global manufacturing company GEORGE UTZ, INC.'s local plant in Edinburgh produced and donated 200 face shields to CRH. The company also donated the shields to police, firefighters, first responders and other critical workers.

THE HEALTHY COMMUNITIES BREASTFEEDING COALITION

The Healthy Communities Breastfeeding Coalition works to ensure nursing moms have the education and resources needed to successfully breastfeed their babies by providing free, regular, predictable support and guidance by a Board Certified Lactation Consultant (IBCLC) through Nurse N' Chat every Tuesday and Thursday. During COVID-19, Nurse N' Chat offered online support and a social network opportunity to participants via Zoom and one on one scheduled appointments. Nurse N' Chat served 330 local moms in 2020. The Breastfeeding coalition supported our community in multiple ways:

- LIVE, LOVE, LATCH EVENT: held virtually August 18th, 2020 on Facebook due to COVID-19.
- Free, bimonthly **PERINATAL DEPRESSION EDUCATION** offered at CRH.
- BREASTMILK DONATION SITE collected 3,000 ounces of milk for the Indiana Milk Bank.
- BREASTFEEDING IN THE WORKPLACE PSA.
- HOSPITAL GRADE BREAST PUMPS LOANED to moms with medical need.



CRH TREATMENT & SUPPORT CENTER

Even though the target only looks at 6-month follow-ups, both rates exceed the target.





ALLIANCE FOR SUBSTANCE ABUSE PROGRAMS (ASAP)

2020 CRHF Support for ASAP \$100,059 2020 City and County Support for ASAP \$430,837



In 2020 CRHF's financial support played a key role in further developing our community's Prevention and Recovery System of Support, as well as working to ensure these programs are woven into the fabric of Healthy Communities Initiatives. While COVID-19 presented many challenges, much was accomplished throughout the year.

RECOVERY SUPPORT

- Prior to COVID-19, recovery meetings were hosted every day of the week, including 12-Step AA Recovery, Celebrate Recovery, SMART Recovery, Professionals in Recovery, Recover Out Loud, 12-Step Yoga and Al Anon.
- In response to COVID-19 closures, ASAP offered a catalogue of online Recovery Rooms, speaker tapes and virtual peer support, as well as a live-online chat with Hub team members.



RESIDENTIAL TREATMENT AND TRANSITIONAL RECOVERY HOUSING

 Over 30 recovery housing stakeholders convened to assess needs and develop strategy for transitional Recovery Housing in Columbus.



 Help from Ascension Recovery Services and

> a grant from the Rx Abuse Leadership Initiative (RALI) enabled development of a Recovery Housing Toolkit, available to any organization interested in developing a National Association of Recovery Residences (NARR) certified, supervised recovery home.

- Despite delays, reduced capacity and many new complexities for recovery residence operators as a result of COVID-19, eight treatment and recovery residences emerged in the community in 2020.
- ASAP Sober Living launched a 12-Step Recovery meeting, hosted at the ASAP Hub, open to all men living in a recovery residence in Columbus.
- Recovery Housing Providers forum hosted monthly to offer support and opportunities for collaboration among the community's recovery residences.

EMPLOYER ENGAGEMENT

The ASAP Hub has partnered with several recovery-friendly second, third and fourth-chance employment partners who welcome ASAP clients into their places of employment and offer a variety of generous benefits to support an individual's recovery, such as flexible scheduling, time off to participate in treatment and recovery meetings, transportation to/from work and recovery meetings onsite for employees.



PREVENTION AND HARM REDUCTION



CRH CONTINUES TO IMPLEMENT CHANGES TO ITS PRESCRIBING PRACTICES

- Transitioning entire health system to Epic as the comprehensive electronic medical record system, which has safer prescribing features such as prescription history, dosage alerts, and warnings of potentially unsafe drug interactions.
- Implementing EPCS (electronic prescribing of controlled substances), which prevents use of paper scripts, decreases the potential for diversion, and reduces opioid prescribing.



EDUCATION AND STIGMA REDUCTION

- 497 middle and high school students participated in Life Skills education, an evidence-based prevention program.
- The ASAP Hub hosted Facebook Roundtable discussions on such topics as Recovery Support Groups, Recovery Housing, Family Support, Medication-Assisted Treatment, Problem Solving Courts and Overdose Reversal: Narcan.

YOU NARCAN SAVE LIVES

NARCAN DISTRIBUTION

- ASAP hosted Narcan November, a month of targeted education and advocacy around the life-saving benefit of the overdose reversal drug Narcan.
- The ASAP Hub hosts a monthly mobile HIV/Hep C Testing Clinic, and simultaneously distributes Narcan.
- ASAP is partnering with Overdose Lifeline to install NaloxBoxes, making Narcan freely and safely available at locations throughout the community.



DRUG TAKE-BACK

- 1,340 pounds of unused medication were collected at the CRH Emergency Room medication drop box.
- Medication disposal bags are available at the ASAP Hub and are being distributed at public events to safely dispose of expired, unused and unnecessary prescription drugs.
- Healthy Communities, ASAP, the Indiana Attorney General and the Bartholomew County Sheriff's Department hosted a Drug Take-Back event at the Anderson Community Center, and safe-disposal bags were distributed to prevent pill abuse and theft.



VIMCARE Nighlights

\$418,180

VIMCare Clinic provides access to primary healthcare for our community's uninsured and underinsured. Through philanthropy, CRH Foundation is able to provide support for critical wrap around services for VIMCare patients such as mental and behavioral health, medication assistance and financial navigation.

MENTAL HEALTH SERVICES

Charitable gifts to CRH Foundation support a full-time Care Coordinator/Licensed Clinical Social Worker (LCSW) at VIMCare Clinic. The LCSW provides patients with critical mental and behavioral healthcare such as social work assistance, cognitive behavioral therapy, motivational interviewing, psycho-social education and other forms of therapeutic intervention. VIMCare follows a Collaborative Care model. embedding the mental health provider in the primary care practice with psychiatric

consulting available by phone. It has been very effective for VIMCare patients struggling with depression, anxiety, mood disorders and substance use disorder.

FINANCIAL NAVIGATION SERVICES

Philanthropy provides a full-time certified Financial Navigator/ Patient Advocate to VIMCare patients who guides them in accessing health insurance and financial assistance resources. Financial Navigation at VIMCare includes screening and assisting patients with the enrollment process for the Healthy Indiana Plan (HIP), Medicaid, Medicare/ Medicaid or Emergency Medicaid. The Financial Navigator is a liaison between the patient and the Medicaid office. For those who do not qualify for Medicaid, the Navigator helps them apply for ACA Marketplace coverage or for charity care through CRH.

AN EXTRAORDINARY PATIENT STORY

A 33 year old, non-English speaking man came to VIMCare for his first visit in August of 2020. He was previously healthy with no known medical history. He contracted COVID-19 in May, which resulted in a devastating stroke. This patient had always worked hard to support his family; however, he lacked health insurance. The stroke left him with permanent impairments and rendered him unable to work. Through word of mouth, he was connected with VIMCare, and was able to meet with the insurance navigator there to come up with a financial plan. Through the clinic, he has been able to access primary care and preventative services, medication assistance and social support. Despite several setbacks, including new-onset seizures, he has progressed as he has continued to work with physical, occupational and speech therapy. He was so proud to show the staff a picture he took with his guitar, in the hopes that someday he may be able to play again. He and his family are grateful for the care they have received at the clinic.



EXTRAORDINARILY UNUSUAL REVERSE RAFFLE

Due to the COVID-19 pandemic, and for the first time ever, the 25th annual Reverse Raffle to benefit VIMCare Clinic was held virtually on November 13th, 2020. The event, streamed live on Facebook, featured Reverse Raffle co-Chairs, Amy McCormick and Andrew Weisner and streamed music from Indianapolis-based The Woomblies Rock Orchestra. Despite the challenges of planning and executing a virtual event, the evening successfully connected our generous community with the essential work of the clinic. As CRHF's only fundraising event, the Reverse Raffle yields over a third of VIMCare's annual budget.






