Incoming President's Welcome Message

Shalom and welcome. We are happy you can join us tonight, at our 89th annual Decalogue Installation and Awards Dinner, as we continue our proud tradition of furthering our commitment to justice, community, scholarship and philanthropy.



Decalogue was founded in 1934, in response to rampant antisemitism, and the exclusion of Jewish lawyers from other organizations. It was during these tumultuous times, that a group of visionaries created the Decalogue Society, embodying the principles of the Ten Commandments. Founded on the values of justice, equality, and compassion, the organization created a safe haven for Jewish lawyers, fostered solidarity and camaraderie in the face of adversity, and gave the Jewish Community, "...a seat at the table." Decalogue is the oldest, and remains one of the largest, Jewish Lawyers associations in the United States.

Though the world has changed significantly since 1934, the spirit of our founders remains strong, and our work continues to fulfill their mission. To illustrate, our Green Book event and our multi-bar model Seder, were informative, extremely well-attended, and co-hosted by a number of other bar associations. Moreover, our Social Action Committee regularly assists home bound individuals and our Foundation provides scholarships. Further, in May, we oversaw the first of its kind event honoring veterans in the legal profession, co-hosted with 39 other bar associations.

We honored our colleagues who served, and conducted a moving memorial service to remember our missing and fallen soldiers. Additionally, our fundraising efforts allowed us to make meaningful contributions to myriad Veterans' organizations.

Congratulations to all of tonight's awardees. Thank you to Joel Bruckman, Aviva Patt, Judge Lori Rosen, and the Board for their dedication. Thank you for attending tonight, and breaking (kosher) bread with us. We are thrilled you could join us as Justice, Justice, Shall We Pursue.

Lifetime Achievement Award David Axelrod

David Axelrod is a preeminent American political strategist and commentator and the former chief strategist and senior advisor to President Barack Obama. Axelrod was the founding director of the University of Chicago's non-partisan Institute of Politics. He currently serves as a Distinguished Fellow at the University of Chicago and as a senior political commentator for CNN. He is the host of The Axe Files, a top-rated podcast featuring in depth conversations with public figures across the political spectrum. A former political writer for the Chicago Tribune, Axelrod produced media strategy and advertising for 150 campaigns across the U.S., culminating in President Obama's historic elections. Axelrod is also the author of The New York Times best-selling memoir, *Believer: My Forty Years in Politics*.



Charles E. Freeman Judicial Merit Award Judge Rena Van Tine



Judge Rena Marie Van Tine is the Acting Presiding Judge of the County Division. She became the first female Indian American judge in the nation to serve on a state court 22 years ago when she was appointed to the bench as an Associate Judge of the Circuit Court of Cook County. In January 2021, the Illinois Supreme Court elevated her to Circuit Court Judge. She subsequently ran and won her county-wide election to keep her position on the court. She has served in four different divisions of the court system including the First Municipal, Juvenile, Law and County Divisions.

Judge Van Tine has been licensed to practice law for 38 years. As a lawyer, she served as an Assistant State's Attorney in various divisions including the Felony Trial Division and the Medical Litigation Division. As an associate in a private law firm, she handled criminal misdemeanor cases as a defense lawyer, and personal injury cases as a plaintiff's lawyer.

Judge Van Tine is the President of the Asian American Judges Association and a past President of the Asian American Bar Association. She is a co-founder of the South Asian Bar Association and its Foundation. She has served on many boards and committees of various bar associations and community groups throughout her almost four decades of practice.

She has been happily married to Matthew Van Tine for 35 years and has a daughter, Kristen who is a rising 3L at a law school in Chicago.

Award of Excellence David H. Levitt & Conrad C. Nowak



David H. Levitt has practiced law at Hinshaw & Culbertson LLP since 1979. A past President of Illinois Defense Counsel, he changed his practice to intellectual property law, having received his L.L.M. in Intellectual Property in 2000, later serving as Chair of DRI's Intellectual Property Committee and founder of Hinshaw's IP practice.

Mr. Levitt is an active blogger on the English language centrist Israeli e-newspaper, Times of Israel, on such topics as international law as applied to Israel and antisemitism, among others. His articles may be found at <https://blogs.timesofisrael.com/author/david-h-levitt/>; the most recent evaluates the legal issues surrounding the First Amendment and hate speech.

Mr. Levitt is the co-chair of the Advisory Board of the DePaul Law School Center for Jewish Law and Judaic Studies. JLJS provides unique programming not found elsewhere, including its April 2022 symposium, *Defining Antisemitism and Why It Matters*, an in-depth exploration of the competing definitions; Mr. Levitt co-chaired and was one of the presenters. Mr. Levitt also has presented at the StandWithUs International Conference on international law regarding Israel's legal borders.

Mr. Levitt is Past President of Congregation B'nai Tikvah in Deerfield, Illinois.



Conrad C. Nowak is a Partner at the national law firm of Hinshaw & Culbertson LLP where he focuses his practice in litigation matters. An Army veteran, he also serves as the national chair for the firm's Veteran Employee Resource Group. Nowak has been a strong advocate for spreading awareness for veteran and attorney mental health, suicide awareness and prevention, working with multiple organizations fighting for these important causes.

Outside the law, Nowak has been an active board member in several international humanitarian non-profits and is the current Co-Chair of the Warsaw Committee of Chicago Sister Cities International. He has also been active in numerous collaborative efforts related to Polish-Jewish affairs, as well as continuing efforts related to the crisis in Ukraine.

He is the proud great grandson of Eugenia Kasztalska (deceased), who hid numerous Jewish families in her Warsaw apartment during the Second World War as they awaited the opportunity to escape. He dedicates this award to her memory.

Nowak is a graduate of DePaul University and Loyola University Chicago School of Law.

Decalogue Society Award Ald. Debra Silverstein

Debra Silverstein has been Alderman of the 50th Ward since 2011. Since being elected, she has worked tirelessly to make her community a better place to live for the many residents who call it home. Her focus has been on making the 50th Ward safer, more family-friendly, beautiful, and economically strong.



Debra has brought several groundbreaking projects to the 50th Ward that improve the quality of life of the neighborhood's residents. These include a new, state-of-the-art library at Pratt and Western, a multi-million-dollar Streetscape of Devon Avenue, and a brand-new park at Devon and McCormick.

Hebrew University Fellowship Award Judge Martin P. Moltz



Hon. Martin "Marty" Moltz has served as a Judge in the Circuit Court of Cook County for 16 years, handling a broad range of civil and criminal cases. Prior to serving on the bench, Judge Moltz began his career as an assistant in the Office of the Cook County State's Attorney. He later became the Deputy Director of the State Appellate Prosecutor's Office where he argued a record number 1700 cases before the Illinois Supreme and Appellate Courts. Judge Moltz has been honored by the Chicago Bar Association, the Women's Bar Association of Illinois, and Phi Alpha Delta Law Fraternity.

Judge Moltz seldom rests. When he is not tending to his duties on the bench or participating in professional and community service organizations, he can generally be found pursuing his love of roller coasters. He has ridden every roller coaster in the United States. When asked if he prefers more modern coasters or the more traditional wooden ones, he says "A wooden roller coaster is just a better ride, because the wood is living and breathing. It changes over time and no ride is ever exactly the same." Judge Moltz has even performed a wedding at the top of a roller coaster ride!

Judge Moltz and his wife Ann have been married for 49 years.

Presidential Citation Howard H. Ankin



Howard Ankin founded the Ankin Law Office in 1997. For over 25 years, the firm has focused exclusively on protecting the rights of injured people in personal injury, motor vehicle, medical malpractice, mass torts, premises liability, and workers' compensation matters. Ankin Law has grown to over 75 attorneys and staff and is a leading filer of workers' compensation claims in Illinois.

Howard Ankin is a third-generation lawyer who opened the firm with his father, Paul B. Ankin. He represents clients not only as their attorney, but as a friend who perpetuates the service tradition of the Ankin family. The Ankin Law tagline is "Injury law made personal."

AWARDS

Hon. Charles E. Freeman Judicial Merit Award

The Charles Freeman Judicial Merit Award is given to those judges who exemplify the highest ideals of the Decalogue Society of Lawyers and of the legal profession by promoting diversity and inclusivity in the legal professions and for outstanding achievement in the judiciary.

Lifetime Achievement Award

The Lifetime Achievement Award recognizes outstanding individuals with pioneering spirit who have demonstrated inventiveness throughout their careers, have helped break down unfair or unjust societal barriers that prevented otherwise qualified individuals from reaching their potential, have notably improved the legal profession and our society in general, and have inspired others by and through their actions. Simply put, candidates for this award are living role models.

The Decalogue Society Award

The Decalogue Society Award is presented to individuals who, through their actions and achievements, exemplify the core principles of the Decalogue Society of Lawyers to bring increased dignity and honor to the legal profession, to maintain vigilance against public and private practices which are anti-social, discriminatory, anti-Semitic or oppressive, and to work with other groups and minorities to help protect the legal rights of all.

The Award Of Excellence

The Decalogue Society of Lawyers' Award of Excellence is presented to attorneys who bring increased dignity and honor to the legal profession by, among other things, rendering useful community service or participating in worthy movements for the public welfare.

Hebrew University Fellowship Award

In 1968 the Decalogue Foundation established the Decalogue Perpetual Fellowship Fund, which provides an endowment for annual fellowships at the Hebrew University in Jerusalem, Israel. Each year, the fellowship is named in honor of a member who has made significant contributions of his or her time to Decalogue.

Presidential Citation

The Presidential Citation is given annually to one or more individuals who have helped to improve the Decalogue Society of Lawyers through their innovative thinking and actions or who have made some notable contribution that enhanced the Society or furthered its goals and objectives.

Intra-Society Award

The Intra Society Award is presented to members of the Decalogue Society of Lawyers who have devoted significant time and energy to augment various functions of the Society, who promote Decalogue's good reputation in the legal community and elsewhere, and who, through their actions, exemplify the Jewish ideals of tzedek (justice), limud (learning), and kavod (respect).

Law Student Award

The Law Student Award is presented to a member of Decalogue's Law Student Division who has contributed significantly to increasing the Decalogue Society's presence among law students.

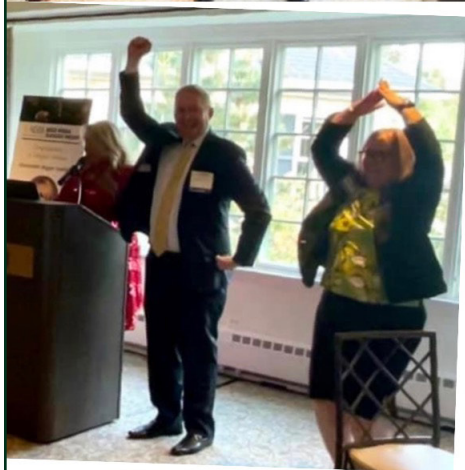

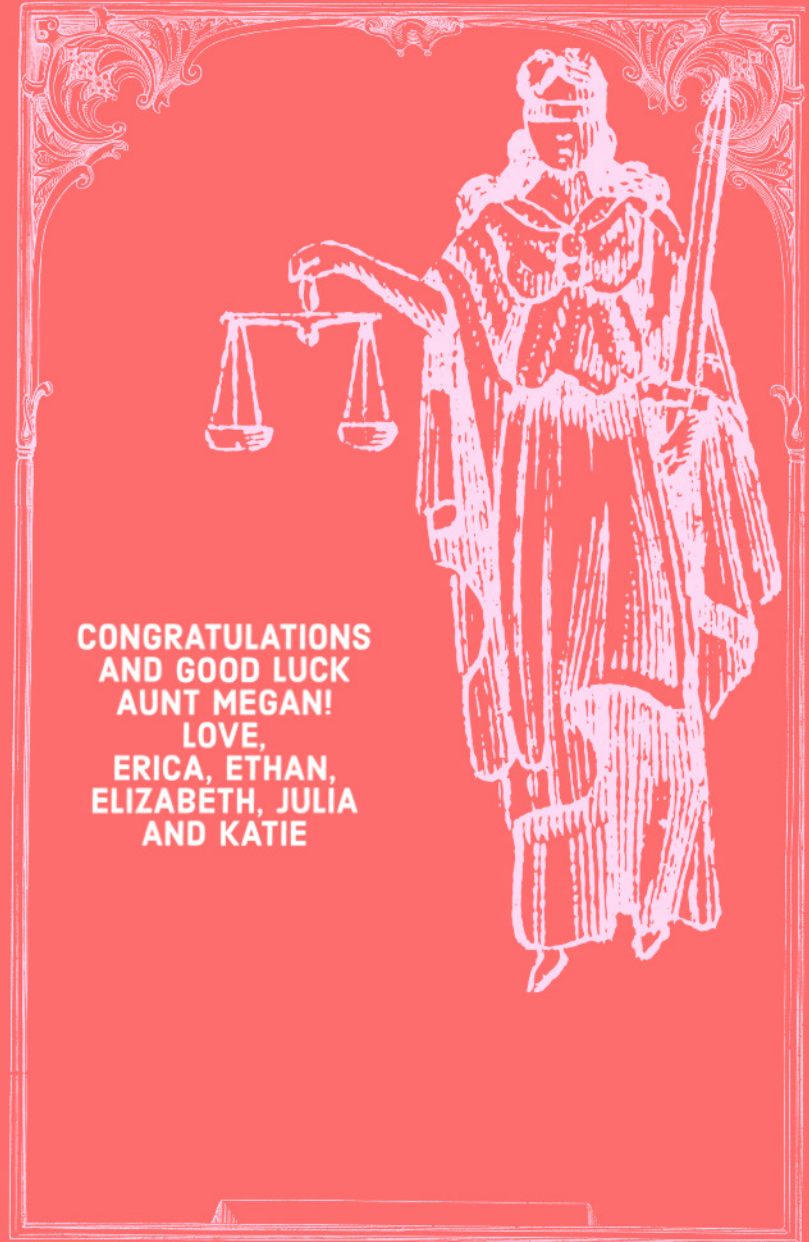

Thanks for the opportunity to say something nice about my very, very good friend David Axelrod. I am always up for a challenge.

My friendship with David began in 1984. David was the chief political writer at the Chicago Tribune. I was a spokesperson for the Illinois Public Action Council. We had helped elect Lane Evans as the first Democratic Congressman from western Illinois in many years, and I wanted David to write about it. The only issue? His wife Susan was in labor with their second child.

Patience has never been my best trait so I proceeded to track down David in the recovery room – and this was long before cell phones, of course. I asked him if it was a boy or a girl, I offered the traditional "Mazel tov" and then I wasted no time in asking when he would be back at work.

It's a miracle that Susan still speaks to me, or that David would want to work with me.

Eventually, David left the noble profession of journalism for the even more noble profession of political consulting – also known as the dark side. From our work together on Paul Simon's campaign for Senate to Rich Daley's bid for mayor, it was clear David was quickly becoming the preeminent political strategist.

In 2002, I asked him if I could win a race for Congress and he told me, "You're not allowed to lose. It's against your nature. You're like a heat-seeking missile. You always hit your target." Suffice to say, a fair statement.

When President Obama asked me to be chief of staff, David convinced me to do it. Our country had come close to the brink of collapse. David's counsel helped the President put it back on track. Amidst the reams of white papers, memos and economic statistics, David kept us focused on everyday Americans with limited income but unlimited potential. 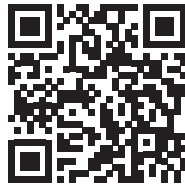
