## **OKP1 - Period Lock**

### **Functionality**

The period lock is used to lock plan and actual business transactions for a combination of controlling area, fiscal year, and version to prevent further postings in the controlling area. This function is similar to FI locking of periods.

### **Scenario**

We want to lock actual postings for the period of June in controlling.

### **Requirements**

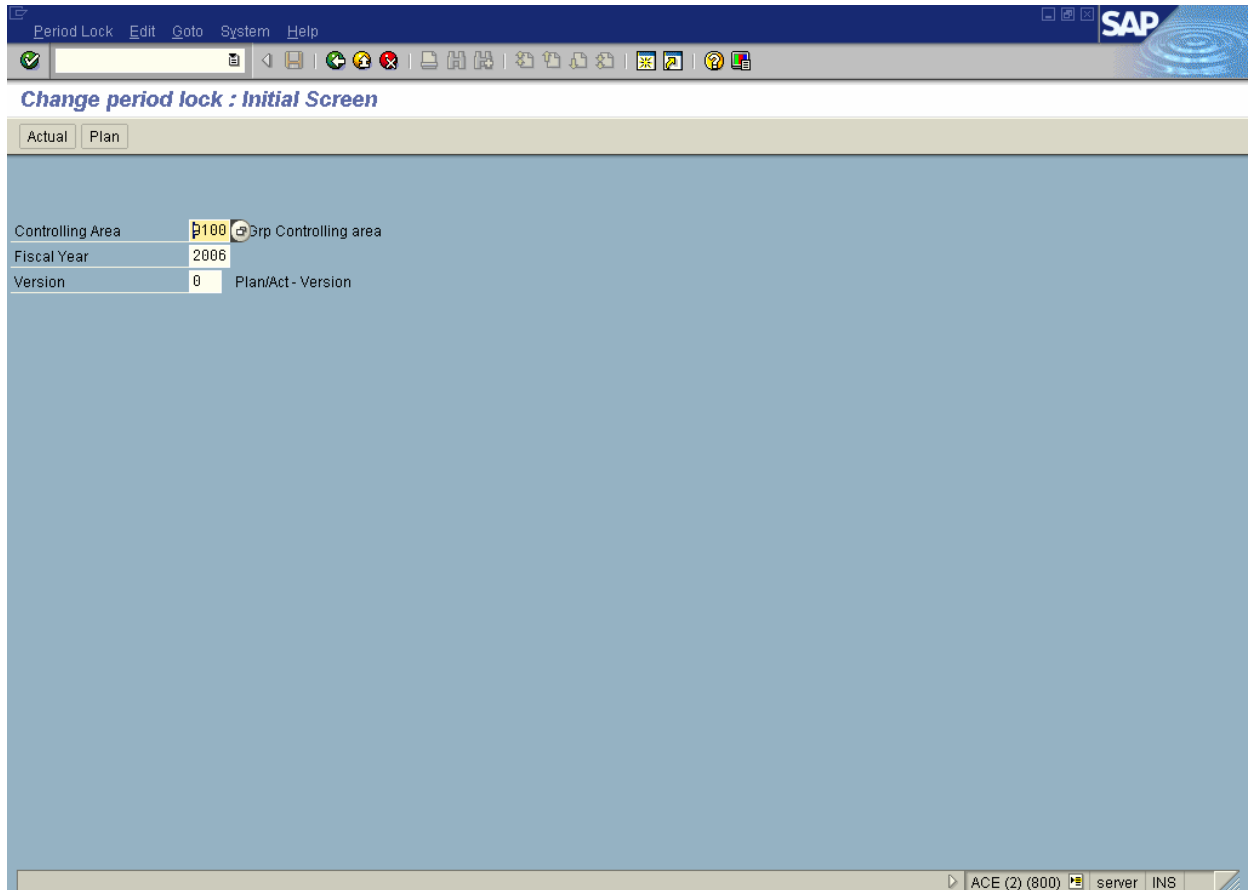
All postings in Controlling module for the period have been executed.

<b>Menu Path</b>	Accounting → Controlling → Cost Center Accounting → Environment → Period Lock → OKP1 - Change
<b>Transaction Code</b>	OKP1
