


According to the values we found on the FEC website, my political donations totaled \$31,000 to Federal candidates, which is \$15,200 below FECA's campaign limits. See enclosed Exhibit D for a spreadsheet breaking down the cited donations.

Furthermore, we also reviewed our own donation records for the same time period. In this instance, our records show that I donated a total of \$38,400 for the 2011-2012 election cycle, which is still \$7,800 under the FEC's campaign limits for Federal candidates. See enclosed Exhibit E for a spreadsheet detailing my contributions for those years.

In summary, the above information demonstrates that I did not contribute in excess of the individual campaign limits as alleged in MUR #6734. As such, I respectfully request that my name be removed from the complaint as I did not willfully or knowingly violate the FECA.
