

## Providing critical care when and where it matters most.

Construction is well underway on the ReEnvisioning Critical Care project on the hospital's 7<sup>th</sup> Street campus. Development Council members are committed to raising \$14.75 million in charitable funds for this \$45.8 million project to renovate and expand Frederick Health Hospital's Emergency Department, Intensive Care Unit, and Interventional Cardiology Services. Thanks to the support of our loyal donors and generous community, nearly \$6 million has already been raised to support this important and timely project.

"As our community continues to grow, so does the need for critical care services. Frederick Health has the 7th busiest Emergency Department in the state, our 18-bed ICU is often at capacity, and Cardiac Services is the hospital's fastest-growing service line. This capital project allows us to expand our critical care services to ensure that we are meeting the expectations of our patients in terms of level of expertise, quality of care, and positive patient and family experience," stated Cheryl Cioffi, Senior Vice President & Chief Operating Officer, Frederick Health.



## A Tradition of Generosity

There's nothing more worthy than passing down to your children a sense of stewardship, generosity, and benevolence. The Ramsburg family knows this best.

Charitable giving in the Ramsburg family dates back generations, starting with JR Ramsburg and his wife, Norma. JR was born and raised in Frederick, so when the couple wed in 1960, the two decided it was the best possible place to plant their roots.

“Frederick has always been home and always will be,” said JR. “Even my grandparents were born here in the late 1800s.”



Emma Smith

**In the late 1890s, Emma Smith vowed to build a hospital in Frederick and began a personal campaign with the help of her community to bring this vision to life.**

Individuals, families, businesses, and organizations staged events, picnics, contests, and “lawn fetes” to generate funds. Miss Smith herself donated a parcel of land on 7<sup>th</sup> Street. On May 1, 1902, Miss Smith’s dream of building a hospital to serve the Frederick community came to fruition.

As a tribute to her vision, the Frederick Health Annual Support Committee named their annual giving club the 1902 Club. The 1902 Club not only commemorates Emma Smith and the date in which Frederick Health opened its doors—but it honors the tradition of philanthropy that began with Emma and continues today.

# Why I Give

## Ali Syed

"I'm proud to be a first-generation American. In Pakistan, where my parents are from, there isn't typically access to integrated healthcare systems. When it comes time to take care of the older generations, caregiving is often left to family members, which can be emotionally and physically challenging.

Here in the U.S., I once went with my wife to visit her grandparents, both of whom were receiving healthcare services in their home at the time. The nurses did anything and everything for her grandparents, giving our family peace of mind and providing much-needed relief from the difficulty that comes with caring for an ill family member.

By giving a small part of my paycheck each month, I know I'm helping to make a big difference in people's lives without having to sacrifice much. The donation is automatically taken from my paycheck and those dollars go to use where they're most needed. It's like a crock pot—I can set it and forget it! Plus, at the end of every year, I receive a letter that shows how much I've donated. I can proudly share that number with my family, and know how much I've been able to help others. Just like the original Ali (the boxer) said, 'Service to others is the rent you pay for your room here on earth.'"
