Message from the President

Dear Friends,

When the Frederick Health Board of Directors made the decision several years ago to embark upon a capital construction project to renovate and expand our Emergency Department, Intensive Care Unit, and Cardiac Catheterization Lab, they never dreamed that it would be happening in the shadow of a worldwide pandemic. We broke ground on this important project in September 2020, and in the months since then, we've treated more than 1,800 COVID patients.

The community has turned to Frederick Health to care for family, friends, neighbors, and co-workers during a time when very little has felt normal. Our staff has worked tirelessly to provide exceptional care while facing a wide array of challenges. Beyond caring for COVID patients requiring hospitalization, our staff established testing and vaccination sites that have served tens of thousands of individuals.

Just as we met the unprecedented needs of our community over the past 19 months in the face of COVID-19, we are, through the *ReEnvisioning Critical Care* capital construction project, ensuring Frederick Health is adequately prepared to meet the critical care needs of our rapidly growing community. When the nearly \$46 million renovation and expansion project is completed on our 7th Street campus, friends and neighbors in need of emergency, critical, or cardiac care will experience a more comfortable, convenient, patient and family-centered environment along with the expert care and advanced technology that has long been a cornerstone of Frederick Health.

My thanks to the many donors who have already made a gift to our *ReEnvisioning Critical Care* campaign. We've raised more than \$6.6 million toward our fundraising goal of \$14.75 million. I'm grateful for all the individuals, companies, organizations, and foundations listed on the following pages. Whether you have supported the campaign, made a memorial gift, shared a grateful patient story, named us in your estate plans, or made an in-kind gift to support our staff, you are helping Frederick Health fulfill our mission to ensure the well-being of every individual in our community.

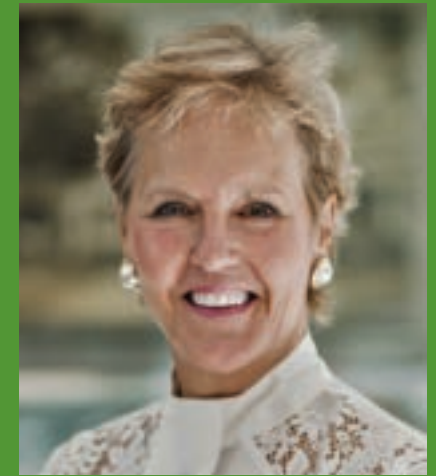

Auxiliary Update: Mission-Driven Volunteers

Over the past fiscal year, the Frederick Health Auxiliary had to limit their volunteer operations and activities, inside the hospital and at off-site locations, due to the ongoing pandemic—but that did not stop them from making a positive impact!

While overall volunteer hours were down from the previous fiscal year, the Auxiliary was still able to clock an impressive 25,236 hours of service—which equates to \$720,249 of donated labor costs to help support Frederick Health and its mission.

Jumping in to help when and where they safely could, Auxiliary volunteers took on new tasks and roles, including answering phones at the Frederick Health Call Center and staffing COVID-19 vaccination clinics. They also sewed gowns and face masks to prepare for any future PPE shortages. In addition, the sewing team went back to work making pillows, activity aprons, and their usual pre-COVID items.

Thanks to the support of Volunteer Services staff members, the hospital Gift Shop was able to operate with limited hours during the pandemic and is now back to normal operations. In addition, the Auxiliary's Select Seconds Thrift Shop in Downtown Frederick has fully reopened and may soon be expanding its hours. Despite a challenging fundraising environment, proceeds from the Gift Shop, Select Seconds, and other operations enabled the Auxiliary to honor its financial commitment to Frederick Health in support of the recent renovation of the Behavioral Health Unit.

Giving Back to Frederick: A Family Tradition

The Weinberg family has been part of the fabric of Frederick since 1850, when Samuel Weinberg traveled from Prussia to the United States.

Samuel built a house on North Market Street, and planted roots for future generations. Now, more than 150 years after Samuel's journey, the Weinberg family still proudly calls Frederick their home.

"I take pride in the lineage of our family in Frederick," said Cody Weinberg, great, great, great grandson of Samuel. "This community has shaped our family for generations, and when a community takes care of you, you take care of it."

Cody and his wife, Rachel, are members of the Order of the Good Samaritan, the hospital's cornerstone giving club. They are the latest members of the Weinberg family to join the Frederick Health donor family, having followed in the footsteps of family members before them. Cody's parents, Rand and Pam Weinberg, have been part of the Order of the Good Samaritan since 1995, and before them, Cody's grandfather, David Weinberg, joined in 1994. Cody's great grandparents Manuel & Sylvia Weinberg were also early supporters of the hospital.

"Our family recognizes the good that Frederick Health has done over the decades," adds Cody. "We're grateful that the organization is a centerpiece in Frederick, and that it continues to evolve to meet the community's growing needs."

After joining the Order of the Good Samaritan in 2018, Cody and Rachel saw firsthand how Frederick Health responded to the COVID-19 pandemic in the county. They were impressed by the system's comprehensive plan and quick response, making them feel even more confident in their decision to support the nonprofit. "Frederick Health really is on the front lines. That's why it's so important for us to give," said Cody.

The three generations of Weinbergs—David, Rand, and Cody—are known in the Frederick community for their work in the legal profession. Rand and David practiced for many years through different variations of Weinberg & Weinberg, and now Rand and Cody work down the hall from one another at Miles & Stockbridge P.C.

"I'm primarily interested in continuing my relationship with Frederick Health because of my children and grandchildren," said Rand.

"I want them to have the quality healthcare that those who came before them enjoyed."

Cody sums it up by stating, "We've been part of the fabric of Frederick for so long, and because of that, we know why it's critical to continue supporting our local healthcare system."

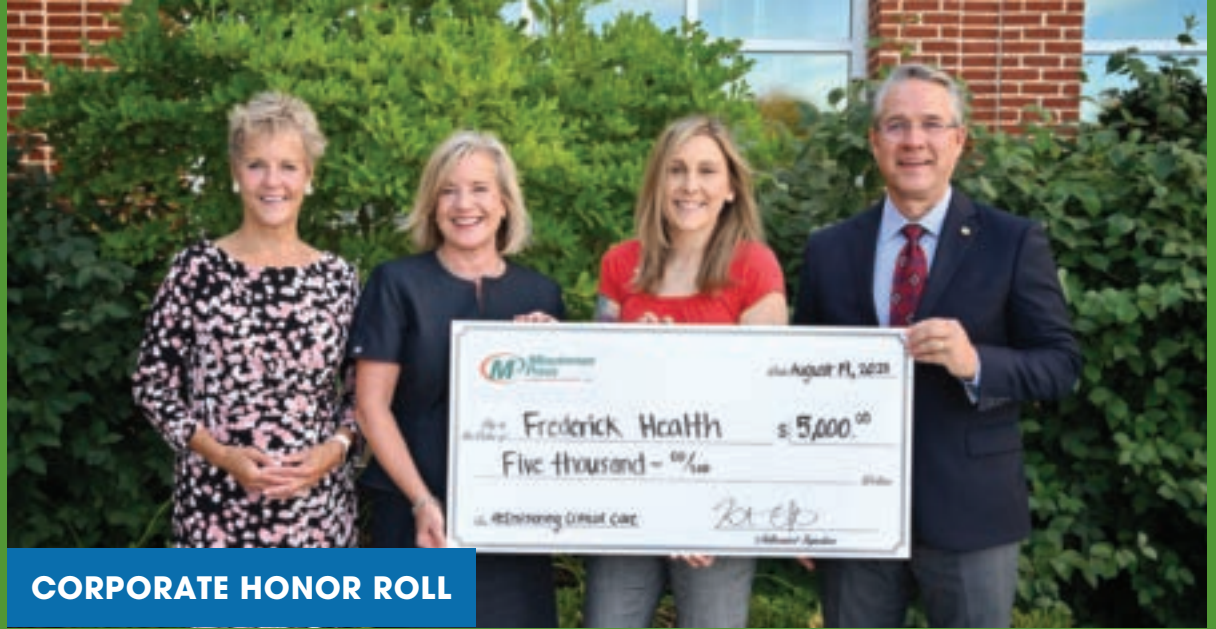

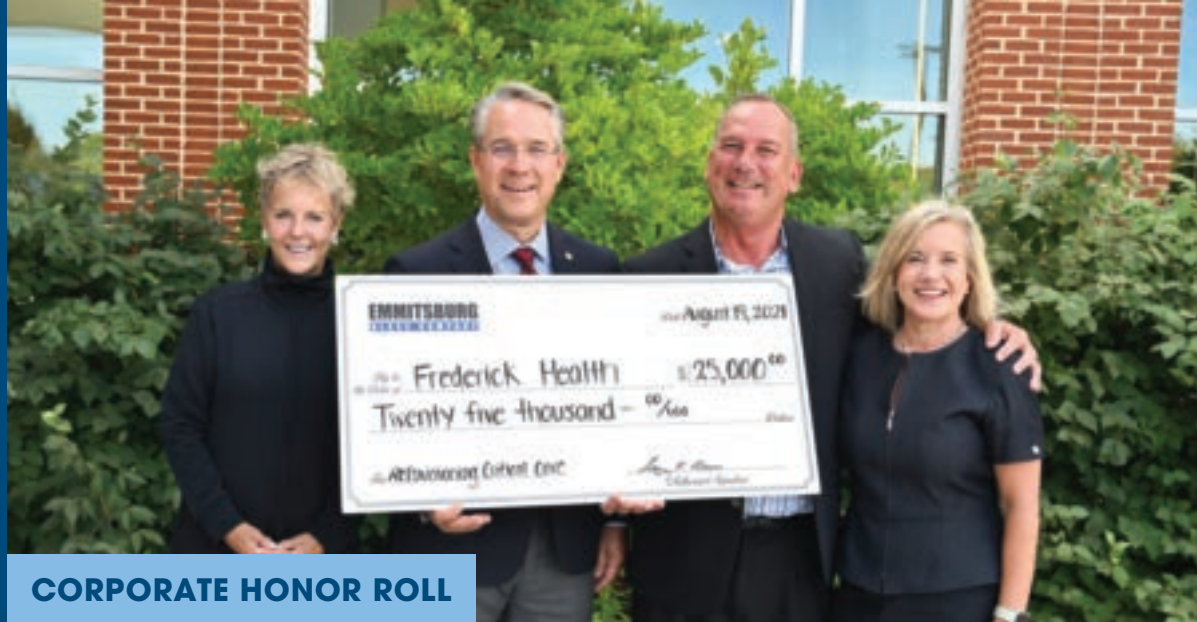

have teamed up to implement strategies that promote healthy behaviors and remove barriers for a healthy lifestyle among our county's youth. Programs like 5-2-1-0 provide education and resources to reduce childhood obesity.



FREDERICK HEALTH AND HOOD COLLEGE are neighbors working together to address the unmet needs of each organization. Frederick Health Toll House Urgent Care and Hood College Health and Counseling Services are now housed under one roof. This facility offers a wide range of services to both the general public and Hood students. Additional collaboration has resulted in Hood leasing space from Frederick Health to accommodate the growth of the college's nursing and health science programs. Hood's state-of-the-art simulation equipment can also be utilized by the hospital's nursing staff for continuing clinical education purposes.
