# 120 Years of Care – And *Philanthropy*

More than a century ago, Emma Smith had a dream of opening a hospital for her community, and she remained committed to making this vision a reality.

Emma’s vision — along with the generosity of the Frederick community — led to Frederick Health being built on a solid foundation of philanthropy.

In the late 1890s Emma began a personal campaign to build a hospital in Frederick by forming a group of women volunteers, who worked tirelessly to raise the \$8,000 needed to open the original hospital. Not only was Emma the first president of the hospital, she generously donated the land on which Frederick Health stands.



**1902**

Emma Smith’s vision to create “a place to care for the sick and comfort the injured” came to fruition when Frederick City Hospital opened its doors on May 1, 1902.



**1904**

The generosity of Margaret S. Hood provided for the first addition to the hospital—a two-story wing with sun parlor and elevator. A second Hood wing was built in 1907.



**1913**

A gift from Georgianna Houck Simmons provided for the Georgianna Houck Simmons Nurses’ Home, which opened in late 1913.



**1929**

An estate gift of \$75,000 from nursing teacher and mentor Dr. Thomas Brashears “T.B.” Johnson provided for a new wing to the Nurses’ Home.



**1952**

The hospital celebrated its 50th anniversary and changed its name to Frederick Memorial Hospital. Mrs. Byron D. White founded the Auxiliary.



**1955**

During its first three years, the Frederick Memorial Hospital Auxiliary became the largest women’s organization in Frederick County.



**1964**

A \$3,410,000 expansion and renovation project began for the new “Y-wing.” The wing opened in 1968, bringing the number of beds to 201 with 40 bassinets.



**1989**

The Development Council is formed, chaired by (clockwise from left): Jay Fifer, Charles Snyder, Anne Butt, Jim McSherry, Charlie Bowers, John Fiesler, & Wade Manning.



**2022**

Four years into the ReEnvisioning Critical Care Campaign, the new Pediatric and Adult Emergency Departments, ICU & Cath Labs are open to the public.



**2020**

Throughout the COVID-19 pandemic, our community came together to support the organization with thousands of in-kind gifts such as snacks and meals for staff, and PPE.



**2019**

Our name is simplified to Frederick Health. We launch the ReEnvisioning Critical Care Campaign, a \$46 million expansion & renovation project focused on the hospital’s critical care areas.



**2017**

At the close of the five-year Time is Now Campaign, \$22 million is raised and the James M Stockman Cancer Institute opens its doors.



**2011**

The Development Council celebrates surpassing their fundraising goal for the Transforming Healthcare Campaign by raising more than \$10 million -- one full year ahead of schedule.



**2008**

The Transforming Healthcare Campaign launches to support the Women’s Center at Crestwood, and the hospital’s Cardiovascular, Interventional & Electrophysiology Suite.



**2007**

Lt. Gov. Anthony Brown speaks at a ‘Grand Reopening’ celebration for the completion of a ten-year, \$103 million expansion project benefitting all major areas of the hospital.



**1995**

The hospital exceeded its fundraising goal for the Equation for Progress Campaign by raising nearly \$5.7 million, supporting new expansion including the opening of FMH Rose Hill.



# Honoring A Family Legacy of Generosity

**Robert & Linda Carmack, Nancy Eppley & William Harding, Terry & Donald Lambert, and Faith & Eugene Hale honor the legacy of their late parents, Marion & Alice Carmack, in a generous and meaningful way.**

“My sisters and I are eleventh generation Frederick County residents,” says Bob. “Our ancestors moved here from Scotland in 1678 and never left the county. Dad was big on the concept of community and community hospital. It was important to him and Mom. They were both born at and later received care at Frederick Health. Their parents had been treated there as well. My siblings, our children, and grandchildren were born there. It has served our family for generations. We have family members who currently – and in the past – have worked at the hospital as nurses.”

“Mom and Dad loved giving back to the Frederick community,” says Nancy. “Dad wanted to give back because he felt Frederick had given him so much. He had a very successful insurance business here and it was the people of Frederick who were the majority of his clients. Dad joined Good Samaritan in 1996 and contributed to ongoing hospital efforts. He donated to the James M Stockman Cancer Institute when it was in the early planning stages. He and Mom donated to at least one or two patient rooms during different hospital renovations. When Dad was there, as a patient, we would walk the halls and see their names on donor recognition plaques. It gave him such pleasure.” Faith adds: “and it still does for their friends. A special friend of my father’s who is a member of the hospital auxiliary once told me that when she passes through the halls and sees Dad’s name outside his dedicated rooms it puts a big smile on her face – and that would make him so happy.”

“During his brief hospital stays,” says Nancy, “Dad would always comment on how well he was treated by the staff. We never heard a negative comment. Then, at the end of life, we were involved with Hospice. Everyone was so accommodating with any request that he or we children had. During a conversation Dad and I had at that time, he told me that when he got better he wanted to elevate his Good Samaritan standing to that of the President’s Level. It was not to be. But my siblings and I wanted to honor him and Mom with a legacy they would be proud of – and to make his last wish come true. Mom and Dad loved their community. So, we kids made a donation in our parents’ name that elevated their giving to the President’s Circle Level.”

Dad’s receiving the “Good Samaritan of the Year” award in 2008 extended beyond his hospital involvement,” says Terry. “He truly exemplified the definition of a Good Samaritan by giving relentlessly of his time, talents and generosity in many ways to the community – not only financially but also through his professional and volunteer service. He was a very dedicated member of Evangelical Lutheran Church, supporter of the Community Foundation of Frederick County, and a Past District Governor of the Lions Club – from which he received the highest honors given by Lions Club International. He was always willing to lend a helping hand to anyone in need.”

“Being Fredericktonians all their lives,” says Faith, “our parents saw the importance of having great local healthcare. The convenience of having state of the art facilities in Frederick was and is such a blessing. They really appreciated the fact that medical-related trips to Baltimore or Washington were unnecessary.” “We are all contributors and strong advocates of the hospital – in large part because of our parents,” says Bob. “We always try to plant the seeds of philanthropy when talking with friends about the hospital. Quality, local healthcare – it just makes sense.”




# ReEnvisioning Critical Care

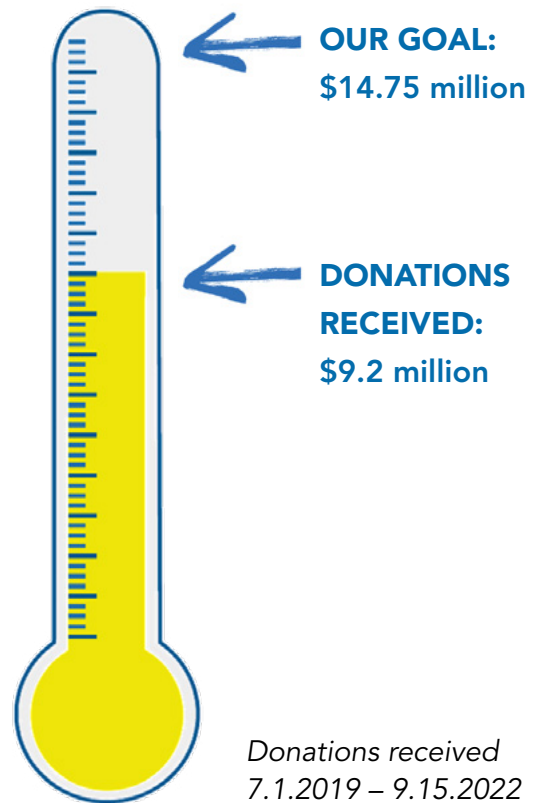
## Campaign Update

Construction continues on the ReEnvisioning Critical Care project on the hospital's 7th Street campus. Development Council members are committed to raising \$14.75 million in charitable funds for this \$46 million project to renovate and expand the Emergency Department (ED), Intensive Care Unit (ICU), and Interventional Cardiology Services. Thanks to our loyal donors and generous community, nearly \$9.2 million has been raised to support this important project.

### Project Phases

- 
**PHASE ONE:** Completed in July 2022  
 Adult ED Waiting Room, Rapid Response Area, Triage Area, Pediatric ED & Waiting Room, and the Pediatric In-Patient Unit
- 
**PHASE TWO:** Completed in August 2022  
 ICU and the ICU Waiting Area
- 
**PHASE THREE:** Completed in September 2022  
 Cardiac Catheterization Labs
- 
**PHASE FOUR:** Projected completion in February 2024  
 Renovations of ED Patient Rooms

# Campaign Leadership Gifts

**Tom and Patsy Houck have been members of the Order of the Good Samaritan since 2001. They are also leadership level contributors to the ReEnvisioning Critical Care Campaign.**

“We have been hospital contributors for the past 21 years,” says Patsy, “ever since Tom’s cancer diagnosis and excellent treatment by Dr. Greg Rausch. We felt so personally blessed that we started donating to the Cancer Patient Assistance Fund – and still do – which helps pay for medicine, supplies, and supportive services for those who can’t afford them.”

“As special projects came up we would contribute,” says Tom. “My grandmother was one of the original nurses who graduated from Frederick City Hospital School of Nursing. When the hospital renovated its patient rooms, we had a room named after her.”

“We try to support every project the hospital takes on. When fundraising began for the James M Stockman Cancer Institute, we made a larger donation since I had been affected by cancer,” says Tom. “Our gift was acknowledged with a treatment area dedicated in our names. Sometime after, the father of one of my team members was diagnosed with cancer and she told me that the entire family was anxious about going in for the treatment visit – until she saw our names on the door. She said it made her feel more at ease; as though we were there. We were so incredibly moved when we heard this it brought tears to our eyes.”

“In 2019, we made a gift to the ReEnvisioning Critical Care Campaign. This past June we were able to get a construction tour of the facility. We met the nursing directors of each of the critical care units and you could tell how excited they were about what this expansion would mean for patients and their families. This moved us to make a second gift in support of the project. We are all fortunate to have this level of care in our backyard,” said Patsy.

“Both of our parents have been to the hospital for cardiac care, ER visits, hospice care and more,” said Patsy. “We’ve had nothing but excellent experiences and want to help make certain this level of care is available to everyone. That’s how we were brought up.”

During his tenure at the FCPS Central Office, Ted developed curriculum for FCPS's first multicultural studies to increase local awareness for diversity and respect for all people. He was later named supervisor of the Multicultural Department where he developed diversity training program for school system personnel. Ted retired from FCPS in 2011 with 36 years of service.

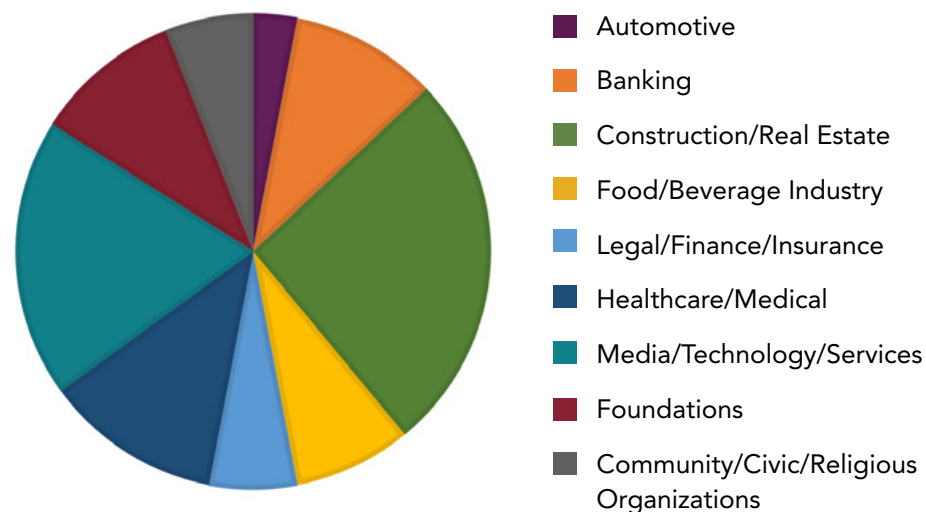

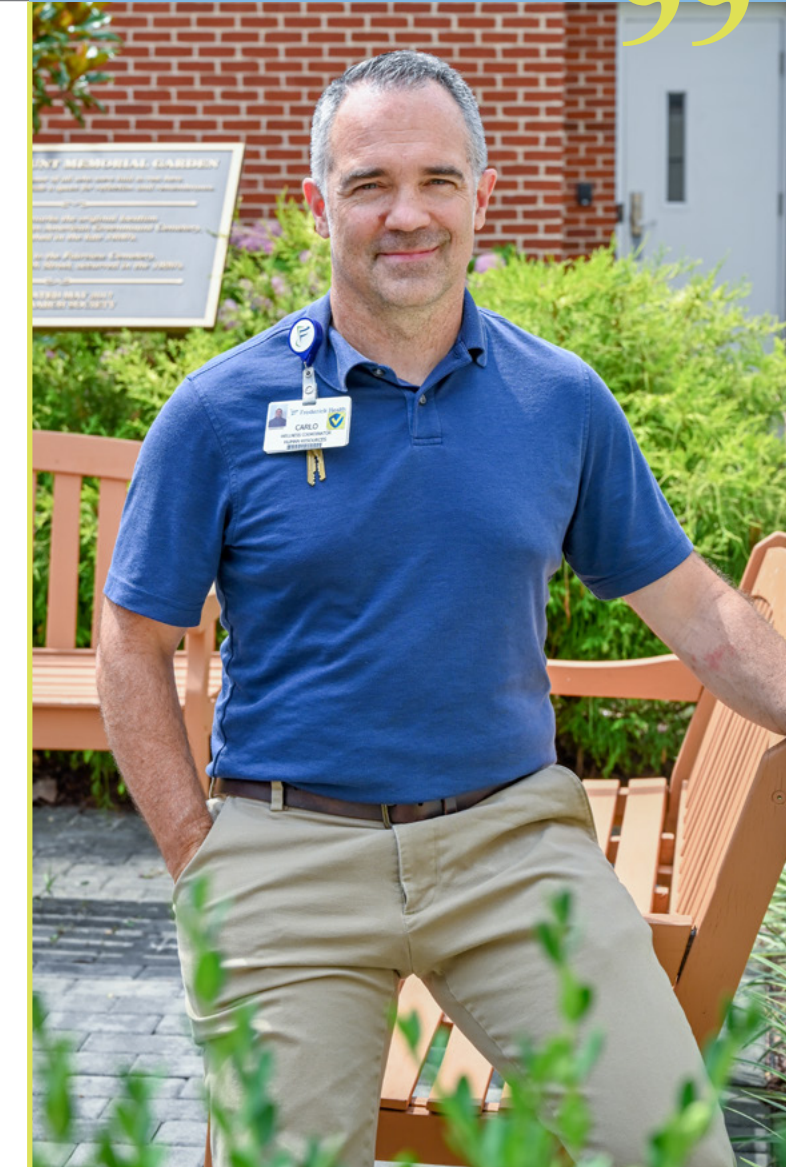

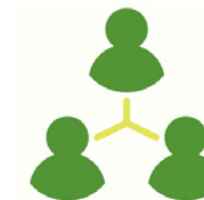

## A Gift of *Lasting Impact*

Upon her death in November of 2020, Carol Fisher donated \$4.4 million from her estate to Frederick Health — among the largest cash gifts the health system has received from an estate.



In July 2021, Frederick Health received a generous bequest in the amount of \$4.4 million from the estate of Ms. Carol Fisher. Per Ms. Fisher's wishes, this gift will be restricted to Frederick Health's cancer program, which she chose to support after her mother received excellent care in the 1990s. Frederick Health will honor Ms. Fisher's desire to promote and enhance the well-being of cancer patients by using her gift to fund several cancer treatment services and programs. Some of the areas that will benefit from this donation include the expansion of the Precision Medicine & Genetic Program, as well as the purchase of new oncology equipment such as the RayCare Oncology Information System and the ION Lung Cancer biopsy machine.

"As a non-profit healthcare system, Frederick Health has always benefited from the generosity of our community," said Tom Kleinhanzl, President & CEO of Frederick Health. "By using this gift to expand our cancer treatment programs, we will help to save the lives of people in this community and celebrate Ms. Fisher's legacy."

Additionally, a generous portion of the donation was used to create an endowed Oncology Education Fund to benefit staff, patients, and the community. This fund will provide classes, training, and informational programming on cancer prevention techniques, new treatments, and other cancer-related topics. "Frederick Health is leading the way when it comes to innovative cancer treatments," said Pat Rice, Clinic Director for the Precision Medicine & Genetics Program. "Ms. Fisher's donation will go directly towards helping to detect future cancer diagnoses in the community and treating those individuals with the best methods available."

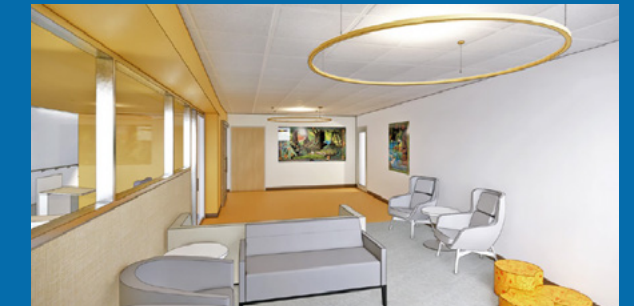

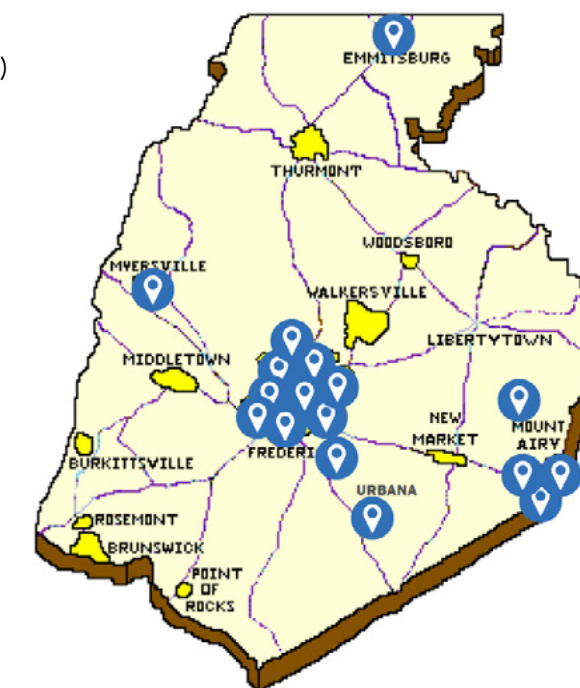
# Here We Grow Again!
