#### **Site description**

Northern Plains Grassland (Corop sub-community) adjacent to wetland and lake. Only known example of this subcommunity. Described in McDougal and Kirkpatrick WWF. Surrounded by intensive irrigated farming land (tomato).

#### **Threatening Processes**

- 1. Ploughing, slashing and or grading.
- 2. Spray drift adjacent farming.
- 3. Irrigation tailwater entering the roadside.

### Management

- 1. Spring survey of flora present.
- 2. Signpost significant roadside.
- 3. Discuss management of roadside with adjoining land managers.
- 4. Rehabilitate disturbed areas.
