Site description

Overstorey dominated by White Box. Grey Box, Yellow Box and River Redgum present. Moderate regeneration. Abundant deadfall and litter. Moderate to abundant cover of native grasses. Good linkages to Broken Creek.

Threats

1. Exotic grasses and weeds.
2. Vehicle track runs through site.
3. Drainage channels
4. Rabbits

Management Options

1. Erect signage to highlight sites values and constraints.
2. Establish trial sites for seasonal control of exotic grasses using strategic burning/herbicide/grazing. Monitor results.
3. Conduct Spring flora and fauna surveys
