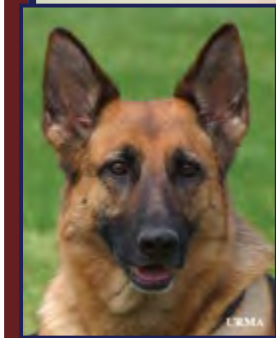

IGP (International Gebrauchshund Prufung) will be under way by the time you receive this issue of the magazine. The USCA version of the FCI Rulebook will be available on the website for download. At all USCA trials this will be the official rulebook for USCA events. It is an edited and corrected version of the English Version that is available on the FCI website. There were some mistakes and missing clarification in the FCI translated version that have been corrected in our version (it is labeled USCA ver:1.0) as well as some previously approved USCA variances. All fundamentals of all exercises and titles remain the same in our version of the rule book as is intended and approved by the FCI and accepted for use by the WUSV. A condensed explanation of the differences and/or corrections will be available on the USCA website as well.

In addition we will have a supplemental rulebook available on the USCA website titled "USCA Trial Addendum / Variances and additional guidelines". It is about 12-15 pages at this time and outlines specific USCA approved variances and information (trial days, field setup, minimum field size, shortcut to common reasons for Termination and Disqualification and more). All USCA members and clubs should have both copies of the Addendum and the rulebook available for review. I will do my best to keep USCA up to date on any additional clarifications or changes as we implement IGP.

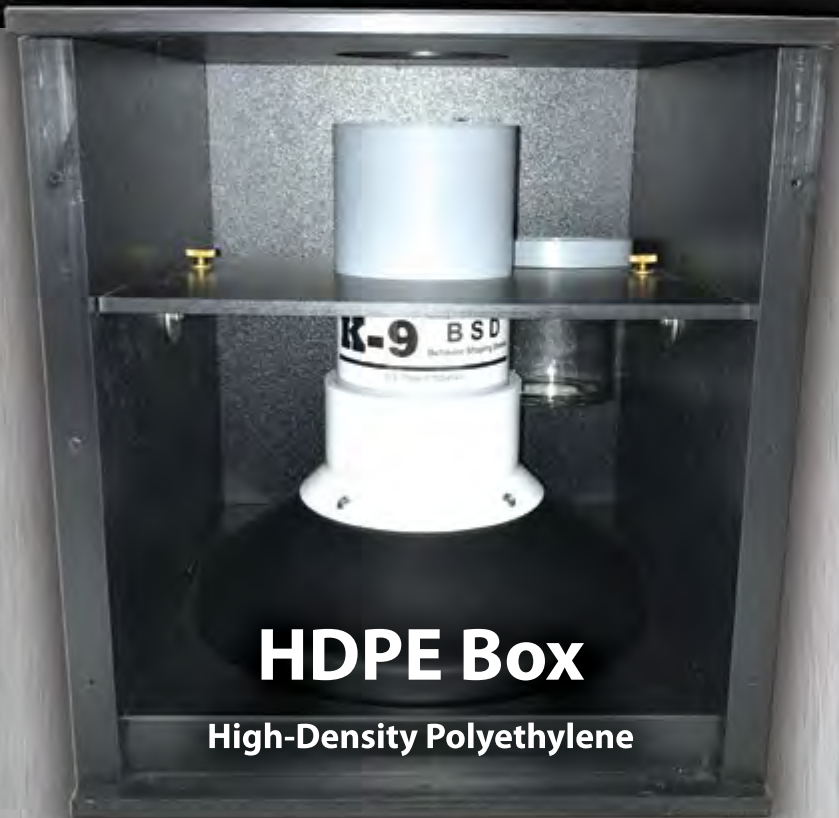
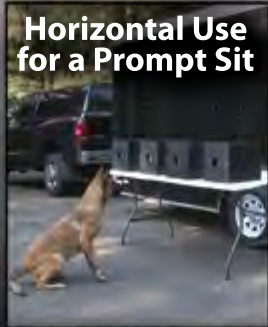

What are Chelated Minerals and Why You Should Care

If you have paid attention to dog food labels and nutrition claims, you have probably run across the term “chelated minerals” and may have wondered what they are. In short, chelated minerals, also referred to as organic trace minerals, are inorganic minerals which have been bound to an organic molecule, typically an amino acid, through the process called chelation.

Benefits of Chelated Minerals

Chelation is a process which occurs naturally during your dog’s digestive process. Unfortunately, the process is not always very efficient and many of the essential trace minerals may not be absorbed in their inorganic state during the digestive process. Chelated minerals basically remove the inefficiency to ensure your dog is able to absorb and use the trace minerals that are ingested. Research has shown that chelated minerals are absorbed at anywhere from two to five times the rate of the same minerals in their inorganic forms. Basically, if your dog is fed only inorganic trace minerals, anywhere from fifty to eighty percent of the minerals are passed without being absorbed.

Another benefit of chelated minerals is that they are ionic compounds and electrically neutral. This means that they do not block the absorption of each other or other nutrients. It also means that they do not degrade the vitamins in the diet in the way that inorganic minerals can.

Identifying Organic Trace Minerals

Understanding that organic trace minerals are a good thing, you might be wondering if there is an easy way to spot make sure your food is using them. Many foods do not specifically mention chelated minerals and there are different ways of labeling that do not necessarily use the words “chelated” or “organic”. Using Zinc as an example, here is a quick way for you to tell if the trace minerals in your food are organic.

Inorganic Examples – Zinc Oxide, Zinc Chloride or Zinc Sulfate

Organic or Chelated Examples - Zinc Proteinate or Zinc Amino Acid Chelate

These same labeling examples for Zinc can be applied for the other essential trace minerals including Iron, Copper and Manganese.

Why Doesn’t Everyone Use Chelated Minerals?

There are still a lot of dog foods out there that continue to use the inorganic minerals. You might be wondering, if chelated minerals are better, why everyone isn’t using them. If you do not know the answer already I would be willing to bet you could guess the answer pretty easily. Chelated minerals can be quite a bit more expensive than the inorganic versions.

Some foods will even use a combination of the inorganic and the chelated minerals so they can say they have chelated minerals but still cut costs by using the less expensive ones as well. There is no viable reason to do this other than to reduce cost. While we understand that cost is always somewhat of a consideration, vitamins and minerals are not a place we would encourage anyone to compromise. If your dog food does not use chelated minerals, preferably exclusively, we would recommend you look for an alternative food that does.

On a beautiful September 8th weekend, the San Jose German Shepherd Club had the honor to host the 2018 Northwestern Regional Championship. A total of 26 dogs competed that weekend, including 17 IPO3's, two IPO2's, one IPO1 and six BH dogs.

The Competitors

First-time HOT handler, Sandy Lynch with her bitch Rocca Vom Haus Tyson, is the Northwest Regional Champion, with an overall score of 284. Achieving a 95 in both tracking and obedience and a 94 in protection, Sandy garnered the High in Trial, High Hot Team and High Hundin titles. This was her first attempt at an IPO3 title. Never considering the podium, she entered the field with aspirations of qualifying for the 2018 Nationals and hoping that everyone did well.

Robin Eales and her dog, Eich Vom Steinbeckland, is Vice-Champion with a score of 283. Her 97 tracking score earned High in Tracking and with a 96 in Obedience and a 90 in Protection, she was also awarded the Jim Lempner Excellence in Handling trophy. Striving always to improve her knowledge of IPO training, she is looking forward to entering the 2018 Nationals in Pittsburgh.

Jason Yan with Nanno du Triangle Magique came in third with scores of 94 in each phase, equaling 282 points. This Championship was particularly intense as he had two dogs entered. He is hoping his busy schedule will allow him to compete in Pittsburgh as well.

The fourth place position went to longtime competitor Deleta Jones with C Mako vom Haus Bergblick, who earned 282 with scores of 94, 96 and 92 in the respective phases. She too will compete at the USCA Nationals in November.

Also heading to the Nationals is Cheryl Green with Expert Barnero, who came in 5th with a 91, 94 and a 93 for a total of 278.

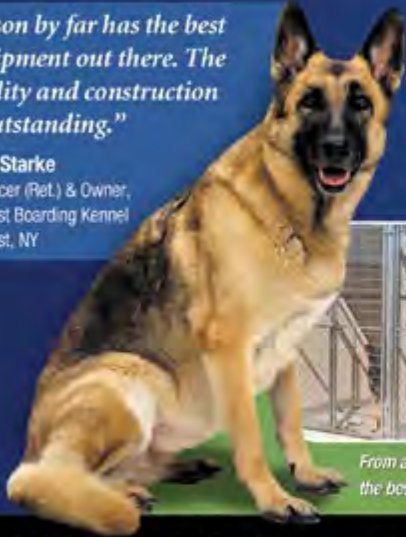

- An email stating his/her desire and availability to be considered for pre-selection to perform the helperwork at one or more of the following: USCA's Sieger Show, Working Dog Championship, German Shepherd Dog National IPO-3 Championship, Qualification Trial for the Selection of the USA (USCAGSDCA) WUSV Championship Team.
- An electronic copy of the Helper's USCA membership card with expiration date. This will be used to verify that the Helper's USCA membership will be current during the Event he/she desires to be considered for. The Helper Program Director/Committee Chair will contact the USCA office via email to verify that the Helper is in good standing with USCA.
- An electronic copy of all pages of the Helper's USCA Trial Helper Record Book. This will be used to verify that the Helper's Classification Level of Regional, National or Teaching Helper will be current during the Event he/she desires to be considered for and that the Helper has not received an Unsatisfactory Rating from a Judge.
- A video link (e.g., youtube, etc.) of the Helper performing the helperwork for the entire IPO-3 protection routine. This, in conjunction with the results of the review of the Helper's Trial Helper Record Book, will be used to assess the Helper's ability to perform the helperwork in the National event.

After a review of the above submitted information is complete, the Helper Committee will recommend a slate of Helpers for the Event to the Executive Board for approval. 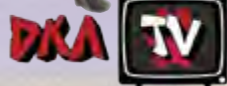

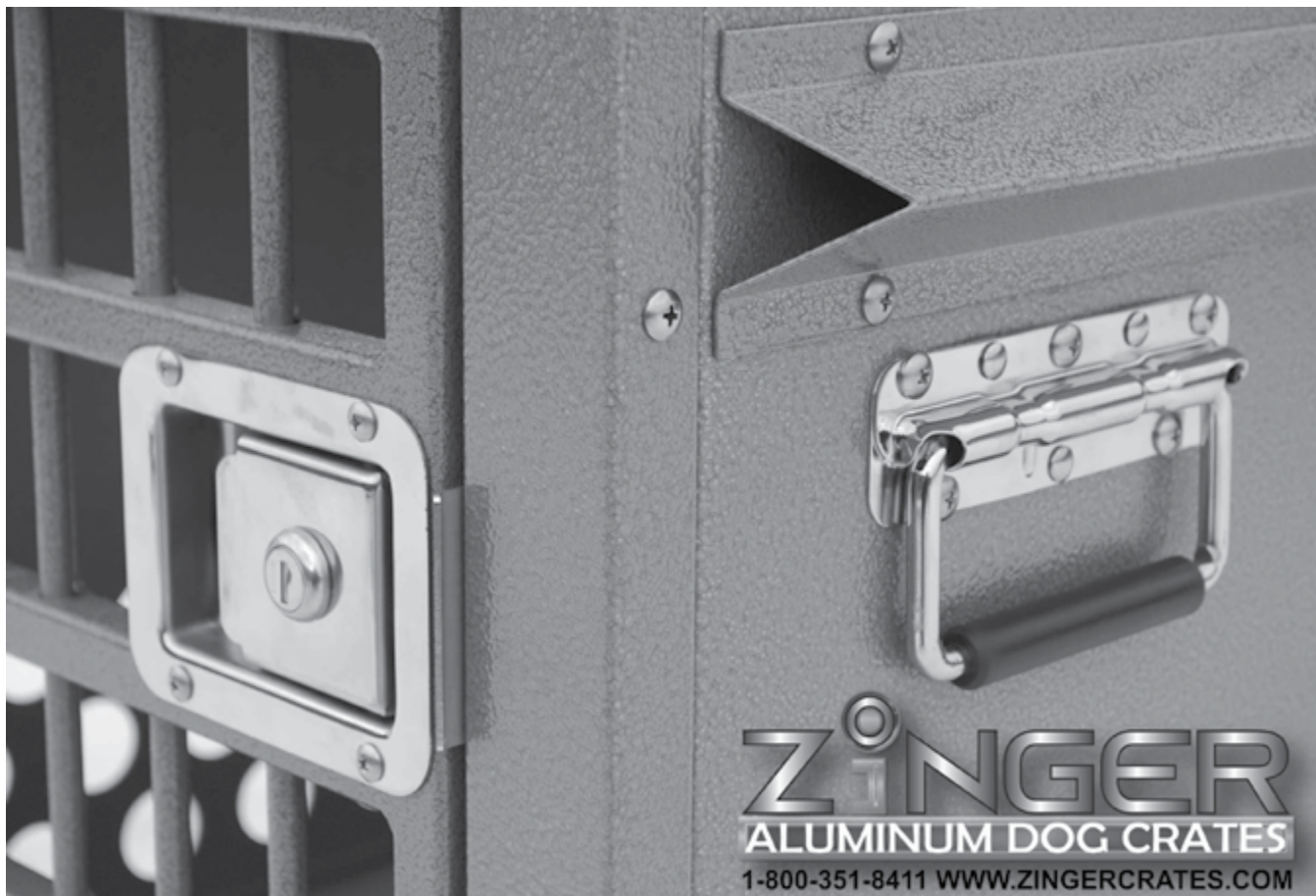

Dennis Vander Linde: The EB needs to understand the factors that influence regional championship participation per region. Our regional championships need to be healthy, as well as the WDC, and the quality of the dogs USCA sends to the USA WUSV qualification trial must be the best possible. Only with this information can the EB make a more informed decision. Until then, regional championship participation should be the first priority, which was the original intent of including it as one of the requirements to go to the USCA nationals.

Michele Scarberry: I recommend the WDC goes into a rotation schedule to lessen the hardships to effected Regions.

Background: The USCA Judges Program requires the General Board or Executive Board to pass the motion to grant / award a USCA Judges Permanent License.

This was submitted late to the GBM. It could not be on the agenda and could not be voted on at the GBM.

Zoltan Nagy is eligible at this time this motion is presented to the Executive Board instead of waiting 12 months to the next General Board Meeting, the GBM will still have the right to affirm this decision or request a new vote.

Zoltan Nagy as a probationary judge has exceeded his requirements and should not have to wait another 12 months to receive his Full License.

The USCA Judges Committee recommends the approval of a Permanent Performance / Trial License for Zoltan Nagy. He has met and exceeded all of the requirements as a probationary judge. EB Motion #34-18 Accept and amend the BOI sanctions regarding USCA Member Anjuli Kolarik

Motion by: Michele Clubb, Secretary, seconded by Dennis Vander Linde, DAL to accept the BOI's findings and amend the sanctions on USCA Member Anjuli Kolarik

Amended Sanctions: Anjuli Kolarik is to serve a ten (10) year suspension. She will never be permitted to hold or seek any office in USCA and will remain on permanent probation status; this would allow permanent expulsion from USCA if she is ever found guilty of an animal related neglect, cruelty, or abuse charge in the future.

Background: BOI charges were filed against USCA member Anjuli Kolarik by the USCA Secretary for animal abuse.

After the BOI's investigation, the BOI submitted their findings and proposed sanctions to the EB for final approval. See website for more detailed information.

After the EB reviewed and voted on the original motion #27-18, there was discussion that the sanctions were not consistent with animal abuse cases in the past. The EB voted on motion #29-18 to ask the BOI to reconsider the sanctions placed on Anjuli Kolarik.

The BOI sent back a response to the EB (see website) stating they did not feel that the USCA bylaws allowed them to reconsider the sanctions, but stated that the EB could amend them based on the USCA bylaws.

After discussions with the EB, it is recommended that the amended sanctions be presented to the EB for a vote.

MOTION CARRIED NOVEMBER 14, 2018

The USCA Judges' Committee has revoked Chris Thompson's Judges License and removed him from the United Schutzhund Clubs of America Judges' Program for Conduct in violation and not in accordance with the "USCA Judges Code of Conduct".

Motion 35-18 was presented to the Executive Board by the USCA Judges Committee after a complete investigation was conducted regarding a formal complaint against him.

It was determined that he was clearly in violation of the "Judges Code of Conduct" based on this complaint. It was also determined to be similar conduct and actions that he had previously received a warning from the USCA Judges Committee in July 2018 regarding conduct towards USCA Member / Members while representing the organization as a Licensed Judge.

The motion to revoke his Judges License was ratified by the USCA Executive Board vote on 11/15/2018.

Effective 11/15/2018 Chris Thompson is no longer a USCA Licensed Judge or member of the USCA Judges College.

All titles awarded by him prior to this date will remain fully recognized by USCA, WUSV and the FCI.

After all facets of this original application are complete, the names of the new USCA Judge applicants will appear in two issues of *Schutzhund USA*. Anyone wishing to comment as to the character or qualifications of the new applicants may do so in writing to the Judges Committee Chairman, Nathaniel Roque. These written comments must be received no later than four weeks following the second publication of the new applicant's name.

The Apprentice Judges are those who have met all training requirements. Apprentice Judge Trainees are those who still have not met the training requirement of titling one dog through a SchH3, a second dog to a SchH1, as well as obtaining an FH on a dog trained by the candidate. The apprentice trainees are yet to fulfill all requirements of the program but are currently active in training a dog toward that goal. All of the requirements for the USCA Apprentice Judge Program can be obtained by contacting the USCA Director of Judges.
