Directors' Foreword

Through the efforts of Dr. Vassos Karageorghis, Director of the Cyprus Department of Antiquities for a quarter of a century until 1989, Cypriot art and archaeology have achieved international recognition. Symposia and loan exhibitions from Cyprus have given a clearer and more detailed picture of the history of the island to an ever-wider audience. This exhibition offers Americans a rare chance to see examples of the art of prehistoric Cyprus. The small and beautifully modeled figures of highly polished picrolite and other important archaeological material help to explain one of the least-understood periods of Cypriot prehistory, the Chalcolithic. We are delighted that these thirty-two objects from Cyprus also include the "Lemba Lady," the only known large-scale limestone idol other than the one at the Getty Museum.

We are deeply indebted to Dr. Karageorghis, currently Advisor to the President of Cyprus on Cultural Property, for initiating the exhibition and proposing a symposium on Chalcolithic Cyprus when he visited the Getty Museum in 1987. The Cyprus Department of Antiquities, whose Acting Director is now Mr. Athanasios Papageorghiou, and the museums of Cyprus have been generous in lending important, recently excavated material from the Neolithic and Chalcolithic periods. Dr. Dimitri Michaelides was helpful in selecting material from the Paphos Museum.

Mr. M. Loulloupis, Curator of the Archaeological Museums and Surveys of Cyprus, has been unselfish with his time in facilitating the loan of the objects and the preparation of the catalogue. Dr. Edgar Peltenburg, Director of the Lemba Project and Reader in Near Eastern Archaeology at the University of Edinburgh, has written the essay on Chalcolithic Cyprus and provided helpful comments during the compilation of the catalogue; Dr. Pavlos Flourentzos, Archaeological Officer of the Cyprus Department of Antiquities, has written the entries for the Cypriot material; and Susan Davidson has compiled the entries for the Menil Collection. The manuscript was prepared by Dorothy Osaki, Senior Secretary in the Department of Antiquities, and the publication was seen through production by John Harris, Associate Editor, both of the J. Paul Getty Museum.

To all those just mentioned, and to curators Marion True and Bertrand Davezac, we offer our admiration and gratitude.

Introduction

SINCE THE DISCOVERY and investigation of the Neolithic and Chalcolithic cultures of Cyprus by my predecessor Porphyrios Dikaios nearly fifty years ago, much new information about these cultures has emerged thanks to excavations and new methods of dating. Of the two periods, the Neolithic has, until recently, received far more attention, perhaps because of the many unsolved problems, chronological and other, connected with it. Apart from Khirokitia and Sotira, where the initial investigations were carried out, at least two new settlements were excavated, at Cape Andreas and Kalavassos-Tenta. The Chalcolithic period, on the other hand, known mainly from the limited excavations at Erimi and stray finds from other sites, was considered a transitional period of short duration between the Stone Age and the Bronze Age, and many scholars felt that its material culture had very little of significance to offer.

This picture has changed dramatically during the last fifteen years. Although the Chalcolithic site at Souskiou-Vathyrkakas near Palaepaphos was severely damaged by looters, it has produced some extraordinary objects, mainly from tombs, which increased considerably not only the repertory of Chalcolithic art (pottery, terra cottas, stone statuettes) but also our knowledge about Chalcolithic culture in general. Scholars were attracted by this new influx of material, and several studies were undertaken, not only of the new material but also of objects kept for many decades in museums.

It is not, therefore, surprising that new, systematic excavations were planned and carried out at sites that have been discovered since the excavations at Erimi. The results of these excavations have been the revelation of the robust, sophisticated, and lively physiognomy of Chalcolithic Cyprus. At Kalavassos-Ayious a limited excavation sponsored by Brandeis University and led by Ian Todd uncovered mysterious tunnels (perhaps used for habitation) and a new repertory of objects (pottery and terra cottas). It was in the Paphos District, however, that the most exciting excavations were carried out. A wellplanned project to investigate the area north of Paphos, known as the Lemba Project of the University of Edinburgh and led by Edgar Peltenburg, has been offering us surprising results since 1976. At Lemba-Lakkous first, and then at Kissonerga-Mosphilia and Mylouthkia, new evidence has been uncovered, including impressive architectural remains, burials, stone artifacts, pottery, terra cottas, copper objects, and even beads of faience-unique testimonies of the daily life, religious beliefs, and social structure that help to make the

Chalcolithic period one of the most fascinating phases of Cypriot prehistory. As a result of these excavations, together with investigations at Maa-Palaeokastro and a surface survey in the area adjacent to Lemba and Kissonerga, the southwestern part of Cyprus, from Erimi to Maa-Palaeokastro, is now known to have been an important cultural center for a period lasting about 1,500 years. The Chalcolithic period is no longer considered a secondary transitional period but one of utmost importance in its own right. The study of this era's relationship with the Late Neolithic and Early Bronze Age has begun, and several excavation reports and syntheses have already been published. I would predict that this period, together with the Late Bronze Age, will dominate archaeological research in Cyprus for the next decade at least.

It was natural, therefore, that the need for a conference on Chalcolithic Cyprus should be felt. In 1987, on a visit to Malibu, we discussed with the director of the J. Paul Getty Museum and his colleagues the possibility of organizing such a conference at the Museum early in 1990, its purpose being a general survey of the Chalcolithic phase of Cypriot prehistory. The interest of Director Walsh and his associates was increased even more by the presence in their collection of a major work of Chalcolithic stone sculpture from Cyprus; the idea for a conference was eagerly accepted. In addition, a suggestion that I put forward for the organization of a small exhibition of Neolithic and Chalcolithic objects from Cyprus was approved by the government of Cyprus, and thus the "Malibu Lady" (the stone statuette referred to above) will play host to a number of relatives from home.

To all those who worked on the organization of the conference and of the exhibition, and particularly to the Getty Museum's Director, John Walsh, and to Marion True and Kenneth Hamma of the Department of Antiquities, as well as to my colleagues in the Cyprus Department of Antiquities, we express warm thanks. We should also mention the assistance of Walter Hopps of the Menil Collection (Houston), who, together with Marion True and myself, selected the objects in the museums of Cyprus. I hope that the exhibition and the proceedings of the conference will foster the study of the culture of Cyprus among scholars. I also hope that they will inspire the sympathy of the American people, who have recently seen evidence of the ways in which the rich cultural heritage of Cyprus has suffered as a result of invasion and occupation. We hope that the proceedings of the conference along with the catalogue of the exhibition will constitute the first handbooks on Chalcolithic Cyprus.

Chalcolithic Cyprus

Edgar J. Peltenburg

THE PERIOD OF some 1,500 years from about 4000 to 2500 B.C. witnessed unprecedented developments in the history of Cyprus. There is clear evidence for a significant growth in population and the emergence of social ranking. Copper was used for the first time on the island whose later prosperity and very name were to become synonymous with that enviable resource. Metallurgy and social hierarchies have often brought conflict with them, yet fortifications and weaponry were entirely lacking in this period. Throughout the island, settlements of varied size, none of which could be classed as urban centers, consisted of novel circular buildings that strike one as anachronistic insofar as there had been a tendency to rectangularity in the preceding Neolithic period. Once established, this circular architecture remained the norm for over a millennium. Amidst these innovating and conserving tendencies there arose highly distinctive sculptural traditions that mark the zenith of artistic achievement in Cyprus before the Bronze Age. Despite the evidence for occasional overseas contacts, the island's flourishing Erimi Culture, so named after a type-site near the south coast, remained essentially unaffected by foreign influence.1

Recent research has demonstrated that the conventional division of this lengthy epoch into periods known as Chalcolithic I and II is no longer capable of satisfactorily encompassing all the evidence, and hence some modification is called for. In particular, we need to take into account the discovery of a formative stage (which could only be vaguely discerned at the key site of Erimi) and a much better defined post-Erimi stage. So distinctive are these episodes that, without wishing unduly to separate what was essentially a cultural continuum, it will be useful to refine the traditional scheme proposed by Porphyrios Dikaios into Early, Middle, and Late Chalcolithic periods.² Such a refinement, it should be emphasized, is necessary if we are to grasp the causes of change and evolution in what must be regarded as one of the most distinctive and artistically prolific prehistoric societies of the Mediterranean region. It should also be stressed that because so few sites of this neglected period have been investigated, any reconstruction must still be regarded as tentative.

EARLY CHALCOLITHIC PERIOD

(circa 3800-3500 B.C.)

EARLY SETTLEMENT PATTERNS on Cyprus are characterized by repeated shifts of locale. Continuous settlement drift suggests chronic instability, perhaps due to the inability of the society to exploit its resources sufficiently to cope with increased population. There is some reason to believe that a more general dislocation took place at the beginning of the fourth millennium B.C. In contrast to most Late Neolithic sites before that time, subsequent occupations have failed to yield upstanding stone architecture, suggesting a major change in settlement type. Moreover, these sites produced new styles of pottery and other artifacts, several of which have proved to herald long-lived traditions. It is, therefore, a formative period in which many critical changes took place.

Early Chalcolithic sites such as Kissonerga-Mylouthkia and Kalavassos-Ayious largely comprise hollows, pits, and tunnels.³ Arguments that these are the subterranean components of eroded settlements that once possessed highly perishable structures have recently been bolstered by the extensive occurrence of daub and postholes at Maa. Suggested reasons for such apparently radical settlement transformations include changes in economy, the establishment of new sites in territory requiring woodland clearance with timber re-usage, and environmental deterioration. By themselves such reasons are not very compelling, but a combination of these and other factors may underlie the observed developments. Subterranean hollows and tunnels are in any case well-attested features in Late Neolithic times.⁴

In spite of their unpretentious nature, these pit-sites have yielded a most informative range of artifactual evidence. Ceramics, worked bone, and ground-stone tools and vessels, while exhibiting a stylistic evolution, are thoroughly in harmony with earlier insular traditions. Even the prodigious output of ceramic and stone figurines, stone pendants, and the advent of metalwork may be explained in insular terms. We may thus exclude foreign inspiration for the genesis of Chalcolithic Cyprus.

Recovered figurines are mostly fragmentary, yet the painted designs on the legs, the elliptical heads with only the eyes and nose articulated, and the short, flange-like extensions for the arms are all incipient features of later canonical types.⁵ Comparison with anthropomorphic representations from the Late Neolithic shows a vast increase in production, a new tendency toward the delineation of a

specifically human form (usually female), and the use of clay. While it is clear that coroplastic art in Cyprus, a major form of expression in antiquity, commenced at this time, so confidently schematized are the figures that the origins of the style presumably existed in other, perishable mediums. Fragments of zoomorphic vessels confirm that the plastic qualities of clay were being exploited as never before and that the fantastic creatures from later Souskiou also belong to a terra-cotta tradition that was established at this time.

The development of new modes of expression is also evident in the production of pendants in bone, shell, and above all picrolite, a soft stone akin to steatite, the finest examples being a vivid bluegreen. This stone, the hallmark of Chalcolithic Cyprus, was used previously, but only for uninspired plain pendants. Now the repertory was expanded in several directions, including incipient cruciform-shaped figurines. The intensified exploitation of picrolite may have been instrumental in a major discovery, copper.

Located around the Troodos Massif in a zone known as the "copper belt" and in smaller pockets elsewhere are surface exposures of copper with bright, attractive colors. In some cases the sources lie close to picrolite seams. Both materials were subject to erosion by rivers, and their distribution was thereby extended in certain drainages. That a copper artifact, in the form of a hook from Mylouthkia, occurs at this time may well be explained in the context of a determined search for picrolite.7 However, it has also been suggested that the trace-element composition of the hook is unlike analyzed native coppers of Cyprus.8 While further analyses of this unique object are desirable, its composition raises the intriguing possibility that sources outside the copper belt area were being exploited or that copper was one of the earliest materials imported to Cyprus. Even were that to be the case, it is hardly enough to sustain arguments for extensive foreign contacts, and so the most satisfactory explanation for the diverse changes in this formative period is likely to be found on Cyprus itself.

MIDDLE CHALCOLITHIC PERIOD

(circa 3500-2800 B.C.)

WITH THE APPEARANCE of conventional settlement and funerary evidence in the archaeological record, it becomes easier to consider cultural developments in their social setting and so move from description to interpretation. A model commonly deployed by explicitly deductive archaeologists to interpret their data is that of anthropologically observed societal types such as tribes and chiefdoms. The former is characterized by a largely egalitarian social structure based on a domestic mode of production; the latter by a two-tier social hierarchy with differential access to resources, and centers for the redistribution of economic goods and ritual activities. In terms of material culture these societal types are often suggested by sites of similar size with little evidence of craft specialization, or by sites of different size with storage centers and public structures such as temples. There may well have been other forms of social evolution in antiquity, but we may at least observe clear signs of the emergence of social ranking in this phase of the Chalcolithic, if not before.

Lemba Period I is the earliest Chalcolithic site with wall foundations. Here, circular structures with central platform hearths reveal what was to become the architectural pattern for Cyprus until circa 2300 B.C. Houses were small, approximately three meters in diameter. Built with pisé, that is, rammed earth, foundations, they were interspersed with graves below a terrace that also contained pit burials. Although there were no grave-goods or stratigraphy to link the two parts of the site, it is inherently likely that the two were contemporary and that located on the upper terrace is the earliest cemetery in Cyprus. In a number of cases the buildings were located over roughly circular pits of the same size, and this congruence, which can be interpreted as a desire to place structures in the protection of existing hollows, may account for the distinctive circular building tradition of Chalcolithic Cyprus.⁹

Later sites, such as Lemba II, Lapithos, Kythrea, and Erimi VII-XIII, have much more substantial and permanent structures with stone wall bases. They are sometimes twice as large as the Lemba I buildings and there are signs of intra-site differentiation, with annexes at Erimi and the juxtaposition of large circular with small rectilinear buildings at Kissonerga-Mosphilia, for example.¹⁰

The much larger structures of Kissonerga merit special attention. Its Building 2 has a diameter of over ten meters and an internal area of seventy-seven square meters. Adjacent to it is part of

an even larger structure with radial walls supporting a roof span of a minimum of fifteen meters and rooms with red-painted floors and walls. Since no site of this period has been completely excavated, it is still uncertain if this outsize group of structures is unique to Kissonerga or was a component of other sites. Whatever the case, the group argues for the existence of impressive engineering skills and a sector of society that had privileged access to the required labor. That the earliest pithoi in Cyprus should be associated with these exceptional structures is also significant in terms of the control of stored bulk commodities.

This slender hint of inter-site, perhaps territorial, differences is corroborated by variations in artifact assemblages and in funerary practices. Single-inhumation pit burials with few if any grave-goods continued to be placed inside settlements. At Souskiou, however, two or three cemeteries provide a sharp contrast to other burials of the period in terms of their deep, bell-shaped shafts, multiple interments, and rich funerary furniture. Grave-goods include fantastic zoomorphs such as a centaur and askos, dentalium shell necklaces with multiple cruciform pendants, and a metal tube.¹¹ Much of this may be regarded as evidence for the interment of high-status goods. When set against the poverty of other burials, it seems once again as if certain sites enjoyed a special status.

More frequent ritual activity serving broad social functions can be another sign of ranking in society. For this reason the discovery of a ceremonial area at Kissonerga is highly relevant. It comprises pits filled with ash and heat-cracked stones; in addition, some have stacks of pottery bowls with, in one case, a cache of nineteen figurines, a model stool, an intact triton shell, and twenty-seven stone tools. Most of these objects were packed inside a model of a building with a detachable door that swung on a pivot, a central hearth, radial floor partitions, and walls with unique painted designs. These walls had been concealed by a thick monotone slip. Protomes over its entrance had been deliberately damaged, just as many of the fragmentary figures show signs of intentional breakage. Three of the figures are seated on what must be regarded as birthing stools since one female figure has the head and arms of an emerging child painted on a panel inset between its legs. Such a concentration of sacred ritual in a public area clearly transcends household activities, even if it does not seem to have occurred in a defined holy precinct.12

It would seem from the foregoing that there was differential access to wealth and some form of social ranking in Middle Chalcolithic Cyprus.

The flourishing nature of Cyprus at this time is epitomized by the abundance, sophistication, and variety of its sculptural and coroplastic art. Anthropomorphs were executed in several kinds of stone, plain terra cotta, painted pottery, and bone.




Figure 2. The only intact dentalium necklace of Chalcolithic Cyprus, belonging to a child. Grave 47 at Lemba-Lakkous, circa 3000-2500 B.C.

The most distinctive anthropomorphs were cruciform pendants of picrolite. The short necks, flange-like arms, and drooping legs of Early Chalcolithic figures were now developed into classic cruciforms: elliptical heads, long necks with pronounced Adam's apples, elongated bar-like arms, and legs sharply drawn up at the knees (cat. 31). Facial features, if articulated, typically comprised relief squares for the eyes separated by a disproportionately long relief rectangle for the nose. Arms were sometimes imaginatively transformed into second figures (cat. 30). Large versions were suspended at the neck, as depicted on the Yialia figure, smaller ones on necklaces that could also carry other pendants, such as the unique twenty-eight-rayed disk from Lemba (fig. 1; see also fig. 2). The nature of picrolite, an ultrabasic rock occurring as thin seams or as small pebbles in riverbeds, precluded the creation of statuary in this medium.¹³

In order to fashion larger-scale representations, sculptors

worked in soft local limestone. Currently only two examples are known, the disturbing "Lemba Lady" (cat. 12) with its phallus-shaped neck and head, and the elegant Getty Museum figure (cat. 13), each approaching forty centimeters in height. Though preserving many of the salient features of the cruciforms, they were clearly too large to function as pendants. The lack of stylistic homogeneity in works in this and other rock types is made evident by smaller representations that include coarsely modeled figures with stump arms, totally plain cross-shapes, figures resembling gingerbread cutouts, and more naturalistic females with outspread arms and phalluses. Sexual dimorphism may be suspected in many of the figures. All kinds of rough or water-worn pebbles suggestive of the human form were also collected.¹⁴

Our appreciation of the range of the ceramic anthropomorphs has, until recently, been severely hampered by the fragmentary nature of the surviving figures. Females predominate, with disk-like heads bearing facial features that range from the abstract to the naturalistic, with outstretched arms and elaborately painted torsos, some with surprisingly realistic modeling (cat. 17, 18). They were found in large numbers at Erimi, where in spite of the deep stratigraphy there is little evidence for an evolution of types. Complete but less securely provenanced figures include lactating females and a

hollow seated male with erect penis. His projecting eyes, thick lips, hands raised to head, and seated posture on a stool—features that might once have been regarded as atypical—may now be seen as part of the Cypriot repertory thanks to the more intact figures of the Kissonerga ritual deposit.¹⁵

Of the nine ceramic figures from the Kissonerga deposit, three are seated on stools, three stand unaided, and three are hollow (and hence are perhaps more accurately to be classed as vessels). Those with articulated disk heads are elaborately painted and up to twenty centimeters in height, with cylindrical bodies and arms outspread. The plain-headed figures are hand-sized cylinders with undifferentiated legs, arms once more extended. The putative vessels are more varied: a bag-shaped kneeling female, a corpulent standing female with arms raised to her shoulders, and a male with conical eyes, protruding nose, and pouting lips punctured and outlined in red. Even this cache can only hint at the remarkable variety of contemporary figurative expressions, for there are also the fantastic creatures from the Souskiou cemeteries mentioned above.

With the exception of the last, all figures seem clearly related to aspects of sexuality, fertility, and parturition. This may not be so obvious from the picrolites, but their carefully drawn-up knees are identical with the posture of the Kissonerga birthing figures. The picrolite image is thus a schematized version of the Kissonerga figures, symbolizing successful birth. Their characteristic outstretched arms, however, are not exclusively associated with birth, for ithyphallic males also possess them (cat. 21).¹⁶ If we allow the picrolite images' general association with procreation, then their use may tell us something of their deeper significance, for example, as dolls or deities.

Picrolite pendants occur in graves and settlements (cat. 23). That they were worn in life and are not simply derived from disturbed graves inside settlement areas is evident from the extensive wear marks in their perforations. No data is available for their association with male or female interments, but the fact that the Yialia female, like certain terra cottas from Kissonerga, is wearing a pendant that bears the likeness of another female with identical features suggests that the pendants were worn as feminine apparel.




Figure 3. The "Lemba Lady" in situ against the back wall of Building 1 at Lemba-Lakkous, circa 3000 B.C.

Of the other stone figures, only the "Lemba Lady" and those from the Kissonerga ritual deposit have in situ find-spots. This class of object was not intended for burial with the dead. The "Lemba Lady" lay behind some pithoi over a groove that may have been a room partition (figs. 3, 4).¹⁷ It was seemingly in storage in a building that is otherwise distinguished by its isolated position in an

earlier burial ground and on a terrace edge. That location suggests the building's special status, since other buildings were clustered, often at the back of terraces. The Getty Museum figure may also have come from a special, nonmortuary context.

The remaining stone and ceramic anthropomorphs have been found only in habitation levels. Their concentration inside a building model at Kissonerga points to contemporary usage in an unconventional structure supplied with a focal platform opposite the door. This architectural arrangement and the associated triton shell are reminiscent of features of Bronze Age sanctuaries, but it is difficult to identify which, if any, of the figures might represent a cult statue. It should be noted that only the ceramic figures could stand unaided and therefore only they could fit on the building model platform. This indirect evidence for a sacred place is tantalizing but hardly conclusive. It may not be too speculative, in the light of the associated equipment and public ritual that involved fire, ocher-smearing, and deliberate breakage in an extramural setting, to suggest that these groups were more than mere toys and were probably more than charms or amulets.

This exuberant representational art of Cyprus in the fourth and third millennia B.C. is sui generis. It lacks the animal imagery that occurred so pervasively in the adjacent Asiatic repertories. To that extent, and in its development of a readily identified and highly schematized canonical type, its sudden appearance, and its dearth of male depictions, the art of Cyprus parallels roughly contemporary Early Cycladic I and II art and its forerunners. Correspondences even extend to composite, acrobatically arranged sculptures. Stylistically, however, the similarities to the Cycladic marbles and to their Anatolian counterparts remain superficial, and we have noted an autonomous evolution of Cypriot forms from Late Neolithic precursors.


LATE CHALCOLITHIC PERIOD

(circa 2800-2300 B.C.)

Consideration of the final period of Chalcolithic Cyprus is inevitably bound up with one of the most controversial aspects of Cypriot prehistory: the nature of the remarkable changes that took place in the transition to the Early Bronze Age. 19 After that transition we are confronted by radically new settlement patterns and architecture, new burial customs, pottery styles, metalwork, and spindle whorls: in other words, virtually a completely new material culture and clear evidence for an altered economy and a new religious expression. In order to understand how these changes came about, we need an accurate and detailed knowledge of pottery styles and other classes of material evidence leading up to and including this critical transition. Because there is no fixed chronological framework for the many relevant assemblages, such knowledge is precisely what has been lacking. Therefore, it is necessary to identify as far as possible the nature of Late Chalcolithic sites and their relationship to each other.

To what extent did the Erimi Culture persist into the Late Chalcolithic? Both Lemba and Kissonerga disclose the same picture: renewed occupation of the standard circular buildings that contain monochrome ceramics rather than the exuberant Close Line style painted pottery of the Middle Chalcolithic (cat. 24). There are some indications that figurative artwork declined and that picrolites were often coarsely reworked. To the intra-site pit burials were added chamber tombs. No cemeteries like those at Souskiou have been located. Terminal radiocarbon dates place the end of the Late Chalcolithic around 2500 B.C., but as these dates are principally derived from structural timbers, a somewhat later date is realistically called for. Thus, there is strong evidence for the continuity of the Erimi Culture and little for calamity and wholesale abandonments at the end of the Middle Chalcolithic.²⁰

There is also the possibility that earlier, broadly defined uniformity in Cyprus broke down into distinctive regional groupings. Such a group around the Bay of Morphou, it is claimed, already coexisted with Middle Chalcolithic Erimi.²¹ The monochrome pottery of this Morphou group, however, is morphologically and decoratively so close to that from Late Chalcolithic Kissonerga and Lemba that it is difficult to concede a major time differential. These mainly unexcavated sites may indicate increased density of population in what was to become a core area in subsequent developments.



By core area is meant a region in which a number of sites exhibit ceramic and other traits that, on typological grounds, seem to be the earliest manifestations of the Early Bronze Age. This phenomenon is represented by the Philia Group, named after the cemetery of Philia-Vasiliko that yielded such novelties as Red Polished pottery, weaponry, annular shell rings, and biconical whorls in chamber tombs. It is likely that this group persisted for some time into the Early Bronze Age, when it coexisted with other local adaptations such as the North Coast Culture.²²

There are several questions that pertain to this Philia Group, not least of which are its origins and the extent of its chronological overlap with the Erimi Culture. Discoveries at Kissonerga reveal the nature of many of the problems more clearly (fig. 5). We have already noted the occurrence of chamber tombs there in the context of a purely Erimi Culture. The Red Polished pottery and other Philia features just mentioned seem to occur in subsequent levels.




Figure 6. The earliest pithos burial in Cyprus, at Kissonerga-Mosphilia, circa 2500 B.C.

Unfortunately, those sparse levels were poorly preserved, hence the evidence is not yet sufficient for an early Philia settlement in Cyprus.²³ Nonetheless, two conclusions may be drawn here from the Kissonerga evidence. First, some features previously regarded as diagnostic of the Early Bronze Age, such as chamber-tombs and annular shell rings, already exist in Late Chalcolithic contexts. Second, Red Polished (Philia) pottery appears in the west after the last circular buildings and other long-lived Chalcolithic features.

This latter point is of considerable importance since it suggests a rapid collapse in the west of Cyprus. Unequivocal evidence from Lemba and from surveys confirms this crisis; the ultimate settlement at Lemba was destroyed by a fire in which its inhabitants were unable to retrieve such goods as rare copper items. Throughout the Paphos District, Late Chalcolithic settlements were abandoned and none, save Kissonerga, has yielded pottery of the succeeding period.

Unfashionable as it may be to refer to events as causative factors in prehistory, it seems as if the end of the western Chalcolithic was catastrophic and complete. It also seems likely that what we know as the Philia Group played some role in these events.

The origin of the Philia Group has been much debated, but even those who argue for an internal evolution recognize Anatolian influence in its pottery. Indeed, before the appearance of the latter in the west, the presence of pithos burials, stamp seals, and pottery with relief knobs and ribs represents evidence for links with Anatolia.²⁴ Recently discovered faience beads at Kissonerga, the earliest from the Mediterranean islands, corroborate the breakdown of Cypriot insularity before Philia.²⁵ Whatever its origins, therefore, there was a growing heterogeneity in Late Chalcolithic material culture.

Comparison of this new evidence from western Cyprus with that from the Aegean provides significant insights into the end of the Chalcolithic in Cyprus. Available chronological data allows us to synchronize this transition with the end of the Early Cycladic II period in the Aegean. According to several analysts, there was a complete disruption of Cycladic culture at that time, due in some part to Anatolian incursions. Factors include the abandonment of sites, the decline or disappearance of marble statuary, new Anatolian pottery forms, new metal types, and new burial practices, namely inhumations in pithoi (fig. 6).26 These changes are precisely the kind that occurred in Cyprus, a coincidence that can hardly have been fortuitous. With regard to the Aegean, Machteld J. Mellink draws attention to the involvement of Tarsus and suggests that Anatolian raiders destroyed and sometimes settled, while Christos Doumas refers to refugee-pirates;²⁷ R. L. N. Barber prefers a more massive incursion.²⁸ Details will have varied from place to place in what appear to have been tumultuous times. For example, wheelmade vessels, depa, and large red platters—all pottery types of the succeeding horizon elsewhere—do not occur in post-Chalcolithic Cyprus, where earlier Anatolian forms found favor. It is becoming increasingly clear that the explanations for this watershed in terms of either insular developments or the presence of refugees from Anatolia are all too limited. The collapse of the Erimi Culture and the beginnings of the Cypriot Bronze Age need to be viewed in the much broader context of the strife and upheavals that profoundly affected much of the East Mediterranean, including the coastal regions of Anatolia, the Aegean, and the Greek mainland.








The idol is complete but not intact; the left arm was broken and mended in antiquity. The form is an enlarged version of more familiar small picrolite figurines.

Squatting with outspread arms, this

figure has broad, flat thighs, deeply cut grooves separating the breasts and lower legs, and incised lines indicating the toes. The arms are decorated with rope patterns that may indicate jewelry. The head, set on a tall neck, is tilted slightly back and shows well-developed and fully carved facial features: round staring eyes, prominent brows and hair, and a small incised mouth.




