AMENDMENT TO RECODIFIED RESTRICTIVE
COVENANTS AND RESERVATIONS FOR ANTIQUER'S AERODROME, INC.

WHEREAS, ANTIQUER'S AERODROME, INC., a Florida corporation, recorded Recodified Restrictive Covenants and Reservations for Antiquer's Aerodrome, Inc., on October 19, 1987 in Official Records Book 5453 at page 397 of the Public Records of Palm Beach County, Florida, regarding the following described real property situate in Palm Beach County, Florida, to wit:

The NW quarter of the NW quarter and the NE quarter of the NW quarter of Section 15, Township 46 South, Range 42 East; and the south half of the NW quarter of the NE quarter and the south half of the NE quarter in Section 16, Township 46 South, Range 42 East, said land lying and being situate in Palm Beach County, Florida,

and, whereas, at the duly called annual membership meeting which was held on November 15, 1992, at which time a quorum was present, the following Amendment to the Recodified Restrictive Covenants and Reservations for Antiquer's Aerodrome, Inc., was adopted by the requisite vote:

"RESOLVED, that paragraph 26(a) of the Recodified Restrictive Covenants and Reservations for Antiquer's Aerodrome, Inc. which were recorded on October 19, 1987 in Official Records Book 5453 at page 397 of the Public Records of Palm Beach County, Florida be and it hereby amended to read as follows: No residence or hanger space may be leased except from one shareholder to another."

NOW THEREFORE, be it hereby known that paragraph 26(a) of the Recodified Restrictive Covenants and Reservations for Antiquer's Aerodrome, Inc., which were recorded on October 19, 1987, in Official Records Book 5453 at page 397 of the Public Records of Palm Beach County, Florida be and is hereby amended to read as follows:

26(a) no residence or hanger space
may be leased except from one share-
holder to another.
