# **Bethpage Chapter**

# May 23, 2018

The weeklong rain stopped, the sun came out and so did the hungry retirees to the Crest Hollow CC. After a great lunch, the meeting began with Sergeant-at-Arms Nick Bazzicalupo leading the Pledge of Allegiance. A moment of silence was then observed for our departed friends and for the well-being of the men and women in the service of our country who fight and die for our freedom. Also remembered were the victims of yet another school shooting in Texas.

President Bob Ripp introduced guest speaker Roger Kilfoyle, Vice President of the organization "Honor Flight of Long Island." They are a 501c3 charitable operation formed in 2005, one year after President Bush dedicated the WWII Memorial to honor the "Greatest Generation." Roger detailed the program which, reportedly, has flown over 159,000 veterans to the Washington, D.C. memorials since 2005. Honor Flight has grown to 133 chapters serving veterans in 41 states and the District of Columbia. Each visit could include the WWII Memorial, the Navy Museum, the Women in Military Service for America Memorial, the Marine Museum, and Arlington National Cemetery.

When Honor Flight started, only WWII vets were invited; however, the trip is now offered to WWII vets, Korean War vets, and terminally ill vets of other periods. Roger said his chapter departs from Islip airport for this one-day trip. The veterans on the honor flights are escorted by volunteer guardians, who help them on the flight and around the D.C. tour. Upon returning from the trip, the vets are often greeted by a crowd of up to 1000 people at the airport. Presently, the LI chapter has flights in the Spring and the Fall.

Roger was joined by Roy Tringali, Grumman Retiree and past Honor Flight participant. Roy spoke fondly about his trip. Finally, Roy introduced Stephanie Folwell, who has served as a guardian on several flights. It should be noted that these guardians not only generously give of their time but also pay their own way on the flights. The three were greeted with



a round of applause. Bob Ripp presented Roger with a \$400 check, which is the cost for one veteran for an upcoming flight.

Retiree Club Treasurer's Report: Frank Rizzo gave the Club's financial report year-to-date. He also noted that he has completed and submitted the Club's annual Income Tax return, which was due on May 15.

Frank noted that, due to the recent tax changes, he expects most retirees will no longer have to Itemize deductions but will be better off using the new, improved Standard Deduction. He also informed the audience of a tax rule that has been established for a while but now, if using the Standard Deduction, would be even more important to the taxpayer: When using the Standard Deduction, the person loses the deductibility of charitable contributions unless those contributions are made [directly] from IRA funds. When IRA monies are contributed, they have a two-fold benefit: (1) the contributed amount counts as part of your RMD, but (2) the contributed amount is not included in your taxable income.

# [Editor's Notes:

(1) This is officially known as a "Qualified Charitable Distribution" (QCD). Information about QCD can be found easily on the Internet.

- (2) QCDs can also help to prevent the increase in Medicare premiums and the increase in tax on Social Security that can result from higher taxable income.
- (3) Disclaimer: All of the above is for information only; it is not to be taken as tax advice. You are urged to consult a competent tax advisor to determine the applicability of QCDs to your particular situation.]



#### We Remember . . .

Bill Schwendler, Jr., who, in 1966, began a 25+ year career with Grumman Corporation, a diversified aerospace company his father co-founded before World War II. In 1969, he was appointed director of the newly formed ecosystems department. In 1974, Bill was elected President of Grumman Ecosystems. Subsequently, he held the positions of Assistant to the Chairman of the Board of Grumman Corporation, Director of Paumanock Development Corporation, and Secretary of the Intercompany Advisory Committee. As Grumman's commercial product business expanded, Bill moved in 1978 to Georgia to become manager of Grumman's new Southeastern Regional Office. Among other Community service activities after his retirement, Bill was instrumental in developing the carrier deck exhibit at the Cradle of Aviation Museum on Long Island. That exhibit includes three restored Grumman Aircraft.

John Caruso, listed in last month's *In Memoriam*, was one of the members who was very influential in establishing the Grumman Memorial Park in Calverton and the placement of the F-14 on display at the Park. John was also Director of the Memorial Park.
