
SERVICES OF PROTECTION

- Ushered nearly 600 families who'd known only war and refugee camps through the resettlement process, helping them embrace their new community.

Our mission is as relevant today as it was at our beginning. Heartland is continually evolving and adapting to ensure human rights protections for all.



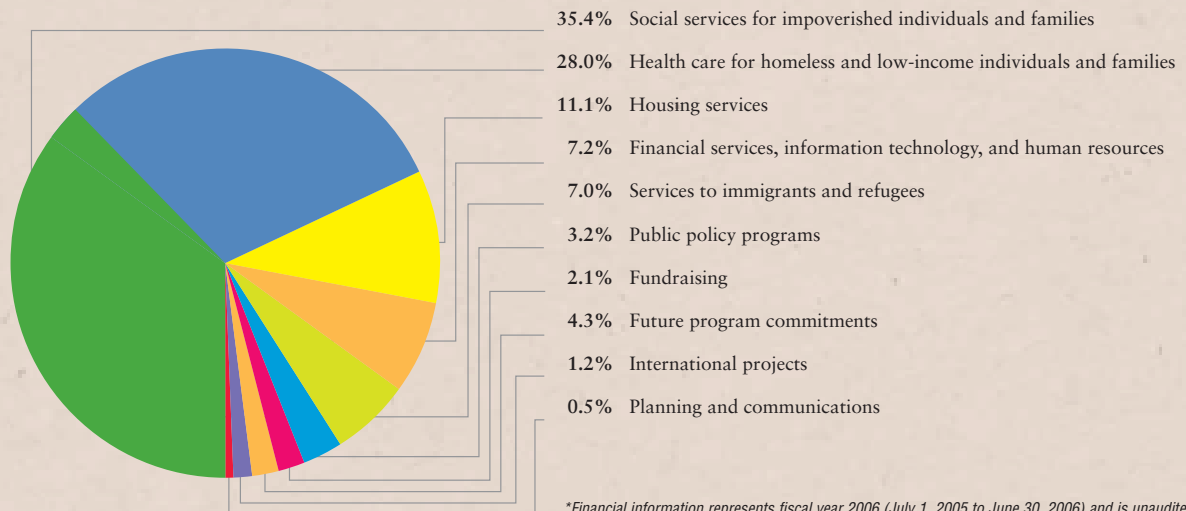


2006 FINANCIAL REPORT*
