WHAT IS A LONGLEAF PINE AND WIREGRASS SAVANNA?

The stewardship of a 2100 acre urban forest is a privilege and a responsibility that the Hitchcock Woods Foundation takes very seriously. The Foundation's care of the Hitchcock Woods is guided by a restoration and management plan developed in the mid 1990s by a consulting plant ecologist and two biology professors.


This plan outlines recommendations and prescriptions that will help over time to restore the Woods to the more natural conditions of a native longleaf pine and wiregrass savanna, which is the native forest ecosystem of the southeastern United States.

This primitive ecosystem was maintained by naturally occurring fires caused by lightning strikes associated with light rainfall. These fires would ignite every two or three years, or whenever the fuel load would be adequate to spread fire across the forest floor. They most commonly occurred in warmer weather when thunderstorms were more prevalent.

Because of the frequency of the fires, native fire-loving grasses regenerated and dominated the forest floor, creating the savanna. The broader spacing of trees in the forest allowed more sunlight to reach the forest floor, which helped the grasses to thrive.

The Hitchcock Woods Foundation has a goal for broader tree spacing that would allow more sunlight and that would minimize the competition among the trees for available nutrients. For areas of the Woods that are identified in the management plan as densely vegetated, the Foundation will schedule operations to mechanically thin the trees. This ultimately results in a healthier forest.

Several areas of Hitchcock Woods are closer than others to the Foundation's forest management goals. For example, on the north side of the Woods, the Pigeon Trap Loop area is coming along very well. On the south side, Willie Barton's Line is a great example of the target ecosystem. To the west, the area stretching from Mrs. Allen's Ride toward High Point Line and Riviere Ride is another great example of the longleaf pine and wiregrass savanna. Please check out these areas the next time you are visiting the Woods. *

TAKE A DRIVE WITH ME

Second in a series on specific topics in our Visitor Guidelines

There is a rich history and tradition of carriage driving in Hitchcock Woods. There are even documented accounts of participants in "Aiken Buggies" accompanying the Aiken Drag. Multiple trails in the Woods are suitable for driving, but drivers should be sensitive to sharing the Woods with those on foot and on horseback. Please exercise caution when you encounter other carriages in the Woods. As you are enjoying the Woods, please be reminded of these guidelines:

- Follow instructions on all "yield" signage.
- Stay on wide paths for safety and for the protection of the environment.
- Carriage drivers will always be aware of and sensitive to current trail conditions.
- Carriages are advised to refrain from entering the Woods during special events and posted hunt times.

Driving clubs must contact the Foundation office (803.642.0528) prior to a scheduled drive. In addition to the above guidelines, driving clubs must:

- Provide all special signage required to make other users aware of their presence in Woods. This signage must be placed two weeks prior to an event and must be removed immediately after the event. (If Hitchcock Woods Foundation staff members assist, the Foundation will be compensated.)
- Keep the designated route to the wide paths. All routes must be cleared with the Woods Superintendent.
- Provide proof of specific liability insurance listing the Hitchcock Woods Foundation as additional insured for the time of the event. Proof must be provided prior to the event. ☺


THE 2009 AIKEN HORSE SHOW FINISHES BIG
