## **NEWS AND NOTES**

#### SPECIFIC EPITHETS

The practice of naming a species by using a person's name to form the specific epithet is open to criticism on the following grounds:

- 1. It prevents giving the species a descriptive epithet. The name Lilium canadense tells us where the plant is found. This gives us a clue to many things, including the manner of cultivation which the plant probably requires. If it had been named Lilium jonesii, this advantage would have been lost. Melaleuca leucadendron means the Melaleuca with white wood. This epithet is a translation of the Malay name Kayu putih, and therefore helps in identification, whereas M. brownii would not.
- 2. It often violates the genius of the classical languages. If the specific epithet of a plant was colquhounii or zwaanhoekiana (fictitious), this would be distressing to persons with a feeling for languages. We have already to put up with too many epithets made from personal names unsuitable for the purpose.
- It may arise from an ignorance of classical languages easily corrected by making enquiries.
- 4. It is often done on the pretext of wishing to honour a person. But does it? Is it an honour to Mr. X, if his name serves to form the specific epithet of a plant he has never seen or heard of? Moreover, it presupposes a vanity most people would be ashamed to possess.

I should be glad if the practice discussed above could be discontinued.
