2023 LEGISLATIVE SESSION TIMELINE

- ▶ The legislative session began on November 22 with **Organization Day**
- ▶ The Senate and House will **reconvene** January 9
- ▶ The **second half** of session begins March 1
- ▶ Session is scheduled to adjourn **Sine Die** on April 27 or at the latest on April 29

NEXT GENERATION HOOSIER EDUCATORS SCHOLARSHIP

- ▶ The Next Generation Hoosier Educator Scholarship is capped at 200 recipients per year
- ▶ Last year, more than \$1M in funding went unspent due multiple factors.
- ▶ The Commission will be seeking to remove the 200-recipient cap to increase access to the award

HIGHER EDUCATION PURPLE STAR DESIGNATION

- ▶ It can be difficult for veterans to know what supports are available on campus and how they are accessed
- ▶ The Commission will work with IDVA, institutions, and veteran groups to identify the supports and services a campus must offer to receive the designation
- ▶ This designation complements the IDOE Purple Star School program at the K-12 level and mirrors an Ohio postsecondary initiative

FAFSA REQUIREMENT

FAFSA REQUIREMENT

- ▶ The Commission supports a FAFSA Requirement for high school graduation with a broad opt-out provision
- ▶ A FAFSA requirement bill has been filed for four years with the bill making it to conference committee multiple times
- ▶ Alabama, Louisiana, Texas, New Hampshire, Colorado, Maryland, Illinois and California all require seniors to file

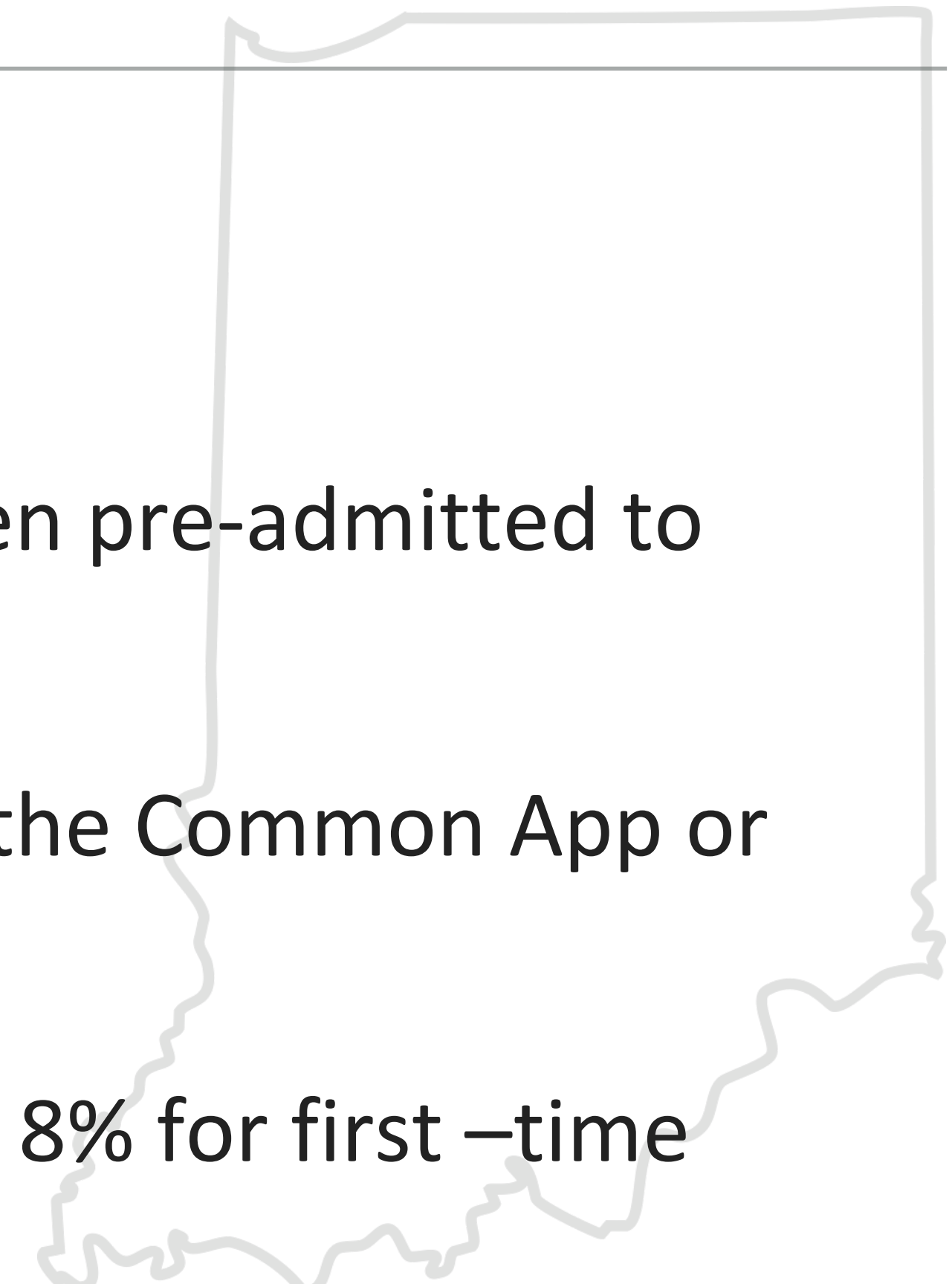

PRE-ADMISSION INITIATIVE

- ▶ The Commission is working to launch a pre/direct admission initiative for the high school class of 2024
- ▶ Starting fall 2023, high school seniors will be notified of the colleges and universities they qualify for admittance
- ▶ The Commission, in partnership with the institutions and the Indiana Department of Education, will use high school GPAs and SAT scores to inform students of their options

PRE-ADMISSION INITIATIVE

- ▶ Students will receive a letter listing the institutions they have been pre-admitted to attend
- ▶ The plan is to direct students to a landing page which will link to the Common App or each Institution's admission processes
- ▶ Idaho launched a similar initiative in 2016 and saw an increase of 8% for first-time undergraduate enrollment during the 17-18 academic year

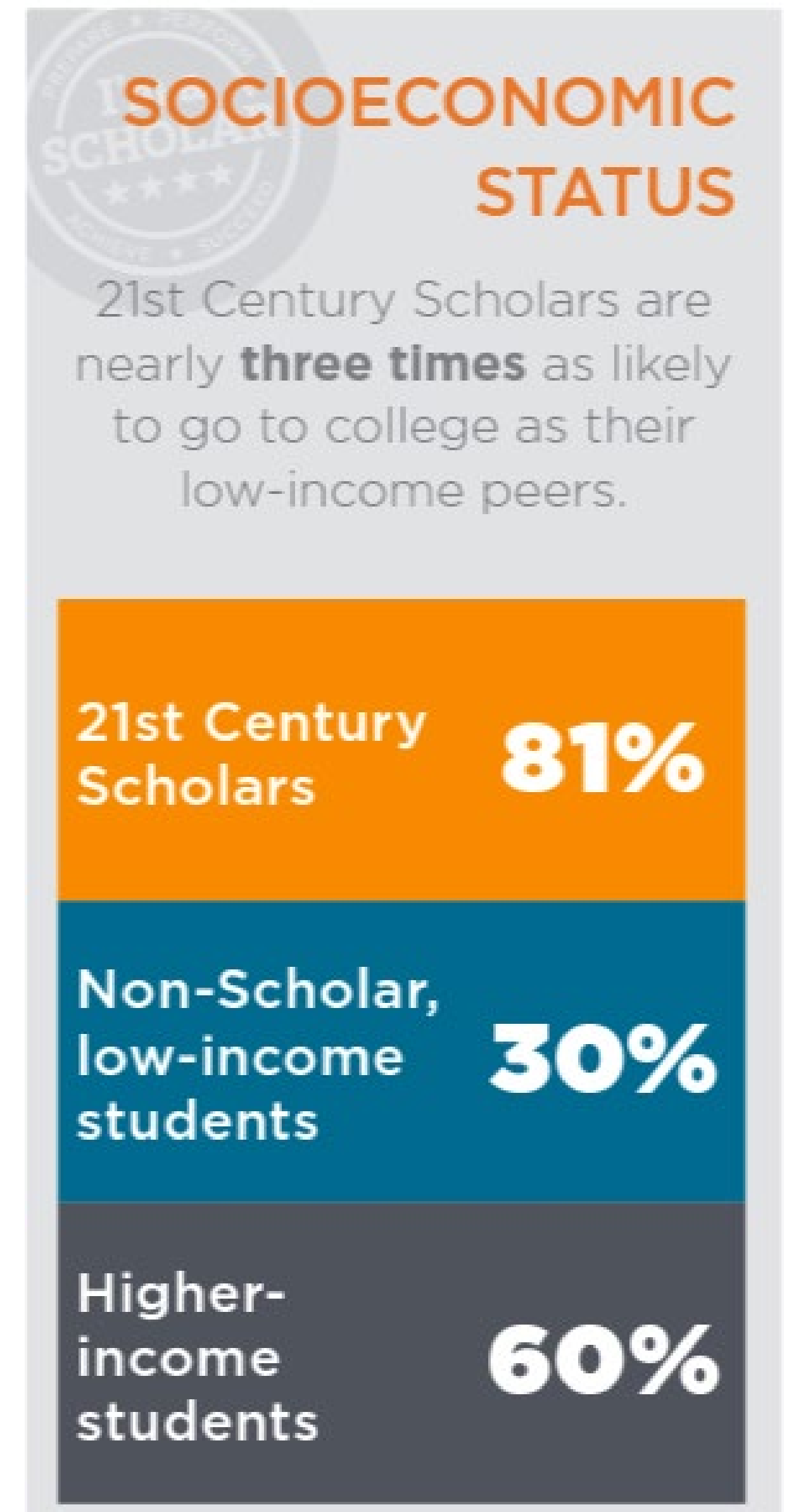
21ST CENTURY SCHOLARS ENROLLMENT SIMPLIFICATION

21ST CENTURY SCHOLARS

- ▶ Over 50,000 Hoosiers have earned a college degree with the 21st Century Scholarship since 1990
- ▶ 81% of 21st Century Scholars went to college in 2020; nearly 3X the college-going rate of their low-income peers
- ▶ Fewer than half of eligible students enroll



SIMPLIFIED ENROLLMENT

- ▶ The Commission recommends streamlining the enrollment process to ensure more Hoosier students access the program
- ▶ Using IDOE and IDOR data, the Commission will mark students as eligible similar to how foster care students become eligible
- ▶ Students will still be required to agree to the 21st Century Scholars pledge



SIMPLIFIED ENROLLMENT

- ▶ The Commission anticipates the cost of the program will not increase due to simplified enrollment until FY28 with the full increase not hitting until FY31
- ▶ We anticipate not needing additional funding to cover automatic enrollment until FY30 due to carry forward funding
- ▶ Last year, the program underspent by \$20M per year with roughly \$33M currently in reserves

FRANK O'BANNON GRANT - HISTORICAL AMOUNTS

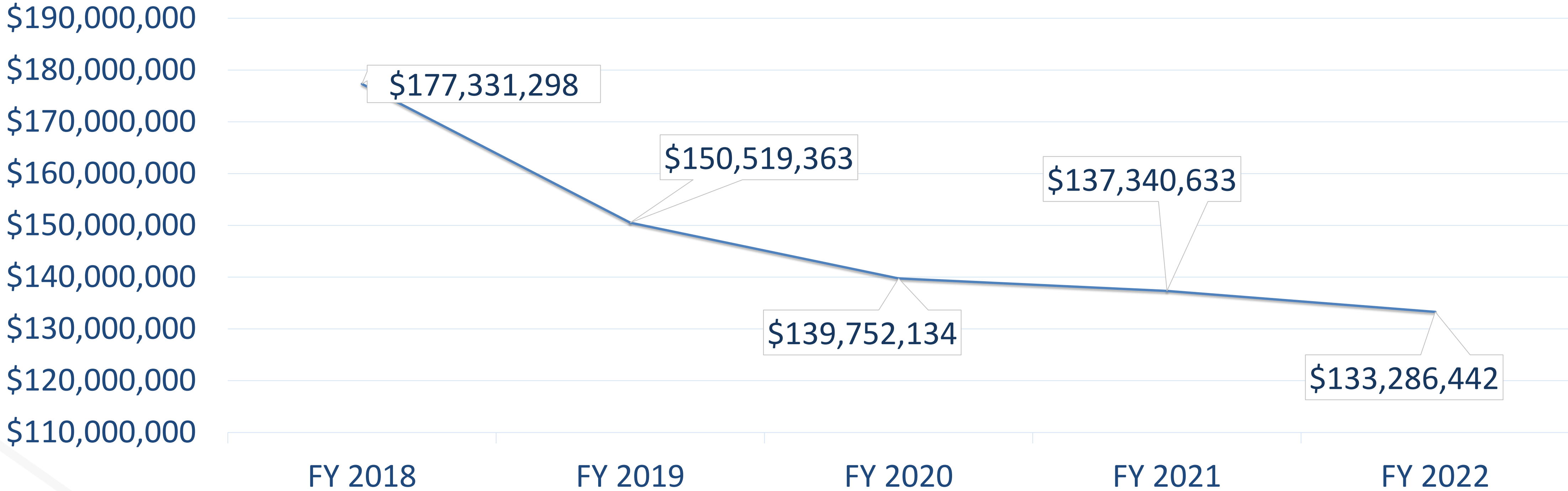
- ▶ The Frank O'Bannon Grant award amounts have yet to recover from cuts made during the Great Recession
- ▶ During the 2008-09 academic year, the maximum base Frank O'Bannon Grant was \$9,160 at a private institution and \$5,080 at a public institution
- ▶ Awards were reduced to \$6,320 at a private institution and \$3,505 at a public institution during the 2009-10 academic year



FRANK O'BANNON GRANT - HISTORICAL AMOUNTS

- ▶ The current maximum base awards are \$9,200 at a private institution and \$4,600 at a public institution
- ▶ Since 2009, awards have increased .4% in nominal dollars at private institutions and decreased by 9.4% at public institutions
- ▶ The maximum base award at a private institution would need to increase to \$12,400 to return buying power to 2008-2009 level

FRANK O'BANNON GRANT - EXPENDITURES



FRANK O'BANNON GRANT- INCREASE

- ▶ The State Budget Committee supported an increase of 35% to the maximum Frank O'Bannon Grant base-award amounts
- ▶ This increase brings the maximum award back to pre-recession levels when adjusted for inflation
- ▶ The maximum award at a private institution is now \$12,400 and \$6,200 at a public institution
