Welcome to the 2018 version of our Outcomes and Annual Report, featuring 2017 - The Year in Review! We're pleased to present this information about our activities in the past year in support of our mission: to provide hope, help and healing to children, adults and those who love them.

2017 was our 135th Anniversary year, and I'm proud to say our achievements through the year matched the high standards set during KidsPeace's long history. We served more than 11,000 clients across our various programs – including our in-patient children's psychiatric hospital, three residential treatment centers, community-based and outpatient programs in Pennsylvania, Maine and Georgia, and foster care services from Maine to North Carolina to Indiana. Advancements included a renewed focus on caring for foster kids affected by the opioid epidemic, a leadingedge trauma-informed program to treat victims of sex trafficking, the creation of a new library at the Graham Lake Campus in Maine, the launch of our redesigned TeenCentral web-based service, and the successful conclusion to our \$2.2 million capital campaign for expansion of our Georgia residential treatment facility, among many others.

It's important to note that these advancements – and more importantly the success of the people we serve in overcoming the challenges that they face – are built on the dedication and passion of KidsPeace's 1,700 associates around the country. Each fall we honor exceptional associates at our KidsPeace Associate Recognition Awards; throughout this report we shine

the spotlight on some of the winners and finalists from the 2017 awards.

One other note about this year's report: we're presenting it in a way that we hope will make it easier to access the information that interests you most. The report now comes in three sections: an overview of the various services that make up the KidsPeace Continuum of Care, including results of key quality indicators for each area of service; a data repository detailing clients' outcomes and level of satisfaction with the care we provide; and a section on financial and philanthropic support for our activities, which allows us to share insights from those who see such value in our work that they give their time, talents and resources to support our organization.

On behalf of KidsPeace, I thank all those who have helped us in the past year — our associates, board volunteers, funders and referral agencies, and donors. Our success is really your success too.

And to those we serve as clients, I hope you will view this report as the renewal of our promise to serve you and meet your needs as best we can in the months and years ahead.






In 2017, KidsPeace provided treatment and help to 11,165 clients across its hospital and residential treatment services, outpatient and community programs, and foster care operations - including 7,603 new admissions.

2017 Admissions



KidsPeace provides community-based outpatient services to children, families and communities in Pennsylvania, Georgia and Maine, as well as through select foster care offices. Services include acute partial hospitalization, programs for children with autism, family and individual counseling, diagnostic services, medication management, urgent care and walk-in screenings, among others.

More than 6,500 individuals received help from KidsPeace's community-based services in 2017.

All four Pennsylvania outpatient locations offer free walk-in assessments during posted hours. During a walk-in the individual and family meet with a master's level therapist to discuss current issues and craft a safety plan. This service is a diversion from emergency rooms, links individuals to services, and helps decrease a potential crisis. Individuals and families surveyed have reported the following:


Through its Orchard Behavioral Health unit, KidsPeace offers an array of mental health services designed specifically for adults - following the holistic approach to treatment that we take in addressing the needs of children and adolescents with mental and behavioral health issues. OBH allows us to care for people ages 3 to 65 – including parents, caregivers and other family members - under one roof.

KidsPeace Children's Hospital is one of the largest free-standing in-patient children's psychiatric hospitals in the United States. The 120-bed facility provides intensive psychiatric services to clients ages 5-21 in serious crisis.






In 2017, KidsPeace Foster Care offices served 1,462 children across seven states — Maine, New York, Pennsylvania, Maryland, Virginia, North Carolina and Indiana. Services include therapeutic, traditional and respite foster care. 



KidsPeace's Bowdon, GA Campus features a 40-bed Room, Board and Watchful Oversight (RBWO) program (males and females) and a separate 20-bed facility for males with sexual issues. An on-site school, recreational facilities, and a wellness and behavioral-health center serve the needs of clients. The campus also offers outpatient walk-in counseling and mental health treatment programs to the community.

148 clients received care at the Bowdon facility in 2017. Also in 2017, KidsPeace completed a \$2.2 million capital campaign for a 20-bed expansion at the Bowdon Campus, scheduled to open in 2018.





KidsPeace New England's residential program, at the Graham Lake Campus in Ellsworth, Maine, is a 44-bed facility providing therapeutic residential treatment, with an emphasis on serving clients with Autism Spectrum Disorders. The program features high quality educational and recreational therapies for clients ranging in age from 3 to 20 years old, and also offers day treatment services.






Students in KidsPeace residential treatment programs attend on-campus classes with emphasis on the curriculum for their current grade level and home school district requirements. Communications with home school districts enable us to maintain coursework and meet Individualized Education Plan (IEP) goals. Many of the students that come to KidsPeace are three to four years behind their peer group academically. Upon admission, each student is tested in both Math and Reading when entering the program and retested after six months. In 2017, 82% experienced gains in their academic performance in math and 91% showed academic improvement in their reading scores during their residential placement with KidsPeace. Our students' progress and success is due largely to smaller class sizes and curricula adapted to their specific needs.

In foster care, 99% of 434 school eligible children in care during the 2016/2017 school year successfully completed the school year while 96.5% advanced a grade or level.

In Maine, KidsPeace operates fully licensed Special Purpose Private Schools at its Graham Lake, East Millinocket and Greenbush sites for children kindergarten through grade 12. Also at those sites, KidsPeace's Milestones preschool program provides individualized education and therapies to children age 3-5, based on developmental disability. 95% of Maine residential students either exceeded or met standards of the Maine Learning Results and Common Core.



At KidsPeace, we are committed to staying on top of and contributing to the research base around what works for our clients.

Prevention of Maltreatment Road Map: How Did We Get Here, and Where Are We Going?





At KidsPeace, we understand the importance of demonstrating the value of our services to everyone concerned. To do this, we use performance measurement tools that provide insights into overall program effectiveness, and allow us to answer the question: How much better, on average, are our clients after having received treatment? We also use these tools during treatment to gauge a client's progress and make necessary adjustments to their treatment plans.

Of course, different measures are needed for the wide variety of clients we serve:

- Many of our programs use the Brief Psychiatric Rating Scale for Children (BPRS-C) to measure individuals' treatment progress as well as our programs' overall effectiveness. The BPRS-C assesses behavioral symptom severity in several areas behavior problems, depression, psychomotor excitation, withdrawal, and anxiety. It also serves as a diagnostic tool in describing symptoms that occur in many child and adolescent psychiatric disorders. Trained KidsPeace clinicians evaluate individual children and youth at the time of their admission, at set points throughout their care, and just prior to their discharge.
- We use the adult version of this scale, the BPRS, to measure the severity of symptoms such as anxiety, depression, suicidality, hostility, distractibility, and others among clients in our adult services programs.
- In addition to the BPRS-C and the BPRS, our Pennsylvania community programs also track data related to two of our most unique and effective services—"walk-ins" and telepsychiatry.
- In our foster care programs, we ask our clients, their families, and our staff to complete a survey called the Trauma-Informed Agency Assessment (TIAA). The TIAA was developed to measure the extent to which agencies employ trauma-informed approaches in meeting the needs of our clients and their families. With the insights we gain through the TIAA, we are able to

develop actionable plans which help us to improve our responsiveness to trauma in our clients - trauma which can impact their physical, emotional, behavioral, and cognitive development.

- New in 2017 was our use of the Child Behavior Checklist (CBCL) in our programs for individuals with autism spectrum disorders in Maine. As scored by our clinicians in these programs, this standardized assessment measures both internalizing and externalizing behaviors in children. Internalizing behaviors include things like crying, guilt, loneliness, and worries; these behaviors can signal problems such as anxiety and depression. In contrast, externalizing behaviors include aggression, screaming, and arguing (among others); high scores on these indicate the possibility of oppositional-defiant disorder or conduct disorder.
- Along with our treatment programs, our educational programs also track outcomes data based on assessments that are given by our teachers. The Title 1 data that we collect meets a federal requirement which ensures that low income children are receiving high quality educations. This data shows that children in our Pennsylvania schools are progressing in both reading and math.

Another indicator of academic success that we monitor is the percentage of individuals who pass into the next grade. In our Maine education program, we measure the success of our students against the statewide standards.






2017 Community Programs Family/Agency Satisfaction Survey


2017 PA Community Programs Brief Psychiatric Rating Scale - Children

2017 PA Community Programs Brief Psychiatric Rating Scale - Adult






2017 Community Programs Walk-ins



2017 Social Skills Improvement System




2017 Telepsychiatry Metrics






2017 Foster Care Family/Agency Satisfaction Survey



2017 PA Residential Brief Psychiatric Rating Scale - Children (BPRS-C)


Decrease in severity of symptoms




2017 GA Residential Brief Psychiatric Rating Scale - Children (BPRS-C)



2017 GA Residential Client Satisfaction Survey




2017 GA Residential Family/Agency Satisfaction Survey





2017 ME Residential Client Satisfaction Survey





2017 ME Internal Behaviors - CBCL



2017 ME External Behaviors - CBCL



Finances, Governance

Over its long history, KidsPeace has earned a reputation for providing a level of care that meets high standards of quality and effectiveness. To do this requires significant financial resources. The information in this section of the Outcomes report shows that in 2017 more than four out of every five dollars that KidsPeace spent went toward program expenses — to providing care and treatment to the clients in our care. Total salaries and related benefits for our highly trained associates who provide direct and indirect care and support for our clients accounted for 72 percent of all expenses in 2017.

Most of our funding comes from fees paid by government agencies and private insurers; at the same time, we have a base of dedicated donors who provide the balance of our funding. We believe that "hope, help and healing are so much more than just treatment," and without the generosity of our donors we could not provide the level of exceptional care our clients need and deserve. In this section we are proud to list their names and share their views on why they support KidsPeace.

In this section we also are pleased to highlight the KidsPeace Board of Directors, the various Boards of Associates across our regions of service, and the creation in 2017 of the KidsPeace Foundation. Our ability to offer outstanding service to those in need is enhanced by the strategic leadership of our Board of Directors, as well as the commitment of our Boards of Associates and Foundation Board to cultivate support for our programs.


Philanthropy



Over its 136-year history, KidsPeace has built a reputation for providing a level of care noted for its exceptional quality and effectiveness. For a nonprofit like KidsPeace, providing such care requires substantial financial resources. The bulk of our funding comes from fees paid by governmental agencies and private insurers; we are fortunate also to have a base of generous donors - individuals, foundations and granting organizations - who provide additional funding for our variety of services.

More than four out of every five dollars spent by KidsPeace in 2017 went toward program expenses to provide care and treatment to our clients, with the remainder funding administration, marketing and advancement activities. Total salaries and related benefits for associates accounted for 72 percent of all expenses in 2017.
