### Kansas Statewide Healthcare Coalition Steering Committee

The steering committee is charged with working on healthcare coalition projects and facilitating statewide information sharing and networking. In addition, the steering committee will give guidance and suggestions to KDHE, the Kansas Association of Local Health Departments (KALHD), and the Kansas Hospital Education and Research Foundation (KHERF) and will function as an advisory board to share the local and regional perspective on HCC-related gaps, strengths, best practices, lessons learned, etc. The Committee is an advising body with a range of health and medical representation across the state. The Committee is comprised of 14 core members, three ex officio members, and six at-large members.

Coalition representatives are invited to participate based on the selection by their respective healthcare coalition. Core members include, but are not exclusive to, at least

two individuals (one public health and one hospital) representing the seven HCC regions across the state; ex-officio members, and vital community at-large members.



# Jason Tiller Vice-Chair of the KS Steering Committee

Jason sits at the helm of several organizations within North Central Kansas, but his primary position is that of Director of the Saline County Health Department. The Saline County Health Department is a well-organized group of public health experts taking care of the most populous part of the North Central Kansas. Jason accepted his current position in November 2015.

He holds a Bachelor's in Public Health with an emphasis on public health policies and public health management as well as a Master's in Health Education from Kaplan University, Nebraska. Jason also spent 20 years in the Army as a combat medic and retired in 2014 as a sergeant first class, medical platoon sergeant. For Jason, the task is not only to be prepared for healthcare emergencies, such as the one we are currently engaged, but also to take a proactive approach with regard to those non-emergency health crises that the health department responds to such as teenage pregnancy, teenage obesity, sexually transmitted diseases, violence. His desire since the beginning of his tenure has been to help the Saline County community reduce the number of incidents of disease instead of just treating the cases.

Jason is married and has three grown daughters, one grandson and another grandbaby on the way. When not involved in combating COVID 19, working at the health department, chairing the State Steering Committee, Saline County ESF#8 Committee or Chairing the NCK HCC, Jason can often be found working with his local church and on rare occasions, playing his drum.


