**EXPLANATORY NOTE**

*(Nid yw'r nodyn hwn yn rhan o'r Rheoliadau)*

*(This note is not part of the Regulations)*

1. Mae'r Rheoliadau hyn yn diwygio ymhellach Rheoliadau Labelu Bwyd 1996 ("y prif Rheoliadau") i'r graddau y maent yn gymwys o ran Cymru. Mae'r prif Rheoliadau yn rhychwantu Prydain Fawr gyfan.

1. These Regulations further amend the Food Labelling Regulations 1996 ("the principal Regulations") in so far as they apply in relation to Wales. The principal Regulations extend to the whole of Great Britain.

2. Mae'r Rheoliadau hyn yn rhoi ar waith yng Nghymru Gyfarwyddeb y Comisiwn Rhif 2006/142/EC (OJ Rhif L368, 23.12.2006, tt.110-111) sy'n diwygio Atodiad IIIa i Gyfarwyddeb 2000/13/EC Senedd Ewrop a'r Cyngor sy'n rhestru'r cynhwysion y mae'n rhaid iddynt ymddangos o dan bob amgylchiad ar labelu bwydydd. Mae dau gynhwysyn newydd wedi'u hychwanegu at y rhestr honno.

2. These Regulations implement in Wales Commission Directive No. 2006/142/EC (OJ No. L368, 23.12.2006, pp.110-111) amending Annex IIIa of Directive 2000/13/EC of the European Parliament and of the Council listing the ingredients which must under all circumstances appear on the labelling of foodstuffs. Two new ingredients are added to that list.

3. Mae asesiad effaith reoleiddiol llawn o'r effaith y bydd yr offeryn hwn yn ei chael ar gostau busnes wedi'i baratoi a gellir cael copiâu gan yr Asiantaeth Safonau Bwyd, Llawr 11, Southgate House, Wood Street, Caerdydd, CF10 1EW.

3. A full regulatory impact assessment of the effect that these Regulations will have on the costs of business has been prepared and copies may be obtained from the Food Standards Agency, 11th Floor, Southgate House, Cardiff CF10 1EW.

Mae Gweinidogion Cymru yn gwneud y Rheoliadau canlynol drwy arfer y pwerau a roddwyd gan adrannau 16(1)(a), (e) ac (f), 17(2), 26(1)(a) a (3) a 48(1) o Ddeddf Diogelwch Bwyd 1990(1).

The Welsh Ministers make the following Regulations in exercise of the powers conferred by sections 16(1)(a), (e) and (f), 17(2), 26(1)(a) and (3), and 48(1) of the Food Safety Act 1990(1).

Yn unol ag adran 48(4A) o'r Ddeddf honno, maent wedi rhoi sylw i gyngor perthnasol a roddwyd iddynt gan yr Asiantaeth Safonau Bwyd.

In accordance with section 48(4A) of that Act, they have had regard to relevant advice given by the Food Standards Agency.

Fel sy'n ofynnol gan Erthygl 9 o Reoliad (EC) Rhif 178/2002 Senedd Ewrop a'r Cyngor, sy'n pennu egwyddorion cyffredinol a gofynion cyfraith bwyd, yn sefydlu Awdurdod Diogelwch Bwyd Ewrop ac yn gosod gweithdrefnau o ran materion diogelwch bwyd(2), cafwyd ymgynghoriad cyhoeddus agored a thryloyw tra bo'r Rheoliadau hyn yn cael eu llunio a'u gwerthuso.

As required by Article 9 of Regulation (EC) No. 178/2002 of the European Parliament and of the Council laying down the general principles and requirements of food law, establishing the European Food Safety Authority and laying down procedures in matters of food safety(2), there has been open and transparent public consultation during the preparation and evaluation of these Regulations.

1. Enw'r Rheoliadau hyn yw Rheoliadau Labelu Bwyd (Datgan Alergenau) (Cymru) 2007, maent yn gymwys o ran Cymru ac yn dod i rym ar 23 Rhagfyr 2007.

## Diwygio Rheoliadau Labelu Bwyd 1996

2.—(1) Mae Rheoliadau Labelu Bwyd 1996(1) wedi'u diwygio (i'r graddau y maent yn gymwys o ran Cymru) yn unol â pharagraffau (2) a (3).

(2) Yn rheoliad 50 (darpariaeth drosiannol), ar ôl paragraff (13) mewnosoder y canlynol —

"(14) In any proceedings for an offence under regulation 44(1)(a), it is to be a defence to prove that —

- (a) the food concerned was sold before 23 December 2008 or marked or labelled before that date; and
- (b) the matters constituting the alleged offence would not have constituted an offence under these Regulations if the amendments made by regulation 2(3) of the Food Labelling (Declaration of Allergens) (Wales) Regulations 2007(2) had not been in operation when the food was sold."

(3) Yn Atodlen AA1 (cynhwysion alergenig) —

- (a) ar ôl paragraff (2) mewnosoder **"2(a)**. Molluscs and products thereof";
- (b) ar ôl paragraff (6) mewnosoder **"6(a)**. Lupin and products thereof".

## Title, application and commencement

1. These Regulations are called the Food Labelling (Declaration of Allergens) (Wales) Regulations 2007, they apply in relation to Wales and come into force on 23 December 2007.

## Amendment of the Food Labelling Regulations 1996

2.—(1) The Food Labelling Regulations 1996(1) are amended (in so far as they apply in relation to Wales) in accordance with paragraphs (2) and (3).

(2) In regulation 50 (transitional provision), after paragraph (13) insert the following —

"(14) In any proceedings for an offence under regulation 44(1)(a) it is a defence to prove that —

- (a) the food concerned was sold before 23 December 2008 or marked or labelled before that date; and
- (b) the matters constituting the alleged offence would not have constituted an offence under these Regulations if the amendments made by regulation 2(3) of the Food Labelling (Declaration of Allergens) (Wales) Regulations 2007(2) had not been in operation when the food was sold."

(3) In Schedule AA1 (allergenic ingredients) —

- (a) after paragraph 2 insert **"2(a)**. Molluscs and products thereof";
- (b) after paragraph 6 insert **"6(a)**. Lupin and products thereof".
