NOTIFICATION OF CHANGE OF OWNERSHIP/SALE OF MOTOR VEHICLE

NOTE: No person may buy, sell or trade with an unregistered or unlicensed motor vehicle.

CHANGE OF OWNER
 (e.g. bank, cash buyer, etc)

- (1) The seller must duly complete parts A-1 to A-3 and C and the buyer parts B-1 to B-3.
- (2) The seller must sign off the current registration certificate and hand it over to the buyer.
- (3) The seller must deliver this notice to his/her appropriate registering authority within 7 days after the date on which the motor vehicle was sold.
- (4) The buyer must apply for registration of the motor vehicle to his/her appropriate registering authority on form RLV-LS, within 21 days after the date on which the vehicle was purchased/acquired. The application must be accompanied by the current registration certificate.
