There have been changes to the team working with **Damien BOURGAREL, CEO** and **Daniel JACQUEMOND, Deputy CEO**.

Christophe BRASSET was appointed **CEO of Limagrain Coop** last May after a career of more than 30 years in the agricultural cooperative segment. **Régis FOURNIER** became **CEO of Field Seeds** at the end of August after acquiring solid experience in the field seeds segment at Maïsadour, an international cooperative group.

Valérie MAZZA, Corporate VP for Scientific Affairs and Innovation since 2012, joined the Executive Committee.

As of November 1, **Agnès MISTRETTA, Corporate VP for Human Resources** since 2017, was also appointed Head of **Corporate Social Responsibility (CSR)**, which the Group has been committed to since 2012.

Franck BERGER, CEO of Vegetable Seeds since 2016, and **Vincent SUPLOT, Group CFO** since 2017, round out the Group Executive Committee.
