### Jens Stoltenberg Prime Minister

Jens Stoltenberg was born in Oslo on 16 March 1959. He spent his childhood years in Belgrade, Yugoslavia, and Oslo, with his diplomat father, mother and two sisters.

Jens Stoltenberg is an economist from the University of Oslo and went to work in Statistics Norway after graduating in 1987. He was called by Prime Minister Gro Harlem Brundtland to serve as Under-Secretary for the Environment in 1990. In 1993 he was elected Member of Parliament for Oslo, and was also appointed Minister of Trade and Energy in the Brundtland Government. He served as Minister of Finance from 1996 to 1997, when the Labour Party lost the election, and he then returned to Parliament.

Jens Stoltenberg was appointed Prime Minister for the first time at the age of 40 in 2000. He stepped down following the election the year after. He was leader of the opposition until 2005, when he again became Prime Minister after the election that year, which brought in a coalition government. His coalition won the next election in 2009 and held on to the majority in Parliament.

Jens Stoltenberg has also had a number of international assignments. In 2005 he was asked by the UN Secretary-General to co-chair the High-Level Panel on System Wide Coherence. The High-Level Panel presented its report UN – Delivering as One to the Secretary-General in 2006.

In 2010 Jens Stoltenberg became co-chair of the UN Secretary-General's High-Level Advisory Group on Climate Change Financing, together with the Ethiopian Prime Minister, Meles Zenawi. The recommendations of the Advisory Group are now being followed up in relevant international forums.

Stoltenberg has been strongly committed to mobilising political support and funds for fighting maternal and child mortality. In 2012 he co-chaired the UN Commission on Life-saving Commodities for women and children together with the President of Nigeria, Goodluck Jonathan. The Commission has presented its recommendations to the UN Secretary-General to ensure lifesaving medicines in connection with childbirth.

Jens Stoltenberg is married to Ingrid Schulerud, a diplomat. They have two grown-up children.

# Sigbjørn Johnsen Minister of Finance

Sigbjørn Johnsen became Minister of Finance for the second time on 20 October 2009. He represents the Labour Party in a majority government also consisting of the Socialist Left Party and the Centre Party.

Mr. Johnsen was Member of Parliament 1976-1997, including Member of the Standing Committee on Finance 1980-1990. His first term as Minister of Finance was 1990-1996. He was County Governor of Hedmark 1997-2009.

Sigbjørn Johnsen has led several major public commissions, including the Election Law Commission 1997-2000 and the Pension Commission 2000-2002. He was member of Norges Bank's (the Central Bank) Executive Board 1999-2004.

Mr. Johnsen was born in Lillehammer on 1 October 1950, and is married with three children.

# Espen Barth Eide Minister of Foreign Affairs

Espen Barth Eide is Minister of Foreign Affairs of Norway. He has a degree in political science from the University of Oslo, including one year at the Autonomous University of Barcelona. His first entry into public life was as project manager and general secretary of the European Movement International in Norway, prior to the Norwegian European Union membership referendum in 1994.

The year before, in 1993, Mr Eide was appointed researcher to The Norwegian Institute of International Affairs (NUPI), where he was in charge of their UN programme. In 2000, he was appointed to the Norwegian Ministry of Foreign Affairs (MFA) as State Secretary, with responsibilities including European relations, North America and Russia, and general security policy. After two years in the ministry, he returned to NUPI to serve as leader of their Department of International Politics. He also worked as a senior consultant for the UN in New York, in charge of the UN "Report on Integrated Missions".

In 2005, Mr Eide was appointed State Secretary of the Norwegian Ministry of Defence (MoD), and after five years there he returned to the Ministry of Foreign Affairs as State Secretary. In November 2011, Mr. Eide was appointed Minister of Defence in Prime Minister Jens Stoltenberg's government, and in September 2012, he became the Minister of Foreign Affairs. Mr Eide belongs to the Norwegian Labour Party.

# Rob Davies Minister of Trade and Industry

Rob Davies is Minister of Trade and Industry of the Republic of South Africa. Between June 2005 and May 2009 he was Deputy Minister in the same portfolio and has been an ANC Member of the South African Parliament since 1994. He previously chaired the Portfolio Committees of Finance and of Trade and Industry as well as the Sub-Committee of the Constitutional Assembly responsible for the Chapter 13 (Finance) of the Constitution.

Professionally, he has an Honours degree in Economics (from Rhodes University), a Masters in International Relations (from the University of Southampton) and a Doctorate in Political Studies (from the University of Sussex). Between 1979 and 1990, he was attached to the Centre of African Studies, Eduardo Mondlane University, working, until her murder in 1982, under the direction of the late Ruth First. Before entering parliament in 1994, he was Professor and Co-Director of the Centre for Southern African Studies at the University of the Western Cape (UWC). His research interests during this period focused on issues of Southern African regional cooperation and integration. He undertook policy research both for the ANC and the Southern African Development Community (SADC) and also became actively engaged with issues of globalisation and international trade.

# Philipp Rösler Federal Minister of Economics and Technology; Vice Chancellor

Dr. Philipp Rösler was born in Vietnam in 1973 and adopted in Germany the same year. He grew up in Hamburg, Bückeburg and Hanover. Following his university entrance examination, he joined the Federal Armed Forces as a trainee medical officer, studying medicine and commencing specialised training between 1993 and 1999. From 2001 until 2003, he worked as a doctor and medical officer of the Federal Armed Forces.

In 2003, Dr. Rösler was elected to the state parliament of Lower Saxony and remained a member of this parliament and chairman of the FDP state parliamentary group until 2009. At the beginning of 2009, he was appointed Minister of Economics, Labour and Transport and Deputy Minister-President of the State of Lower Saxony. In October 2009 he joined the Federal Government as Federal Minister of Health. He has been Federal Minister of Economics and Technology, Federal Chairman of the FDP and Vice-Chancellor since May 2011.

# Anne Ruth Herkes State Secretary, Federal Ministry of Economics and Technology

Anne Ruth Herkes was appointed State Secretary in the Federal Ministry of Economics and Technology on 5 March 2012 and is responsible for external economic policy, technology policy, and IT, communications and postal policy.

Ms Herkes studied Romance Languages and Literature and Political Science at the Freie Universität Berlin, the Institut d'Etudes Politiques Paris and the London School of Economics, and subsequently spent a postgraduate year at the Diplomatic Academy of Vienna. She entered the German foreign service in 1985. Following training as a diplomat, she took up a post as personal assistant to the State Minister in the Federal Foreign Office. She moved on to serve at the embassies in Washington (1988-92) and Tokyo (1992-96), and at the Permanent Mission to the Organization for Security and Co-operation in Europe in Vienna (1996-99). From 1999 to 2002, she was deputy head of the Protocol Division in the Federal Foreign Office. She then moved to the embassy in London as Head of the Economic Affairs Department until 2006.

That year, Ms Herkes switched to BP Biofuels in London as Vice President Policy and Communications. From July 2010 until her appointment as State Secretary, Ms Herkes was German Ambassador to Qatar.

# Ed Fast Minister of International Trade and Minister for the Asia-Pacific Gateway

The Honourable Ed Fast was first elected to the House of Commons in 2006 and re-elected in 2008 and 2011. He had previously served for two terms as an Abbotsford school trustee and for three terms as a member of Abbotsford City Council.

A graduate of the University of British Columbia, Minister Fast practised corporate and commercial law for 24 years.

On May 18, 2011, Prime Minister Stephen Harper appointed Ed Fast to his cabinet to serve as Minister of International Trade and Minister for the Asia-Pacific Gateway. Minister Fast assumed responsibility for the Government of Canada's Global Commerce Strategy, which aims to create a more competitive Canadian economy by deepening Canada's trade and investment ties in large, dynamic and fast-growing economies around the world. His top trade priorities include oversight of negotiations on free trade agreements with the European Union, India and Japan. Minister Fast is also the lead minister for the Asia-Pacific Gateway and Corridor Initiative.

Prior to his appointment to Cabinet, Minister Fast served on a number of parliamentary committees and chaired the Standing Committee on Justice and Human Rights. In 2011, he was appointed Queen's Counsel for British Columbia and more recently was awarded the Queen's Diamond Jubilee Medal for service to his community and country.

Minister Fast and his wife, Annette, have lived in Abbotsford, British Columbia, for 30 years. They have four daughters.

Ted Menzies was first elected to the House of Commons in 2004 and was re-elected in 2006, 2008 and 2011. ### Felipe Larraín Bascuñán Minister of Finance

Since March 2010, Felipe Larraín Bascuñán is the Minister of Finance of the Government of President Sebastián Piñera. PhD (1985) and Master of Arts (1983) in Economics from Harvard University, and Bachelor of Arts in Economics from Universidad Católica de Chile (1981).

He has been a Professor of Economics at Universidad Católica de Chile in Santiago, where he previously served as Associate and Assistant Professor. From 1997 to 2002 he was affiliated to Harvard University, first as the Robert F. Kennedy Visiting Professor of Latin American Studies (1997-99), then as Faculty Fellow (1999-2002).

Since 1985, he has served as economic advisor to several American governments, including Bolivia, Canada, Colombia, Costa Rica, Chile, Dominican Republic, Ecuador, El Salvador, Guatemala, Honduras, Jamaica, Mexico, Nicaragua, Paraguay, Perú and Venezuela.

Felipe Larraín has been a consultant on macroeconomic issues to the United Nations, the World Bank, the Economic Commission for Latin America and the Caribbean (ECLAC), the Inter-American Development Bank and the International Monetary Fund. He is also the editor and author of ten books, including: Macroeconomics in the Global Economy, co-authored with Professor Jeffrey Sachs, (Prentice Hall: New Jersey; Harvester Wheatsheaf: London, 1993), which has been translated into Chinese, German, Italian, Japanese, Portuguese, Russian and Spanish.

# **Oh-Seok Hyun** Deputy Prime Minister; Minister of Strategy and Finance

Prior to his current position, he served as President of the Korea Development Institute (KDI) from 2009 to 2013, where he helped make economic policies of Korea by providing insightful policy alternatives enabling new growth engines despite the current global fiscal crisis and economic recession.

Dr. Hyun has been a member of the Knowledge Advisory Commission of the World Bank since 2012. In academia, he taught at the School of Management of Korea Advanced Institute of Science and Technology (KAIST). While serving as President of the Institute for International Trade of the Korea International Trade Association (KITA) between 2002 and 2008, he contributed to concluding free trade agreements including the KOR-US FTA, KOR-EU FTA and the DDA.

Dr. Hyun's extensive experience in policy making and research in the public sector is a unique career path for a government official in Korea. He served as Special Advisor to Deputy Prime Minister and Minister of Finance and Economy in 2002, and worked as Director-General of the National Economic Advisory Council in 2000. He was the Director-General of the Bureau of Treasury of the Ministry of Finance and Economy in 1999. He led the structural reform during the Asian Financial Crisis as Director-General of the Bureau of Economic Policy in 1998. He was the Director General of the Bureau of Budget of the Ministry of Finance and Economy from 1996 to 1997. He served as Economist at the World Bank between 1989 and 1991.

Dr. Hyun received his Ph.D. in Economics from the University of Pennsylvania in 1984. He earned his M.A. in Public Administration from Seoul National University in 1976, and earned his B.A. in Business Administration from Seoul National University in 1974.

Dr. Hyun regularly provides insightful knowledge on open-economy macroeconomics, industrial policies and social development through publication and media interviews to further contribute towards designing of economic policies suitable for this truly global era.

He was born in Korea on May 5, 1950, and is married with one daughter and one son.

## Tae-yul Cho Vice Minister of Foreign Affairs

H.E. Mr. Cho Tae-yul is Vice Minister of Foreign Affairs of the Republic of Korea. His distinguished diplomatic career includes postings in Bangkok, Washington D.C., Riyadh and Geneva. Ambassador Berglind Ásgeirsdóttir took up her duties as Permanent Representative of Iceland to the OECD on 7 March 2011.



## Yair Lapid Minister of Finance

Yair Lapid was born in Israel in 1963. As of this past March, he is the Minister of Finance in Israel's newly formed government. He founded and headed a brand new political party Yesh Atid in the recent general elections (January 2013) and surprised politicians and pollsters alike by garnering 19 (out of 120) seats in the Knesset, making his the second largest party.

Prior to pursuing a political career, he was a popular television personality, having anchored the main Friday evening News Program for 3 years and prior to that having hosted for 8 years the popular talkshow on Israel's Channel 2, *Yair Lapid*. On two separate occasions, he was voted as Israeli television's "host of the year".

In his career as a journalist, Yair has interviewed some of the world's leading political, cultural and economic figures. In addition to his career in the electronic media, Yair wrote weekly in Yediot Ahronot (Israel's leading daily) from 2002 until recently what was probably the most widely read and frequently quoted column in Israel. He also worked for the other major Israeli daily *Maariv* as reporter, US correspondent and news editor.

Yair, in addition to journalism, has also been a prolific writer. He has published 11 books (translated and distributed in numerous countries), a number of which became #1 best-sellers in Israel. He has also written several plays and lyrics for a number of songs, as well as a TV drama series. He is a two-time recipient of the "Platinum Book Award" by the Israeli Union of Publishers. His most recent best-seller, Memories After my Death", was a biography of his father (also journalist and politician) Yosef "Tommy" Lapid.

Throughout his professional life, Yair has been active in civic/community affairs. Among the nonprofits in which he volunteered are those assisting the underprivileged *Aleh*, *Youth Renewal Fund* (YRF) and *Miftan Safed* (which he chaired). For 2 years, until last year, he taught civics and media studies at a special "inner-city" high school in one of Tel Aviv-Jaffa's poorest neighborhoods. He was also a partner in the founding of *Home for Life*, a residential facility for autistic youth.

## Luc Frieden Minister of Finance

Luc FRIEDEN was born in Luxembourg on September 16, 1963. He is married and has two children, born in 1994 and 1996.

After finishing high school in Luxembourg, he studied law at the University of Paris I (Panthéon-Sorbonne) where he graduated in 1986 with a degree (maîtrise) in business law. He continued with his postgraduate studies and obtained a Master of Comparative Law and Legal Philosophy at the University of Cambridge, U.K. (1987) and went on to obtain a Master of Laws at Harvard Law School, U.S.A. (1988).

From 1989 to 1998, he worked as an attorney-at-law in Luxembourg. During the same period, he taught constitutional law at the University Center of Luxembourg.

Luc Frieden's political career took off in 1994 when he participated in the general elections in Luxembourg for the Christian Democratic Party (CSV / EPP) and was immediately elected to Parliament. He served as member of the Luxembourg Parliament from 1994 to 1998 and was the Chairman of the Finance Committee and Chairman of the Committee on Constitutional Affairs.

In 1998, at the age of 34, he was appointed Minister of Justice and Minister of Budget in the Luxembourg Government. He was reappointed to those same functions after the general elections of 1999. In 2004, after general elections, he continued to serve as a Minister of Justice and Minister of Treasury and Budget. He was also Minister of Defence from 2004 until 2006. After general elections in 2009, Luc Frieden was again confirmed as a member of the Government and is now the Minister of Finance.

In addition to his functions as Minister of Finance, Luc Frieden was appointed in 2013 Minister for Communications and Media.

He also serves as the Luxembourg Governor of the World Bank, of the European Bank for Reconstruction and Development and of the Asian Development Bank.

(1994).

At the state level, he was head of the Governor's Executive Office (2003 – 2006), year in which he ran as candidate for Congress for the First Local District of Monterrey, position that won, becoming leader of the Minority Group of the Nuevo Leon State Congress, in the LXX Legislature.

His latest positions were Federal Congressman for the Second District of Nuevo Leon, Chairman of the Economics Commission, Member of the Treasury and Public Credit Commission, and President of the Mexico-U.S.A. Friendship Group at the LXI Legislature of the Mexican Chamber of Deputies, and Coordinator of the Entrepreneurial Liaison in the Presidential Campaign of Mr. Enrique Peña Nieto.

He has been a full time professor at the Autonomous University of Nuevo León; and assistant professor at the Arizona State University and the Wharton Business School at the University of Pennsylvania.

On December 1, 2012, Mr. Guajardo Villarreal was appointed as Secretary of the Economy by the President Enrique Peña Nieto.

Tim is a special guest of the Major Economies Forum, which is dedicated to climate change. He has represented New Zealand at numerous UN, UNCTAD, OECD, World Bank, UNFCCC and APEC Conferences. He was chief adviser to the NZ ABAC (APEC Business Advisory Council) delegation 2000-2002.

In 1988, Guy Ryder became Assistant Director and, from 1993, Director of the Geneva office of the International Confederation of Free Trade Unions (ICFTU).

Guy Ryder first joined the International Labour Organization in 1998 as Director of the Bureau for Workers' Activities and, from 1999, as Director of the Office of the Director-General. It was during this time that the ILO's Decent Work Agenda was launched and won support from the international community.

In 2002, he moved to Brussels where he was appointed General Secretary of the ICFTU, leading the process of global unification of the democratic international trade union movement. He was elected as first General Secretary of the International Trade Union Confederation (ITUC) when it was created in 2006. He headed international trade union delegations to high level talks with the UN, IMF, World Bank and WTO and to the G20 Leaders' Summits.

In September 2010, Guy Ryder came back to the ILO in Geneva as Executive Director, responsible for international labour standards and fundamental principles and rights at work. Among other activities, he supervised the application of ILO Conventions and Recommendations. He also headed several high-level ILO missions to address a range of issues related to labour standards in countries such as Bahrain, Colombia, Fiji, Georgia, Greece, Myanmar and Swaziland.

Guy Ryder was elected as ILO Director-General in May 2012 and took office on 1 October, 2012.

#### Pascal Lamy Director-General

Mr. Pascal Lamy is Director-General of the World Trade Organization (WTO) since September 2005.

Mr. Lamy holds degrees from the Paris based Ecole des Hautes Etudes Commerciales (HEC), from the Institut d'Etudes Politiques (IEP) and from the Ecole Nationale d'Administration (ENA). He began his career in the French civil service at the Inspection Générale des finances and at the Treasury. He then became an advisor to the Finance Minister Jacques Delors, and subsequently to Prime Minister Pierre Mauroy.

In Brussels from 1985 to 1994, Pascal Lamy was Chief of staff for the President of the European Commission, Jacques Delors, and his representative as Sherpa in the G7.

In November 1994, he joined the team in charge of rescuing the French bank, Credit Lyonnais, and later became CEO of the bank until its privatisation in 1999.

Between 1999 and 2004, Pascal Lamy was Commissioner for Trade at the European Commission under Romano Prodi.

After his tenure in Brussels, Pascal Lamy spent a short sabbatical period as President of "Notre Europe", a think tank working on European integration, as associate Professor at the Institut d'études politiques in Paris and as advisor to Poul Nyrup Rasmussen (President of the European Socialist Party).

Mr. Lamy was reappointed Director-General of the World Trade Organization by its Members for a second mandate in May 2009.

#### Angel Gurría Secretary-General

Born on May 8th, 1950, in Tampico, Mexico, Angel Gurría came to the OECD following a distinguished career in public service, including two ministerial posts.

As Mexico's Minister of Foreign Affairs from December 1994 to January 1998, he made dialogue and consensus-building one of the hallmarks of his approach to global issues. From January 1998 to December 2000, he was Mexico's Minister of Finance and Public Credit. For the first time in a generation, he steered Mexico's economy through a change of Administration without a recurrence of the financial crises that had previously dogged such changes.

As OECD Secretary-General, since June 2006, he has reinforced the OECD's role as a 'hub" for global dialogue and debate on economic policy issues while pursuing internal modernization and reform. Under his leadership, OECD has expanded its membership to include Chile, Estonia, Israel and Slovenia and opened accession talks with Russia. It has also strengthened links with other major emerging economies, including Brazil, China, India, Indonesia and South Africa, with a view to possible membership. The OECD is now an active participant in both the G-8 and the G-20 Summit processes.

Mr. Gurría has participated in various international not-for-profit bodies, including the Population Council, based in New York, and the Center for Global Development based in Washington. He chaired the International Task Force on Financing Water for All and continues to be deeply involved in water issues. He is a member of the International Advisory Board of Governors of the Centre for International Governance Innovation, based in Canada, and was the first recipient of the Globalist of the Year Award of the Canadian International Council to honour his efforts as a global citizen to promote trans-nationalism, inclusiveness, and a global consciousness.

Mr. Gurría holds a B.A. degree in Economics from UNAM (Mexico), and a M.A. degree in Economics from Leeds University (United Kingdom). He speaks: Spanish, French, English, Portuguese, Italian and some German.

He is married to Dr. Lulu Quintana, a distinguished ophthalmologist, and they have three adult children.



## Pier Carlo Padoan Deputy Secretary-General and Chief Economist of the OECD

Mr. Pier Carlo Padoan took up his functions as Deputy Secretary-General of the OECD on 1 June 2007. As of 1 December 2009 he was also appointed Chief Economist while retaining his role as Deputy Secretary-General. In addition to heading the Economics Department, Mr. Padoan is the G20 Finance Deputy for the OECD and also leads the Strategic Response, the Green Growth and Innovation initiatives of the Organisation and helps build the necessary synergies between the work of the Economics Department and that of other Directorates.

Mr. Padoan is an Italian national and prior to joining the OECD was Professor of Economics at the University La Sapienza of Rome, and Director of the Fondazione Italianieuropei, a policy think-tank focusing on economic and social issues.

From 2001 to 2005, Mr. Padoan was the Italian Executive Director at the International Monetary Fund, with responsibility for Greece, Portugal, San Marino, Albania and Timor Leste. He served as a member of the Board and chaired a number of Board Committees. During his mandate at the IMF he was also in charge of European Co-ordination.

From 1998 to 2001, Mr. Padoan served as Economic Adviser to the Italian Prime Ministers, Massimo D'Alema and Giuliano Amato, in charge of international economic policies. He was responsible for co ordinating the Italian position in the Agenda 2000 negotiations for the EU budget, Lisbon Agenda, European Council, bilateral meetings, and G8 Summits.

He has been a consultant to the World Bank, European Commission, European Central Bank.

Mr. Padoan has a degree in Economics from the University of Rome and has held various academic positions in Italian and foreign universities, including at the University of Rome, College of Europe (Bruges and Warsaw), Université Libre de Bruxelles, University of Urbino, Universidad de la Plata, and University of Tokyo. He has published widely in international academic journals and is the author and editor of several books.



#### Richard A. Boucher Deputy Secretary-General

Ambassador Richard A. Boucher was appointed Deputy Secretary-General of the OECD in November 5, 2009. Among his responsibilities, he spearheads the Organisation's global relations portfolio, including outreach and accession. He also has oversight of the OECD's work in anti-corruption, science and technology, investment and corporate affairs and private sector development.

Ambassador Boucher, a U.S. national, is a senior foreign policy executive who has managed world-wide teams, programs and strategies and brings extensive experience in emerging economies. Over his thirty-year career in foreign policy, he has consistently had challenging assignments and achieved the highest rank in the United States Foreign Service.

From 2006 to 2009, as Assistant Secretary of State for South and Central Asia, Ambassador Boucher was involved in high-level negotiations throughout the region, from Kazakhstan to India. Prior to this, he became the longest-serving Spokesman and Assistant Secretary for Public Affairs, crafting the U.S. public approach on critical world issues for six Secretaries of State. In 1999, he served as the U.S. Senior Official for Asia-Pacific Economic Co-operation promoting more open trade and an improved investment climate. From 1993 to 1999, he served consecutive terms as the U.S. Ambassador to Cyprus and Consul General in Hong Kong.

Ambassador Boucher is fluent in French and Mandarin Chinese. He holds a BA in French and English Literature from Tufts University and undertook further studies in International Economics at George Washington University.



### Rintaro Tamaki Deputy Secretary-General

Mr. Rintaro Tamaki was appointed Deputy Secretary-General of the OECD on August 1, 2011. His portfolio includes the strategic direction of OECD policy on Environment, Development, Green Growth, Financial Affairs and Taxes.

Prior to joining the OECD Mr. Tamaki, a Japanese national, was Vice-Minister of Finance for International Affairs at the Ministry of Finance, Government of Japan.

During his prominent 35-year career at the Japanese Ministry of Finance, Mr. Tamaki has worked on various budget, taxation, international finance and development issues. He worked as part of the OECD Secretariat from 1978 – 1980 in the Economic Prospects Division and from 1983 – 1986 in the Fiscal Affairs Division of the Directorate for Financial, Fiscal and Enterprise Affairs (DAFFE). In 1994 Mr. Tamaki was posted to the World Bank as Alternate Executive Director for Japan and in 2002 as Finance Minister at the Embassy of Japan in Washington DC. He then became Deputy Director-General (2005), before becoming Director-General (2007) and subsequently Vice-Minister for International Affairs (2009) at the Ministry of Finance.

Mr. Tamaki graduated in 1976, L.L.B. from the University of Tokyo and has held academic positions at the University of Tokyo and Kobe University. He has published books and articles on international institutions, the international monetary system, development, debt and taxation.



#### Yves Leterme Deputy Secretary-General

Yves Leterme was appointed Deputy Secretary-General of the OECD on 8 December 2011. He is in charge of Social Affairs, Education, Governance and Entrepreneurship.

Before joining the OECD, Yves Leterme held a variety of political posts in Belgium at all levels and in all areas of government. After starting his career as an alderman in his home town of Ypres, he became a Deputy in the Chamber of Representatives, Group Chairman, National Secretary and Chairman of the CD&V party, Minister-President of the Flemish Government, Federal Senator, Deputy Prime Minister, Minister of the Budget and Mobility, Minister of Foreign Affairs and Prime Minister. Yves Leterme is currently Minister of State and a municipal councillor in Ypres.

At a professional level, Yves Leterme has worked, inter alia, as a deputy auditor at the Belgian Court of Audit and an administrator at the European Parliament.

Yves Leterme, who was born on 6 October 1960, has a degree in Law and Political Science from the University of Ghent.

Gabriela Ramos is the OECD Chief of Staff and Sherpa to the G20. Prior to joining the OECD, Ms. Ramos held several positions in the Mexican Government, notably as advisor to the Minister of Foreign Affairs and Director of OECD Affairs. She has also held several positions as Professor of International Economy at the Universidad Iberoamericana and at the Instituto Tecnológico Autónomo de México. Ms. Ramos holds an MA in Public Policies from Harvard University, and was a Fulbright and Ford MacArthur fellow.

From 1978 to 1982, she was a project director at the Congressional Office of Technology Assessment, specializing in East-West trade, technology transfer and Soviet energy development.

## Charles P. Heeter, Jr.

## BIAC Chair (Outgoing); Managing Director, Deloitte Touche Tohmatsu Limited

Charles P. Heeter Jr. is Managing Director, Deloitte Touche Tohmatsu Limited. He directs the Deloitte global public policy program, is responsible for building cooperative relationships with other capital markets stakeholder groups, and coordinates the organization's global regulatory program.

Prior to joining Deloitte, Mr. Heeter was a Principal, Associate Principal and Manager with Andersen Worldwide (1984-2002). At Andersen, he created a service center in Washington DC to support the organization's partners, offices and clients on non-technical international issues; coordinated a worldwide program to address trade and investment barriers in the accounting profession; and supported the firm's leadership in their participation in international business and professional organizations. From 1975 to 1984, Mr. Heeter was the Director of Trade and International Affairs for the Government Research Corporation, a Washington DC-based public affairs consulting group. He also served as the legislative research assistant to a Member of Congress, working primarily on international issues.

Mr. Heeter was elected in June 2006 to a two-year term as Chairman of the Business and Industry Advisory Committee (BIAC) to the OECD, representing the interests of business in the 34 OECD member countries and its Observers. He is Vice Chairman of the Financial Services and Insurance Commission of the International Chamber of Commerce (ICC), and is a member of the ICC's Commission on International Trade and Investment. Mr. Heeter also serves as a member of the Executive Committee of the United States Council for International Business, the US affiliate of BIAC and ICC.

Will Morris is currently Director, Global Tax Policy, in General Electric's corporate tax department based in London. Will has degrees in history, law, and theology from Trinity College Cambridge, the University of Virginia, and St Mellitus College, respectively. He is qualified as a US attorney and an English solicitor.

After private practice in London and Washington, DC, he joined the IRS in 1995, moving to the Office of Tax Policy at the US Treasury in January 1997 to work on international tax policy. Mr. Morris was Associate International Tax Counsel until March 2000, when he joined GE, first in Fairfield CT., then London.

Mr. Morris was appointed Chair of the BIAC Tax Committee to the OECD in November 2012. He is also Chair of the CBI Tax Committee and of the AmCham EU Tax Committee, as well as the European Tax Policy Forum (ETPF), a registered UK charity that since 2005 has commissioned over 40 papers from leading academic economists into business tax issues.

Prior to this he served as Executive Director of the New Zealand Newspaper Publishers Association from 1989 to 1999 and Chairman of the New Zealand Advertising Standards Authority from 1995 to 1999.

After graduating in 1985 from the University of Auckland with an Honours Masterate in History he worked as an Industrial Advocate from 1986 to 1989, representing many industrial sectors and negotiated with more than ten unions to agree New Zealand's first composite industry award.

Mr. O'Reilly is a Member of several Boards and Advisory Groups concerned with labour, manufacturing and trade issues, including the Industry Capability Network Advisory Group, the Workplace Health and Safety Council, the International Business Forum and Export New Zealand.

Professor Randolf Rodenstock is Managing Partner of Optische Werke G. Rodenstock GmbH & Co. KG, and former President of the Bavarian Industry Association (vbw).

Having graduated with Physics Diploma in 1976, Pr. Rodenstock joined Optische Werke G. Rodenstock, Munich. ## **Richard Trumka**

## President of TUAC; President, American Federation of Labor & Congress of Industrial Organizations

In September 2009, Richard Trumka was elected President of the AFL-CIO. His election followed 15 years of service as the AFL-CIO's Secretary Treasurer. It capped Trumka's rise to leadership of the nation's largest labour federation from humble beginnings in the small coal mining communities of southwest Pennsylvania. Richard Trumka was elected President of the Trade Union Advisory Committee (TUAC) to the OECD in 2010.

Richard worked in the mines for more than seven years, working his way through Penn State University, where he graduated in 1971 with a Bachelor of Science degree, and eventually got a law degree from Villanova University in 1974. He worked on the legal staff of the United Mine Workers for four years before returning to mine work in 1979.

Once back at work in the mining community, Trumka rose quickly through the ranks, first serving as chair of UMWA Local 6290's safety committee and later on the union's International Executive Board. At 33, he was elected the UMWA's youngest president.

By his third term as president of the Mine Workers in 1995, Trumka's record of activism, innovation and reform was firmly established and well known to AFL-CIO union presidents. In 1995, Richard became the youngest Secretary-Treasurer in AFL-CIO history.



#### John Evans TUAC General Secretary, ITUC Chief Economist

John Evans is General Secretary of TUAC, a position he has held since 1985.

After studying, Philosophy, Politics and Economics at the University of Oxford and teaching Introductory Economics, he worked as an economist in the Economic Department at the Trade Union Congress in London. Subsequent posts included positions with the International Federation of Commercial, Clerical and Technical Employees (FIET- the forerunner of what is now UNI Global Union) in Geneva and Research Officer with the European Trade Union Institute in Brussels where he published extensively on Labour Markets and the Impact of Technological Change on Employment.

Since 2012 he also serves as Chief Economist of the International Trade Union Confederation in Brussels. TUAC and the ITUC together form the secretariat for the L20 that coordinates the labour input to the G20 process.

Past not-for profit board positions include the Global Reporting Initiative and the Helsinki Group. He is currently a member of the Comité Médicis at the Amundi Group, the Conseil d'Orientation, IDDRI (the French Institute for Research on Sustainable Development) and Council of Ruskin College, Oxford. He is also Chair of the World Economic Forum Global Agenda Council on Employment.



#### Sharan Burrow General Secretary of the International Trade Union Confederation (ITUC)

Sharan Burrow was elected General Secretary of the International Trade Union Confederation (ITUC) at its Second World Congress in Vancouver in June 2010. Previously President of the Australian Council of Trade Unions (ACTU) since 1992, she served as inaugural President of the ITUC from its foundation in Vienna in 2006, and of the International Confederation of Free Trade Unions (a predecessor organisation to the ITUC) from 2004.

Sharan Burrow was born in 1954 in Warren, New South Wales (NSW), and graduated from the University of NSW as a teacher in 1976, following which she taught at high schools until 1980 when she began working for the NSW Teacher's Federation. In 1992 she was elected President of the Australian Education Union, until her election as ACTU President.



#### Ken Georgetti President, Canadian Labour Congress

Ken Georgetti's career has taken him from pipefitter to President of the Canadian Labour Congress, and from being ordered to face seditious conspiracy charges for leading a general strike to being awarded the Order of Canada for service to the country.

Ken Georgetti is now the longest-serving president since the CLC was established in 1956. Under Ken's leadership, the CLC membership has grown by 750,000 new union members to represent 3.3 million workers. First elected at age 46 in May 1999 as the youngest president in the CLC's history, Ken's contributions to labour and the community have earned him the Order of Canada, the Order of British Columbia, the Queen Elizabeth II Golden Jubilee Medal for Community Service, the Commemorative Medal for the 125th Anniversary of the Confederation of Canada in recognition of significant contribution to Canada, and the Queen Elizabeth II Diamond Jubilee Medal in 2012 that honours significant contributions and achievements by Canadians. In 2011, he was named a Life Literacy Ambassador by ABC Life Literacy Canada.



## Marie-Louise Knuppert

TUAC Vice-President, National Secretary, Danish Confederation of Trade Unions (LO Denmark)

Marie-Louise Knuppert is a National Secretary in the Danish Confederation of Trade Unions (LO Denmark) and the Vice-President of TUAC.

Ms. Knuppert trained to become a union representative through the Trade Union Movement's Internal Training System and studied labour market policy and business organisation in the Open University, AUC. She has been a member of LO Denmark's management since 2005, and its General Council since 1999.

She sits on a number of boards, including the Danish Trade Union Council for International Development Co-operation, Danida (the Danish International Development Agency), the Workers' Educational Association and the European Trade Union Confederation Executive Committee.

#### Mario Monti Senator and former Prime Minister of Italy

Mario Monti has been Prime Minister of Italy (November 2011-April 2013) and Minister of Economy and Finance (November 2011-July 2012).

In November 2011 he was appointed Senator-for-life by the President of the Italian Republic, Giorgio Napolitano.

He served for ten years as a member of the European Commission, in charge of the Internal market, Financial services and Tax policy (1995-1999), then of Competition (1999-2004). In addition to a number of high-profile cases, he introduced radical modernization reforms of EU antitrust and merger control and led, with the US authorities, the creation of the International Competition Network (ICN).

He is President of Bocconi University, Milan, and Honorary Chairman of Bruegel, the European think-tank he founded in 2005.

He is the author of the report to the President of the European Commission on "A new strategy for the single market" (May 2010).

Born in Varese, Italy, in 1943, he graduated from Bocconi University and did graduate studies at Yale University. Prior to joining the European Commission, he had been Professor of Economics and Rector at Bocconi. His publications focus mainly on monetary and financial economics, public finance, competition policy and on the economic and political dimensions of European integration.
