The Survivor Advocacy Program (SAP) seeks to provide support and advocacy services to student survivors of sexual assault, dating/domestic violence and stalking. We work to increase survivors' access to support and resources.

SAP is staffed by three full-time, licensed professionals: a director of the program and two survivor advocates/case managers. The program is part of the Division of Student Affairs. All staff are confidential and are not mandated reporters.

What To Expect from an Advocate

» CONFIDENTIALITY.

Assurance that what you share will be kept private and confidential, barring any legal exceptions and/ or your permission.

» RESPECT, EMPATHY, SUPPORT, BELIEF.

Advocates are there to listen, not to pass judgment or investigate. We always use the "Start By Believing" approach.

» A SURVIVOR-CENTERED APPROACH TO ADVOCACY.

We acknowledge that you are the expert in your situation. Advocates have knowledge and experience to assist you in making informed choices, but those choices are yours and deserve to be respected.

Regardless of when an assault occurred, or when the dating/domestic violence or stalking began, the Survivor Advocacy Program is here to serve you and help you make informed decisions.

If the person seeking services is a faculty/staff member or a community member (not an OHIO student), advocacy services are available through The Survivor Advocacy Outreach Program (SAOP) (740) 591-4266.

If you have experienced sexual assault, dating/ domestic violence, sexual harassment or stalking:

WE BELIEVE YOU.

- If you wish to seek medical attention or receive a forensic exam, an advocate can accompany you to OhioHealth O'Bleness qHospital.
- If you choose to report to law enforcement or Title IX, an advocate can provide support throughout the reporting and interview process.
- If you choose not to report the incident or seek medical attention, you can still utilize SAP services for support, crisis intervention, accommodations, referrals and workshops.

If someone discloses an assault to you:

- Your response to a survivor is very important. Always Start by Believing, it can make a significant difference.
- Ask if the survivor is safe or what they need to feel safe.
- Do not not press for details. Let the survivor guide the conversation and level of disclosure.
- Do not make promises that you cannot keep.
- Trauma may cause a survivor to act in unexpected ways or have limited memory. Know that there is no "right" or "wrong" way to act after a traumatic incident.
- Know that all University employees (exception-SAP, CPS & Campus Care) are mandated reporters.
