Objection/Response to Motion for Relief from Stay & Notice of Hearing Thereon

Introduction

This document contains filing procedures for e-filing objections or responses to motions for relief from stay in chapter 7 and chapter 13 cases and the notices of hearings thereon that must accompany such objections or responses.

Required Forms

Objections/responses to motions for relief from stay must be filed on the following forms in the following order as a single PDF document:

- [LBF 721](#), *Notice of Hearing on Motion for Relief from Debtor's Automatic Stay in a Chapter 7/13 Case, and/or Codebtor's Stay in a Chapter 13 Case*
- [LBF 720.80](#), *Chapter 7/13 Motion for Relief from Debtor/Chapter 13 Codebtor Stay*

LBF 721: Notice of hearing

Before filing the objection/response, go to the [Ch. 7/13 Relief From Stay Hearing](#) page on the court's website.¹

Use the first hearing date on this page that is at least six calendar days after the objection will be filed to complete the hearing date and time sections of the form.

LBF 720.80: Objection/response form

A motion for relief from stay must be filed on LBF 720.80. To file an objection to the motion, complete the "**OBJECTION**" sections for each applicable part.

For example, when objecting to a relief from codebtor stay request which is included in the form at part 4, enter the grounds for objection here:

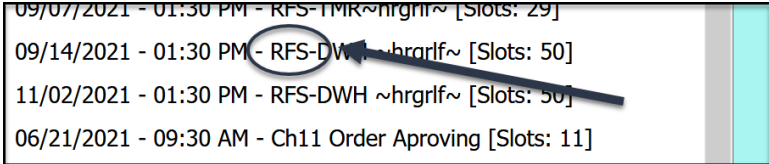
