**PETITION/OBJECTIONS TO SET ASIDE
NOMINATION PETITION/NOMINATION PAPERS**

AND NOW comes the Petitioners, Donald E. Land and Patrick M. Casey, by and through their attorneys, DILLON McCANDLESS KING COULTER & GRAHAM, L.L.P., per Thomas W. King, III, Esquire and Thomas E. Breth, Esquire to file the within Petition to Set Aside Nomination Petition/Nomination Papers of Gregory G. Deal as a candidate for the State Representative in the 2022 Election for the Eleventh Legislative District of the Commonwealth of Pennsylvania, averring thereof as follows:

1. The Court has exclusive original jurisdiction over the subject matter of this action pursuant to 42 Pa. C.S. § 764 and Section 977 of the Pennsylvania Election Code (Election Code), 25 P.S. § 2937.

2. Petitioners are duly qualified and validly registered electors residing within the Eleventh Legislative District and registered to vote therein in Butler County, Pennsylvania.

3. Petitioners are duly qualified and validly registered electors of the Republican Party in Pennsylvania with addresses as follows: Donald E. Land, 433 Saxonburg Blvd., Saxonburg, Pennsylvania 16056, and Patrick M. Casey, 227 E. Pearl Street, Butler, Pennsylvania 16001.

4. Upon information and belief, Respondent, Gregory G. Deal ("Respondent"), resides at 162 Nursery Lane, Butler, PA 16002.

5. On or about July 26, 2022, Respondent filed Nomination Papers with the Pennsylvania Department of State to run as a candidate for the Libertarian Party for Eleventh Legislative District of the Commonwealth of Pennsylvania. (A true and correct copy of Respondent's Nomination Papers are attached hereto as "Exhibit A.")

6. Pursuant to Section 912.1(14) of the Election Code, 25 P.S. 2872.1(14), Respondent was required to submit no less than three hundred (300) valid signatures of registered electors who reside in 11th Legislative District in order to be eligible to stand as a candidate for the Libertarian Party for State Representative for the Eleventh Legislative District of the Commonwealth of Pennsylvania.

7. However, for the reasons set forth more fully in the Petitioners' Objections Spreadsheet, Respondent's Nomination Papers fail to contain the required number of properly ascribed signatures, and/or is otherwise improper. (A true and correct copy of Petitioner's Objection Spreadsheet is Attached hereto as "Exhibit B.") Specifically, Petitioner challenges 121 signature lines in Respondent's Nomination Papers as defective.

8. As a result of the foregoing, Respondent's Nomination Papers contain only 222 valid signature lines that comport with the requirements of the Election Code.

9. As a further result of the foregoing, Respondent's Nomination Papers fail to conform to the express requirements of the Election Code.

10. Section 977 of the Election Code, 25 P.S. § 2937, provides that a court shall set aside Nomination Petitions/Nomination Papers that are defective.

11. For all the foregoing reasons, Respondent's Nomination Papers must be set aside, and his name should not be placed on (or alternatively, stricken from) the ballot.

12. Petitioners respectfully reserve their right to add such additional objections as are appropriate at the time of hearing.

WHEREFORE, Petitioners pray this Honorable Court issue a Rule upon Respondent to show cause why his Nomination Papers should not be set aside, and further, enter an order that Respondent's name shall not be placed on (or alternatively, stricken from) the ballot.
