Eric Krasnoff

Chairman of the Board and Chief Executive Officer



Eric Krasnoff is Chairman of the Board and Chief Executive Officer of Pall Corporation. With annual sales exceeding \$2.3 billion, Pall is the largest and most diverse filtration, separation and purification company in the world.

Pall provides leading-edge products and services that protect people and the environment. The company's technologies enable customers to purify and conserve water, reduce their carbon footprint, make alternative energy sources practical and advance health care. Key markets include biotechnology, medical, energy, electronics, water and aerospace.

Since joining the company in 1975, Mr. Krasnoff has been a key figure in Pall Corporation's development. He has served in a variety of corporate management positions leading to responsibility for the company's Medical and Diagnostics market in 1987. From then until being elected Pall's President and Chief Operating Officer in 1993, this Division's sales grew from \$40 million to \$200 million a year. Mr. Krasnoff served as Pall Corporation's Group Vice President from 1987 to 1991 and Executive Vice President, responsible for worldwide sales and marketing for all Pall business lines, from 1991 to 1993. Mr. Krasnoff was elected Chairman and Chief Executive Officer in 1994.

A graduate of Columbia University, Mr. Krasnoff is an active community leader. He is the past Chairman of the National Blood Foundation (2001-2005). He is a long-time Trustee of Long Island University, serving on the Executive Committee and as Chairman of the Planning Committee. Mr. Krasnoff is a member of the Board of Directors for Winthrop Hospital and a Trustee of the Long Island Children's Museum, among many eleemosynary involvements.

Donald Stevens

President and Chief Operating Officer of Pall Corporation



Don Stevens was appointed to the position of President of Pall Corporation in April 2008. Don is also the Chief Operating Officer and President of Pall Industrial, responsible for the global operation of that business, representing about 59% of Pall's annual sales. He is also responsible for Pall's Global Common Support Functions such as regional shared services, logistics and indirect procurement. Don is the leader of the company's strategic planning and business development process, drives the broadening of Pall's Total Fluid Management (TFM) capabilities, and champions key corporate initiatives.

Previously, Don was Executive Vice President of Pall Corporation, with global responsibility for the Industrial Filtration market. This serves producers of municipal drinking water, semiconductors, oil, gas, electricity, chemicals, automobiles, information storage, photographic film, food and beverages, and the aerospace market.

Don has held many key management positions since joining Pall Corporation in 1968, including that of Group Vice President. During his career, he has launched several new business segments for Pall Corporation, and led the integration of several acquisitions, and more recently the restructuring of numerous business processes in Europe and the WH.
