UMTHETHOSIVIVINYWA WOKUCHIBIYELA UKULAMULA UKUPHATHWA KWAMACALA OKUPHULWA KWEMITHETHO YOMGWAQO [B 38-2015] Isimemo somphakathi sokuthumela ezinye izethulo

IKomidi lesiShayamthetho kuZwelonke mayelana nezokuThutha limema bonke abantu nababambiqhaza abanentshisekelo ukuthi bathumele okunye ukuphawula kwabo okubhaliwe ngoMthethosivivinywa wokuChibiyela uMthetho wokuLamula ukuPhathwa kwamaCala okuphulwa kweMithetho yoMgwaqo iAdministrative Adjudication of Road Traffic Offences Amendment Bill [B 38-2015] njengoba kuqukethwe ezichibiyelweni eziphakanyiwe ezilandelayo ezidlulayo ohlelweni loMthethosivivinywa:

- Ukufakwa kwegama elithi “ukwephula” encazelweni ephakanyiwe “yoMthetho kaZwelonke wezokuThutha ezihamba phansi, wezi-2009 (uMthetho Nombolo 5 wezi-2009) kanye noMthetho wezokuThutha ezihamba eMgwaqeni ezeqa imiNgcele, wezi-1998 (uMthetho Nombolo 4 wezi-1998)” emva kwebinzana elithi “umthetho olawula umgwaqo.”
- Ukufakwa komshwana osungula ubuye uphathe izinhlelo zokuhlumelelisa izimilo kulabo abavamile ukuphula umthetho.
- Ukufakwa kweSahluko eMthethweni omkhulu, emva kweSahluko III, esizohlinzekela ukusungulwa kweNkantolo yokuBuyekezwa kwamacala.
- Ukufakwa komshwana omusha omayelana nokwabiwa kwezinhlawulo kubandakanya, kodwa kungagcini, ekubhekeni ukuvimbela ukuthi izinhlawulo zingaphindwaphindwa noma kube nezinye izindlela okungakhethwa kuzo.

UMthethosivivinywa wayiswa eKomidini mhla zingama-30 kuLwezi wezi-2015 (ACT Nombolo 161-2015). IKomidi labamba izigcawu zomphakathi labheka ukuchibiyela okuphakanyiwe kuMthethosivivinywa. Ngenkathi lisahlola isihloko soMthethosivivinywa nangenkathi yezigcawu zomphakathi iKomidi labona kunesidingo sokuchibiyela okunye okuhlinzekela uMthetho omkhulu obekungafakiwe kuMthethosivivinywa, ngalokho libe selelula ukuxhumana nomphakathi.
