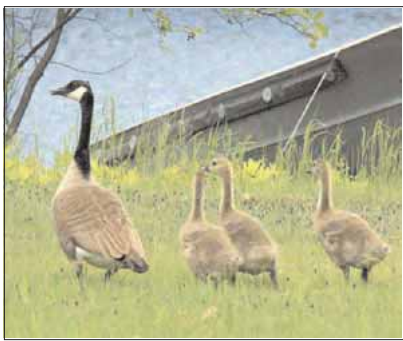

## Wabeno Area Players present "A Day at the Old Schoolhouse"



Have you ever wondered what rural schools were like in the early 1900s? For starters, you'd have to imagine eight grades of students, sharing one teacher, and in only one classroom. On Saturday, August 13, with shows, at 2:00 and 6:00 p.m., the Wabeno Area Players will take audiences back in time for a glimpse at the one-room schoolhouse, with an original readers' theater production of, "A Day at the Old School House."

The Players' production will be performed on a stage in front of the one-room schoolhouse in the park in downtown Wabeno. The play is a collection of historical and comedic skits that explore the system of education that served rural Wisconsin for 150 years.

The story will be told through the eyes of Grandma Clara who was once a student and later a teacher in a one-room school. Costumed actors will bring to life what it was like to be a teacher, student, parent and even the schoolhouse itself during that time in our history. Topics will also include the beginnings and demise of one-room schoolhouses, discipline in the classroom, the daily schedule and even outhouse protocol. The Wabeno Area Players promise it will be a fun, educational, and eye-opening event for all ages.

Tickets will be sold at the schoolhouse in the Wabeno Park, beginning one hour before each show. The cost is \$5.00 per person. There will be folding chairs, but you may wish to bring your own chair. ### Wisconsin Caterpillars

Once again this summer, my wife is out with her day car minions collecting milkweed and monarch butterfly eggs and caterpillars. She'll put the milkweed and eggs in a large terrarium that's presently taking up a lot of space on our kitchen island, and then has her daycare monitor their growth and transformation from caterpillars to butterflies. She usually is able to raise and release about a dozen butterflies.

Did you know that besides the Monarch, there are more than 50 species of caterpillars found in Wisconsin? Each with their own host plants, colorations, and adaptations, the variety is extensive.

Five common caterpillars in Wisconsin are the:  
 • Monarch: the best place to look for monarch caterpillars is in open areas or along woodland edges. Monarchs spend a lot of time on their host plant, the milkweed. They lay their eggs on them and caterpillars eat their leaves. An interesting fact is that when they eat the leaves, the caterpillars absorb the poison in the leaves, which makes them taste bad to predators!  
 • Painted Lady: This caterpillar lives in silk nests on 100+ host plants, including thistles, hollyhocks, and mallows. Caterpillars spend most of their time in these nests. Look for these in open habitats such as old fields, meadows, disturbed areas, and roadsides.

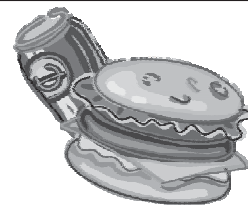

- **Viceroy:** This caterpillar's strange appearance is a camouflage to look like bird droppings. Their host plants are the willow, poplar, and cottonwood trees. Viceroy's hibernate in tube-like shelters built on the leaves of these trees. They are a very unique looking caterpillar, but the adults look very similar to monarchs. You can find these caterpillars in wetland areas, especially along streams where their host trees are found.
- **Red Admiral:** The red admiral is often found along edges of wet wooded areas, streams, trails, and nearby fields. They tend to live on plants in the nettle family. The stinging nettle helps the caterpillars protect themselves from predators. They also range in color from yellow all the way to black.
- **Cabbage White:** As the name suggests, this caterpillar lives off cabbage as well as broccoli, cauliflower, and turnip leaves. Holes in these vegetable leaves are indicators of the presence of this caterpillar. They are pale green and covered in short velvet-like hairs. This caterpillar can be found in any open areas with plants in the mustard family.

**Damage Causing Caterpillars**

There are at least three invasive caterpillars that can be found defoliating leaves of hardwood trees such as aspen, oaks, and birch.

- **Eastern Tent Caterpillar:** The eastern tent caterpillar, *Malacosoma americanum*, is a conspicuous sight in early spring in Wisconsin. Those white masses in the forks of tree limbs are created by colonies of caterpillars. The tent protects them from predators, such as birds, and from temperature extremes. They come out of their silken webs to feed in early morning, evening or at night when it is not too cold. They return to the nest during the heat of the day and remain in the tent during rainy or cold weather.
- **Forest Tent Caterpillar:** The forest tent caterpillar is an important leaf-eating (defoliating) caterpillar in Wisconsin. Some people call forest tent caterpillars "army worms" because as they travel across the ground they look like marching soldiers. Forest tent caterpillars are about 2 inches long with colorful bodies covered by many hairs. The sides of their bodies are blue with narrow orange stripes. Their backs are black with white markings that resemble keyholes, penguins, or footprints.
- **Gypsy Moth Caterpillar:** European gypsy moths were accidentally introduced into Massachusetts in 1869 by an amateur entomologist. Since then, gypsy moths have defoliated millions of acres of trees in forests and urban areas in at least 20 states and the Washington DC area. Gypsy moth caterpillars feed on more than 300 species of deciduous and evergreen trees. Gypsy moths were first found in Wisconsin in the late 1960s in the eastern part of the state. Moths have since been found in every county. The eastern two-thirds of the state is considered generally infested.

What I mean by that is this town cannot and will not function properly or efficiently without your eyes and ears. Your calls are appreciated and welcomed, as it helps us tremendously, as we cannot be everywhere and are not always aware of all of the things that need attention.

Late summer is the time that our road construction projects start. Once we have those numbers, the board will sit and discuss a fix and make any changes necessary. We will continue to offer the hours we currently have.

In closing, we are still looking for a second full time road worker (CDL required). We offer some benefits, and the pay is negotiable with prior experience. Please contact any board member or Tressa Votis for more info.

There is also a special use permit meeting Aug 11th at 6 p.m. over a proposed non-metallic mine (gravel pit) in the township. If you have any questions or concerns, please attend. As a reminder, the board meets every second Monday of the month at 6pm and all are welcomed. I hope you all enjoy the rest of your summer and think rain!

## Baldwin, Grassley introduce legislation to protect American farmers and rural communities from foreign investors

WASHINGTON, D.C. – Today, U.S. Senators Tammy Baldwin (D-WI) and Chuck Grassley (R-IA) introduced the Farmland Security Act to increase scrutiny over foreign investments in American agricultural land. The legislation ensures that the American people and Congress can address the impacts foreign investments have on family farms, rural communities, and the domestic food supply.

"I am proud to advocate for our agriculture industry by introducing the American Farmland Security Act," said Senator Baldwin. "This bipartisan legislation will provide the tools we need to protect the longevity of American family farm operations for generations to come."

"I've been sounding the alarm on the increase in foreign-own farmland for decades and was the original author of the Agriculture Foreign Investment Disclosure Act. Foreign buyers, especially those backed by governments like China, buying up prime farmland here in the U.S. raises serious national security concerns – and the American people have a right to know about it. By requiring the USDA to report these purchases in real-time, we can keep better track of the impact these acquisitions could have on our rural communities. The Farmland Security Act will also help protect domestic food production and our national security interests," Grassley said.

The Agricultural Foreign Investment Disclosure Act requires foreign entities to disclose their purchases of American agricultural land. Current reporting shows that foreign-owned agricultural acreage has nearly doubled in the past decade, however, the data that has been collected is incomplete and inaccurate. In fact, investigators estimate that the foreign ownership of land is nearly double current figures.

To protect American farmers, rural communities, and our food supply chains, the Farmland Security Act includes the following provisions:

- The Secretary shall report to Congress on foreign investments in agricultural land in the United States, including the impact foreign ownership has on family farms, rural communities, and the domestic food supply.
- The Secretary shall publish all prior year disclosures of foreign investments in agricultural land in the United States on an interactive public USDA database and have real time updates to the database as disclosures are filed.

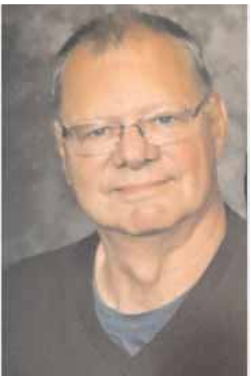

### What to know about Hepatitis and the current outbreak

WAUSAU, Wis. – The world is currently facing a new outbreak of unexplained acute hepatitis infections affecting children. According to the World Health Organization, this year between April 5 and May 26, 650 probable cases of acute hepatitis have been reported in children from 33 countries.

This new outbreak has brought attention to the thousands of acute viral hepatitis infections that occur among children, adolescents and adults every year. Most acute hepatitis infections cause mild disease and often can go undetected; however, in some cases these viruses can lead to complications and be fatal.

World Hepatitis Day is observed each year on July 28 to raise awareness of viral hepatitis. Hepatitis is inflammation of the liver, a vital organ that processes nutrients, filters the blood, and fights infections. Heavy alcohol use, exposure to toxins, some medications, and certain medical conditions can cause hepatitis. However, hepatitis is often caused by a virus. According to the Center for Disease Control (CDC), the most common types of viral hepatitis in the United States are hepatitis A, B and C.

- Hepatitis A can be spread through sexual contact or through food or drinking water that is carrying the virus through bits of fecal matter from an infected person. This form of hepatitis does not lead to a chronic infection and usually has no complications. The liver usually heals from hepatitis A within several months.

- Hepatitis B is the leading cause of liver cancer and it is estimated that 850,000 people in the United States are currently living with it. Hepatitis B spreads through contact with blood, semen or other body fluids from an infected person. This viral infection can range from a mild illness, lasting a few weeks, to a serious, life-long (chronic) condition.

- Hepatitis C is the most common in the United States, affecting an estimated 2.4 million people, with 50 percent unaware they are infected. The virus is transmitted through needles or syringes, blood transfusions and through birth from the mother. More than 50 percent of people who get infected develop a chronic infection.

Both Hepatitis A and B have vaccines and are administered during infancy or before the age of two. Unfortunately, Hepatitis C does not have a vaccine at this time.

Hepatitis symptoms include a fever, fatigue, loss of appetite, nausea, vomiting, abdominal pain, dark urine, light-colored stools, joint pain, and jaundice.

Most people recover from hepatitis, and the disease is often preventable. However, it is still considered a serious health risk because it can destroy liver tissue, spread easily, weaken the immune system, cause liver failure or cancer, and in rare cases, death.

"There are many ways you can reduce your chances of getting hepatitis," says Aspirus Regional Director of Hospital Medicine Dr. Stephen Phillipson. "Get available vaccines, practice protective sex, don't share needles, practice good hand hygiene, don't share personal care items, take precautions when getting tattoos/piercings and when traveling to areas of the world with poor sanitation."

Although the current hepatitis outbreak does not appear to belong to any of the known hepatitis viruses, according to the World Health Organization (WHO), it is still important to be proactive against the virus.

### WI DMV extends hours ahead of primary. Steps to obtain an ID to vote explained

The Wisconsin Department of Transportation Division of Motor Vehicles (DMV) will extend hours next week at customer service centers that are open on Monday (August 8) and/or Tuesday (August 9). These centers will remain open until 6 p.m. The extended hours will enable those needing a photo ID, frequently those who are new to the state, time to visit a DMV.

Most Wisconsin voters already have some form of ID to show at the polls, including a Wisconsin driver license or ID. There is no separate "voter ID" and a federally compliant REAL ID card is not required for voting purposes. The Wisconsin Elections Commission explains the acceptable options to bring to the polls on its website.

#### Steps to obtain an ID to vote

Anyone without the required identification to vote may obtain an ID free from the DMV. Voters looking to get their first Wisconsin ID should begin at DMV's website [wisconsinidmv.gov/idcards](http://wisconsinidmv.gov/idcards).

Next, bring the required documents to apply at your nearest DMV. Certain documents, such as a birth certificate, proof of identity and Wisconsin residency, are necessary to obtain an official Wisconsin ID card. If all documentation is not readily available, the ID Petition Process (IDPP) may be used to obtain a receipt valid for voting while the remaining documents or verifications are obtained. The voter should bring any documentation available to the DMV and complete the required application.

Finally, a receipt valid for voting purposes will be provided and may be used to show at the polls.

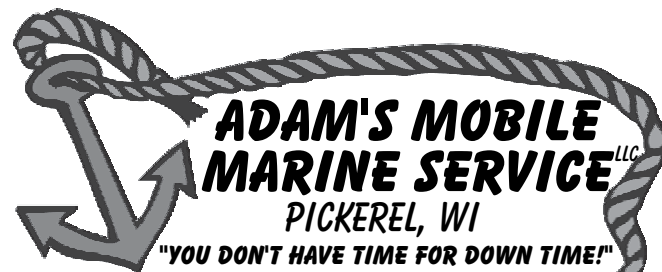

**ANNUAL NOTICE OF SPECIAL EDUCATION REFERRAL AND EVALUATION PROCEDURES**

Upon request, the School District of Wabeno Area is required to evaluate a child for eligibility for special education services. A request for evaluation is known as a referral. When the district receives a referral, the district will appoint an Individualized Education Program (IEP) team to determine if the child has a disability, and if the child needs special education services. The district locates, identifies, and evaluates all children with disabilities who are enrolled by their parents in private (including religious) schools, elementary schools and secondary schools located in the school district.

A physician, nurse, psychologist, social worker, or administrator of a social agency who reasonably believes a child brought to him or her for services is a child with a disability has a legal duty to refer the child, including a homeless child, to the school district in which the child resides. Before referring the child, the person making the referral must inform the child's parent that the referral will be made.

Others, including parents, who reasonably believe a child is a child with a disability, may also refer the child, including a homeless child, to the school district in which the child resides.

Referrals must be in writing and include the reason why the person believes the child is a child with a disability. A referral may be made by contacting Robert Tucker, Director of Pupil Services, School District of Wabeno Area, at 715.473.1212, or by writing him at P.O. Box 460, Wabeno, WI 54566.

**NOTICE OF SPECIAL NEEDS SCHOLARSHIP PROGRAM**

This notice serves to inform parents and guardians of students with disabilities that the State of Wisconsin has established the Special Needs Scholarship Program. Under this scholarship program and as further specified in state law, a child with a disability who has been denied the opportunity to attend a nonresident school district under the full-time open enrollment program may be eligible to receive a scholarship from the Department of Public Instruction (DPI) that allows the child to attend an eligible private school that is participating in the Special Needs Scholarship Program.

This is a state-administered program. A parent or guardian who is interested in the Special Needs Scholarship Program should independently verify the participating private schools and the specific terms, eligibility criteria, and application procedures of the scholarship program with the DPI.

The Special Needs Scholarship Program is further defined under section 115.7915 of the state statutes. However, special eligibility requirements not found in that statute exist for program scholarships that are awarded for private school attendance that initially begins in the 2022-2023 school year. **ACCESS TO PUBLIC RECORDS**

The Board of the School District of Wabeno Area shall allow persons to have access to school district records in accordance with this policy and implementing procedures and in accordance with the law.

The District Administrator is designated as the legal custodian of records. The legal custodian shall safely keep and preserve records of the authority and shall have full legal power to render decisions and carry out duties related to those records maintained by any school district authority. The legal custodian may deny access to records only in accordance with the law.

Public records may be inspected, copied and/or abstracted at any time during the established District Office hours, which are from 8:00 A.M. to 4:00 P.M., Monday through Friday. The legal custodian may establish fees for services in accordance with the law. A list of fees is available at the District Office.

**STUDENT RECORDS**

Student records are maintained to assist students, parents, guardians, and the school in achieving the student's educational goals. Such records are accumulated, maintained, released, transferred, and eventually destroyed by the building principal or his/her designee in accordance with state and federal law. Only those individuals or agencies specifically authorized by state and federal law shall be granted access to a student's records.

The School District does forward records to other schools that have requested the records and in which the student seeks or intends to enroll, or is already enrolled, as long as the disclosure is for purposes related to the student's enrollment or transfer.

An adult student or the parent/guardian of a minor student may inspect the student's records in accordance with administrative policy and established procedures and may challenge the content if he/she believes the records are inaccurate or misleading. Such a complaint would be filed with the building principal. If not satisfied with the decision, an appeal avenue is available through the Family Policy and Regulations Office of the U.S. Department of Education.

**TEACHER LICENCE**

Students taking courses through the Start College Now Program can enroll in courses during the fall and/or spring semesters.

The Early College Credit Program is available for students who have completed 8th grade and successfully completed Algebra 1. Students who meet the eligibility criteria may take courses through the UW System of a private, non-profit institution of higher education. Students taking courses through Early College Credit Program may take courses during the summer, fall and/or spring semesters.

To participate in either the Start College Now Program or the Early College Credit Program, qualifying students must submit the required paperwork to Mrs. Rocolle by October 1, 2022 to enroll for the Spring 2023 semester. Students interested in Fall 2023 courses must submit paperwork by March 1, 2023. For planning purposes, if you are interested in pursuing one of these programs in the next year, please notify Mrs. Rocolle via phone 715.473.2592 ext. 1210 or e-mail [mrocole@wabeno.k12.wi.us](mailto:mrocole@wabeno.k12.wi.us) by September 20, 2022. ## School District of Wabeno Area ANNUAL NOTICE - HOMELESS CHILDREN

The McKinney-Vento Act defines children and youth who are homeless (twenty-one years of age and younger) as:

- \* Children and youth who lack a fixed, regular, and adequate nighttime residence, and includes children and youth who are:
  - sharing the housing of other persons due to loss of housing, economic hardship, or a similar reason (sometimes referred to as double-up);
  - living in motels, hotels, trailer parks, or camping grounds due to lack of alternative adequate accommodations;
  - living emergency or transitional shelters;
  - abandoned in hospitals;
  - awaiting foster care placement;
- \* Children and youth who have a primary nighttime residence that is a public or private place not designated for, or ordinarily used as, a regular sleeping accommodation for human beings.
- \* Children and youth who are living in cars, parks, public spaces, abandoned buildings, substandard housing, bus or train stations, or similar settings.
- \* Migratory children who qualify as homeless because they are living in circumstances described above.

If you are personally aware of or are acquainted with any children who may qualify according to the above criteria, the School District of Wabeno Area provides the following assurances to parents of homeless children:

- \* Local school district staff member (liaison) to assist homeless children/families:

- \* There shall be immediate enrollment and school participation, even if educational and medical records and proof of residency are not available.
- \* All educational opportunities and related opportunities for homeless students (preschool to age 21), including unaccompanied youth, shall be the same as for the general student population.
- \* Enrollment and transportation rights, including transportation to the school of origin. "School of origin" is defined as the school the child or youth attended when permanently housed or the school in which the child or youth was last enrolled.
- \* Written explanation of a child or youth's school placement, other than school of origin or the school requested by the parent, with the right to appeal within the local dispute resolution process.
- \* Meaningful opportunities for parents to participate in the education of their children. These shall include: special notices of events, parent-teacher conferences, newsletters, and access to student records. ### SCHOOL DISTRICT OF WABENO AREA CONFIDENTIALITY OF PERSONALLY IDENTIFIABLE INFORMATION OBTAINED THROUGH CHILD FIND ACTIVITIES

The School District of Wabeno Area is required to locate, identify, and evaluate all children, with disabilities, including children with disabilities attending private schools in the school district, and homeless children. The process of locating, identifying, and evaluating children with disabilities is known as Child Find. This agency conducts the following child find activities each year during Early Childhood Developmental Days. This notice informs parents of the records the school district will develop and maintain as part of its child find activities. This notice also informs parents of their rights regarding any records developed.

The school district gathers personally identifiable information on any child who participates in child find activities. Parents, teachers, and other professionals provide information to the school related to the child's academic performance, behavior, and health. This information is used to determine whether the child needs special education services. Personally identifiable information directly related to a child and maintained by the school is a pupil record. Pupil records include records maintained in any way including, but not limited to, computer storage media, video and audiotape, film, microfilm, and microfiche. Records maintained for personal use by a teacher and not available to others and records available only to persons involved in the psychological treatment of a child are **not** pupil records.

**The school district maintains several classes of pupil records.**

- "Progress records" include grades, courses the child has taken, the child's attendance record, immunization records, required lead screening records, and records of school extra-curricular activities. Progress records must be maintained for at least five years after the child ceases to be enrolled.
- "Behavioral records" include such records as psychological tests, personality evaluations, records of conversations, written statements relating specifically to the pupil's behavior, tests relating specifically to achievement or measurement of ability, physical health records other than immunization and lead screening records, law enforcement officers' records, and other pupil records that are not "progress records." Law enforcement officers' records are maintained separately from other pupil records. Behavioral records may be maintained for no longer than one year after the child graduates or otherwise ceases to be enrolled, unless the parent specifies in writing that the records may be maintained for a longer period of time. The school district informs parents when pupil records are no longer needed to provide special education. At the request of the child's parents, the school district destroys the information that is no longer needed.
- "Directory data" includes the student's name, address, telephone listing, date and place of birth, major field of study, participation in officially recognized activities and sports, weight and height of members of athletic teams, dates of attendance, photographs, degrees and awards received, and the name of the school most recently previously attended by the student.
- "Pupil physical health records" include basic health information about a pupil, including the pupil's immunization records, an emergency medical card, a log of first aid and medicine administered to the pupil, an athletic permit card, a record concerning the pupil's ability to participate in an education program, any required lead screening records, the results of any routine screening test, such as for hearing, vision or scoliosis, and any follow-up to the test, and any other basic health information, as determined by the state superintendent. Any pupil record relating to a pupil's physical health that is not a pupil physical health record is treated as a patient health care record under sections 146.81 to 146.84, Wisconsin Statutes. Any pupil record concerning HIV testing is treated as provided under section 252.15, Wisconsin Statutes.

**The Family Educational Rights and Privacy Act (FERPA), the Individuals with Disabilities Education Act (IDEA), and section 118.125, Wisconsin Statutes, afford parents and students over 18 years of age ("eligible students") the following rights with respect to education records:**

- **The right to inspect and review the student's education records within 45 days of receipt of the request.** Parents or eligible students should submit to the school principal [or appropriate school official] a written request that identifies the records(s) they wish to inspect. The principal will make arrangements for access and notify the parent or eligible student of the time and place where the records may be inspected. The school district will comply with the request without unnecessary delay and before any meeting about an individualized education program, or any due process hearing, and in no case more than 45 days after the request has been made. If any record includes information on more than one child, the parents of those children have the right to inspect and review only the information about their child or to be informed of that specific information. Upon request, the school district will give a parent or eligible student a copy of the progress records and a copy of the behavioral records. Upon request, the school district will give the parent or eligible student list of the types and locations of education records collected, maintained, or used by the district for special education. The school district will respond to reasonable requests for explanations and interpretations of the records. A representative of the parent may inspect and review the records.
  - **The right to request the amendment of the student's education records that the parent or eligible student believes is inaccurate or misleading.** Parents or eligible students may ask the School District of Wabeno Area to amend a record that they believe is inaccurate or misleading. They should write the school principal, clearly identify the part of the record they want changed, and specify why it is inaccurate or misleading. If the district decides not to amend the record, the district will notify the parent or eligible student of the decision and the right to a hearing regarding the request for amendment. Additional information regarding the hearing procedures will be provided to the parent or eligible student when notified of the right to a hearing.
  - **The right to consent to disclosures of personally identifiable information in the student's education records, except to the extent that federal and state law authorize disclosure without consent.** The exceptions are stated in 34 CFR 99.31, Family Educational Rights and Privacy Act regulations; Sec. 9528, PL107-110, Every Student Succeeds Act (ESSA); and section 118.125(2)(a) to (m) and sub. (2m), Wisconsin Statutes. One exception that permits disclosure without consent is disclosures to school officials with legitimate educational interests. A school official is a person employed by the district as an administrator, supervisor, instructor, or support staff member (including health or medical staff and law enforcement unit personnel); a person serving on the school board; a person or company with whom the district has contracted to perform a special task (such as an attorney, auditor, medical consultant, or therapist); or a parent or student serving on an official committee, such as a disciplinary or grievance committee, or assisting another school official in performing his or her tasks. A school official has a legitimate educational interest if the official needs to review an education record in order to fulfill his or her professional responsibility. Upon request, the district discloses education records without consent to officials of another school district in which a student seeks or intends to enroll. Also the district discloses "directory data" without consent, unless the parent notifies the district that it may not be released without prior parental consent.
  - **The right to file a complaint with the U.S. Department of Education concerning alleged failure by the District to comply with requirements of FERPA.** The name and address of the Office that administers FERPA is: Family Policy Compliance Office, U.S. Department of Education, 400 Maryland Avenue, S.W., Washington, DC 20202-4605.

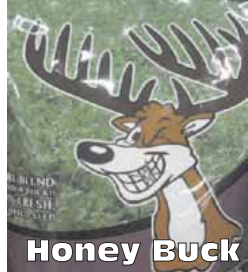

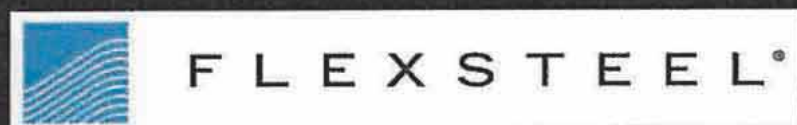
