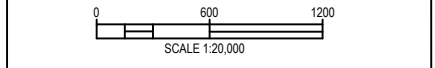

WITHIN THAT RED LINE, SEVEN SEPARATE LOCATIONS ARE THE SUBJECT OF THIS PLANNING APPLICATION TO CORK COUNTY COUNCIL. (THESE ARE LABELLED AS AREA 1, 2, 3, 4, 5, 6 AND 7). THE REMAINING AREAS WITHIN THE RED LINE ARE THE SUBJECT OF AN APPLICATION FOR LEAVE TO APPLY FOR SUBSTITUTE CONSENT TO AN BORD PLEANÁLA REFERENCE 302837-18. THE GRID CONNECTION PLANNING APPLICATION BOUNDARY ENCOMPASSING BOTH THE APPLICATIONS, TO CORK COUNTY COUNCIL AND AN BORD PLEANÁLA, IS BEING SHOWN WITHIN ONE SOLID RED LINE SO AS TO GIVE A FULL UNDERSTANDING TO THE PUBLIC OF THE PLANNING STATUS OF ALL ASPECTS OF THE GRID CONNECTION.
