DYMA HYSBYSIAD bod Cyngor Bwrdeistref Sirol Rhondda Cynon Taf yn bwriadu gwneud Gorchymyn o dan Adrannau 1, 2, 4, 81, 82, 83 a 84 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984 ("y Ddeddf"), ar ôl ymgynghori â Phrif Swyddog yr Heddlu yn unol ag Adran 23(2)(a) o'r Ddeddf honno, ac wedi hysbysu Llywodraeth Cymru mewn ysgrifen, a phob pŵer galluogi arall, a'i effaith fydd:

1. Amrywio'r Gorchymyn Rheoleiddio Traffig wedi'i nodi yn Atodlen 1
2. Cyflwyno gwaharddiadau aros ar y ffyrdd sydd wedi'u nodi yn Atodlen 2
3. Cyflwyno terfyn cyflymder o 20 mya ar y ffyrdd sydd wedi'u nodi yn Atodlen 3
4. Sefydlu Croesfan Sebra i Gerddwyr ar y lleoliad sydd wedi'i bennu yn Atodlen 4

6. Gosod cyffordd wedi'i chodi yn y lleoliad a nodwyd yn Atodlen 6.

1. Bydd "Gorchymyn Cydgrynhau (Gwahardd a Chyfyngu ar Aros a Llwytho a Mannau Parcio ar ochr y Ffordd) Cyngor Bwrdeistref Sirol Rhondda Cynon Taf 2012" yn cael ei amrywio, sy'n golygu bydd:
 - a. "Gorchymyn Cyngor Bwrdeistref Sirol Rhondda Cynon Taf (Strydoedd Amrywiol, Tonpentre) (Dim Aros ar Unrhwy Adeg a Phart 20mya) 2009" yn cael ei amrywio trwy dynnu eitem 3 yn ei chyfarwydd o Atodlen 2
 - b. "Gorchymyn 1994 Cyngor Sir Morgannwg Ganol (Stryd Bailey, Tonpentre) (Dim Aros)" yn cael ei amrywio trwy dynnu eitem (ii) yn ei chyfarwydd o'r Atodlen
 - c. "Gorchymyn 1972 Cyngor Rhondda Cynon Taf (Stryd yr Eglwys, Tonpentre, Heol y Gelli, Gelli) (Cyfyngiadau Aros)" yn cael ei amrywio trwy dynnu'r rhannau o'r ffordd a gyfeirir atyn nhw yn eitemau (i) a (ii) yn atodlen 2

ATODLEN 2 – Gwahardd Aros ar Unrhwy Adeg

1. Ochr ogledd-orllewinol Heol yr Eglwys (B4223), Tonpentre, o gyferbyn â phwynt sydd 5 metr i'r gogledd-ddwyrain o'r ffin gyffredin rhwng rhif 1 Llys Elias ac Eglwys Gynulleidfaol Lloegr, Ystrad, i'r gogledd-ddwyrain am bellter o oddeutu 51 metr
2. Ochr dde-ddwyreiniol Heol yr Eglwys (B4223), Tonpentre, o bwynt sydd 5 metr i'r gogledd-ddwyrain o'r ffin gyffredin rhwng rhif 1 Llys Elias a'r Eglwys Gynulleidfaol Lloegr, Ystrad, i'r gogledd-ddwyrain am bellter o oddeutu 70 metr
3. Ochr ogledd-ddwyreiniol Stryd Bailey, Tonpentre, o'i chyffordd â Heol yr Eglwys (B4223) i ochr dde-ddwyreiniol y lôn ddienw sydd ochr yn ochr ag Eglwys loan Fedyddiwr a rhif 80, i'r gogledd-orllewin am bellter o oddeutu 48 metr
4. Ochr ogledd-orllewinol y ffordd ddienw gyferbyn ag Eglwys loan Fedyddiwr, Tonpentre, o'i chyffordd â Stryd Bailey, tua'r gogledd-ddwyrain; bellter o oddeutu 17 metr
5. Ochr dde-ddwyreiniol y ffordd ddienw gyferbyn ag Eglwys loan Fedyddiwr, Tonpentre, o'i chyffordd â Stryd Bailey, tua'r gogledd-ddwyrain am bellter o oddeutu 13 metr
6. Ochr dde-orllewinol Stryd yr Eglwys, Tonpentre, o'i chyffordd â Heol yr Eglwys (B4223), tua'r de-ddwyrain am bellter o oddeutu 14 metr
7. Ochr ogledd-orllewinol Y Rhodfa, Tonpentre, o'i chyffordd â Heol y Maendy (B4223), tua'r de-orllewin am bellter o oddeutu 18 metr
8. Ochr dde-ddwyreiniol y Rhodfa, Tonpentre, o'i chyffordd â Heol y Maendy (B4223) i bwynt sydd 2 fetr i'r de-ddwyrain o'r ffin gyffredin rhwng Gorsaf Heddlu De Cymru a'r llys

ATODLEN 3 – Terfyn cyflymder 20 mya

1. Heol y Maendy (B4223), Tonpentre yn ei chyfanrwydd
2. Tyddyn y Maendy, Tonpentre yn ei chyfanrwydd
3. Cilgant y Maendy (B4223), Tonpentre, o'i chyffordd â'r Rhodfa i bwynt sydd 63 metr i'r gogledd-orllewin o'r ffin gyffredin rhwng Rhif 25 a 26 am bellter o oddeutu 336 metr.

ATODLEN 4 - Croesfan sebra

1. I'w sefydlu ar Heol y Maendy (B4223), Tonpentre ar bwynt sydd 9 metr i'r gogledd-orllewin o ffin orllewinol Rhif 1 Heol y Maendy.



PEDESTRIAN CROSSING NOTICE 2021 (TRAFFIC CALMING MEASURES) NOTICE 2021

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose to make an Order under Sections 1, 2, 4, 81, 82, 83 and 84 of the Road Traffic Regulation Act 1984 ("the Act"), after consultation with the Chief Officer of Police in accordance with Section 23(2)(a) of the said Act and having notified the Welsh Government in writing, proposes the following and of all other enabling powers, the effect of which will be to:

1. Vary the Traffic Regulation Order specified in Schedule 1
2. Introduce waiting restrictions on the roads identified in Schedule 2
3. Introduce a 20mph speed limit on the roads identified in Schedule 3
4. Establish a Zebra Pedestrian Crossing at the location specified in Schedule 4

NOTICE IS HEREBY GIVEN that the Rhondda Cynon Taff County Borough Council propose under Sections 90A, 90C and 90G of the Highways Act 1980, the Highways (Road Humps) Regulations 1999 and the Highways (Traffic Calming) Regulations 1999 and all enabling powers, to implement the following traffic calming measures:

5. Speed Cushion (between 25mm-100mm in height, 1900mm wide and 2500mm long), to be provided in groups of two at, or within the vicinity of the locations specified in Schedule 5
6. Raised junction to be provided at the location specified in Schedule 6

SCHEDULE 1 – Variation

1. The "Rhondda Cynon Taff County Borough (Prohibition and restriction of Waiting and Loading and On Street Parking Places) Consolidation Order 2012" shall be varied so that the orders referred to as:
 - a. The "Rhondda Cynon Taff County Borough (Various Streets, Ton Pentre) (Prohibition of Waiting At Any Time and 20mph Zone) Order 2009" shall be varied by removal of item 3 from Schedule 2 in its entirety
 - b. The "Mid Glamorgan County Council (Bailey Street, Ton Pentre) (Prohibition of Waiting) Order 1994" shall be varied by removal of item (ii) from the Schedule in its entirety
 - c. The "Rhondda Borough Council (Church Street, Ton Pentre and Gelli Road, Gelli) (Restriction of Waiting) Order 1972" shall be varied by removal of the lengths of road specified in items (i) and (ii) from schedule 2

SCHEDULE 2 – Prohibition of Waiting At Any Time

1. The north-western side of Church Road (B4223), Ton Pentre, from opposite a point 5 metres north-east of the common boundary between number 1 Elias Court and Ystrad English Congregational Church, north-eastwards for a distance of approximately 51 metres
2. The south-eastern side of Church Road (B4223), Ton Pentre, from a point 5 metres north-east of the common boundary between number 1 Elias Court and Ystrad English Congregational Church, north-eastwards for a distance of approximately 70 metres
3. The north-eastern side of Bailey Street, Ton Pentre, from its junction with Church Road (B4223) to the south-eastern side of an unadopted lane running alongside St. John the Baptist Church and number 80, north-westwards a distance of approximately 48 metres
4. The north-western side of the unnamed road opposite St. John the Baptist Church, Ton Pentre, from its junction with Bailey Street, north-eastwards a distance of approximately 17 metres
5. The south-eastern side of the unnamed road opposite St. John the Baptist Church, Ton Pentre, from its junction with Bailey Street, north-eastwards a distance of approximately 13 metres
6. The south-western side of Church Street, Ton Pentre, from its junction with Church Road (B4223), south-eastwards for a distance of approximately 14 metres
7. The north-western side of The Parade, Ton Pentre, from its junction with Maindy Road (B4223), south-westwards for a distance of approximately 18 metres
8. The south-eastern side of The Parade, Ton Pentre, from its junction with Maindy Road (B4223) to a point 2 metres south-east of the common boundary between South Wales Police Station and courthouse

SCHEDULE 3 – 20MPH Speed Limit

1. Maindy Road (B4223), Ton Pentre in its entirety
2. Maindy Croft, Ton Pentre in its entirety
3. Maindy Crescent (B4223), Ton Pentre, from its junction with The Parade to a point 63 metres north west of the common boundary between No. 25 and 26, a distance of approximately 336 metres

SCHEDULE 4 – Zebra Crossing

1. To be established on Maindy Road (B4223), Ton Pentre at a point 9 metres north west of the western boundary of No. 1 Maindy Road

SCHEDULE 5 – Speed Cushions


Speed Cushions in groups of two, at or within the vicinity of the following locations:

1. **Maindy Road (B4223), Ton Pentre**
 - a. Opposite the common boundary of No. 3 and 4
 - b. Opposite the common boundary of No. 16 and 17
 - c. Opposite the common boundary of No. 26 and 27
2. **Maindy Crescent (B4223), Ton Pentre**
 - a. Opposite the common boundary of No. 4 and 5
 - b. Opposite the common boundary of No. 16 and 17
 - c. Opposite the common boundary of No. 27 and 28
 - d. 40 metres north-west of the common boundary between No. 25 and 26

SCHEDULE 6 – Raised Junction

1. Church Road (B4223), Ton Pentre between its junction with Bailey Street, Church Street and the unnamed road opposite St John the Baptist Church
