



## **Herzliya Conference Speakers and Members Of board**

Prof. **Israel (Robert) J. Aumann** Professor Emeritus of Mathematics at the Hebrew University of Jerusalem and a member of the university's Center for the Study of Rationality. Recipient of the Nobel Prize in Economics for 2005. Has been a guest lecturer and researcher with leading academic institutions including Yale, Stanford and Princeton Universities. Holds a Ph.D. in Mathematics from the Massachusetts Institute of Technology.

Maj. Gen. (res.) Yaakov Amidror Head of the Defensible Borders Project and the Institute for Contemporary Affairs at the Jerusalem Center for Public Affairs. Vice President of the Lander Institute, Jerusalem. Former Commander of the IDF's Military Colleges. Served in the IDF for thirty-six years in positions including Head of the Research and Assessment division, with special responsibility for preparing the National Intelligence Assessment, and Military Secretary to the Minister of Defense. Author of two books on intelligence.

Prof. **Uzi Arad** Founding Head of the Institute for Policy and Strategy at the Lauder School of Government, Diplomacy and Strategy, the Interdisciplinary Center Herzliya. Chair of the Herzliya Conference. Concurrently, Advisor to the Knesset Foreign Affairs and Defense Committee. Served in the Mossad for twenty-five years holding senior positions in Israel and abroad, his last position being Director of Intelligence, after which he was appointed Foreign Policy Advisor to Prime Minister Benjamin Netanyahu. Prior to his government career, he was a Professional Staff Member with the Hudson Institute in New York, and a Fellow at the New York Council on Foreign Relations and with Tel Aviv University's Center for Strategic Studies. Received an M.A. and a Ph.D. in International Relations from Princeton University, which he attended as a Fulbright scholar. Participated in advanced executive courses at Harvard University. Serves on the boards of several academic institutions and as an advisor to the Posen Foundation.

Prof. **Arie Arnon** Professor of Economics at Ben-Gurion University and Head of the Program on Economics and Society at the Van Leer Jerusalem Institute. Areas of research include macroeconomics, monetary theory, history of economic thought, and the political economy of the Israeli-Palestinian conflict. He was a visiting scholar and professor at Berkeley, Stanford, Penn, the New School and SOAS. Additional positions have included Senior Economist in the Research Department of the Bank of Israel and Chair of the Department of Economics at Ben-Gurion University.

Dr. **Faisal Azaiza** Head of the Jewish-Arab Center and the Gustav Heinemann Institute for Middle Eastern Studies at Haifa University. Member of the Council for Higher Education. Previously, served as Mayor of Daburiya Municipality and as Director of "*Sikkuy*," the Association for the Advancement of Equal Opportunity between Arabs and Jews in Israel. Has published extensively on his areas of research. Holds Ph.D. in Social Work from the Hebrew University of Jerusalem.

**Shula Bahat** Associate Executive Director of the American Jewish Committee, responsible for AJC's organizational development and management, leadership development and training programs. Former Director of Israeli Programs in American and Canadian Universities for the Israeli Students and Academicians Organization in the U.S. and Canada. Also served as a career officer in the IDF as Executive Director of the Sociological and Psychological Research Division, Operations Officer for the Gadna-Youth Corps, and Education Welfare and Women's Officer for the Jerusalem Division. Holds an M.A. in Environmental Studies from the Technion, the Israel Institute of Technology.

Dr. **Shmuel Bar** Senior Research Fellow at the Institute for Policy and Strategy, Interdisciplinary Center Herzliya. Served in the Israeli intelligence community for thirty years where he held senior analytical, planning, and diplomatic positions, specializing in regional security, Islamic radicalism and terrorism in the Middle East and East Asia. Published a number of books and articles in his areas of expertise. Received a Ph.D. in History of the Middle East from Tel Aviv University.

**Nir Barkat** Councilor of the Municipality of Jerusalem. Founding partner of BRM Group and of the venture capital fund BRM Capital, and founding member of the Israel Venture Network. Founder and Vice-Chairman of StartUp Jerusalem, a non-profit organization. Graduate of the Hebrew University of Jerusalem in Computer Science.

Prof. **Amir Barnea** Professor of Finance at the Arison School of Business, Interdisciplinary Center Herzliya, and former Dean of the School. Professor Emeritus at Tel Aviv University. Deputy Chairman of the Board and CEO, Singer

Barnea & Co. Held Visiting Professorships at several leading institutions, including Cornell and New York Universities. Serves in several senior positions in Israeli business institutions, as well as on the public committees of the Bank of Israel and the Ministry of Finance. Received a Ph.D. in Finance and Managerial Economics from Cornell University. Member of the Board of Directors, the Institute for Policy and Strategy, the Interdisciplinary Center Herzliya.

Prof. **Moshe Barniv** Professor at the Radzyner Law School at the Interdisciplinary Center Herzliya, where he also served as Dean. Additionally lectures in the School of Management and the Faculty of Law at Bar Ilan University. Practices law, specializing in business and economic law and technology. Past positions include Head of the Program in Law and Management at Bar Ilan University, lecturer at Hebrew and Tel Aviv Universities, Visiting Scholar at Harvard University and Visiting Professor at Boston University. Formerly, a founder and manager of Yeda Computers Ltd, and a partner in M. Druker Law Firm. Recipient of the Recanati Graduate School of Management Best Research Award for 1995, along with Prof. D. Samet. Holds a Ph.D. in Law from Tel Aviv University. Member of the Board of Directors, the Institute for Policy and Strategy, the Interdisciplinary Center Herzliya.

Dr. **Sean Barrett** Member of the Economics Department at Trinity College since 1970. He has been an external examiner at the University of Ulster at Coleraine and at Loughborough University. Served as a director of the Irish Tourist Board and as a member of the Culliton Review of Industrial Policy. Was both an advocate and analyst of airline deregulation in Ireland and the wider European market. Served as a member of the board of the Journal of Air Transport Management, and has participated in European Science Foundation transport research programs. Holds a Ph.D. from the National University of Ireland.

**Avinoam Bar-Yosef** Director-General of the Jewish People Policy Planning Institute. Previously, Senior Advisor to the Chair of the Jewish Agency for Israel. Prior to his involvement in the Jewish Agency, served as Bureau-Chief for *Ma'ariv* daily newspaper in Washington, D.C., and as its chief diplomatic correspondent. He was a visiting fellow at the Washington Institute for Middle East Policy, and was on the Israeli negotiating team at the Wye Plantation summit.

Prof. **Yehuda Bauer** Academic Advisor to Yad Vashem and member of the Israeli Academy of Sciences and Humanities. Serves as an advisor to international forums for national commemoration. Previously held the positions of Chair of the International Institute for Holocaust Research at Yad Vashem, Founding Chair of the Vidal Sassoon International Center for the Study of Anti-Semitism at the Hebrew University of Jerusalem, and Academic Chair of the Institute of Contemporary Jewry. Published numerous books and articles about the Holocaust. Holds a Ph.D. in History from the Hebrew University of Jerusalem.

Prof. **Gabriel Ben-Dor** Professor of Political Science and Director of the National Security Studies Center, University of Haifa. Also served as the Rector of the University and as President of the Israeli Political Science Association. Published seven books and over one hundred articles on Middle East politics, civic-military relations, conflict resolution, and ethnic politics. Received a Ph.D. in Political Science and Middle Eastern Studies from Princeton University.

Maj. Gen. (res.) **Eitan Ben-Eliyahu** CEO of Sentry Technology Group, a defense technology firm, and former Commander of the Air Force. Graduate of Tel Aviv University in Strategic Studies and International Relations.

Maj. Gen. (res.) Prof. Isaac Ben-Israel Head of the Program for Security Studies at Tel Aviv University, lecturer at the Cohen Institute for the History and Philosophy of Sciences and Ideas, and Head of the Curiel Center. Additionally, heads the Tel Aviv Workshop for Science, Technology and Security. Served in the IDF for over thirty years, holding several posts in operations, intelligence and weapon development units of the Air Force. Served as Head of Military R&D in the IDF and as Director of Defense R&D Directorate in the Ministry of Defense. He has written numerous books and articles on military and security issues and received several awards, including twice the Israel Defense Award. Holds a Ph.D. in Philosophy from Tel Aviv University.

**Zeev Bielski** Chairman of the Executive of the Jewish Agency for Israel and the World Zionist Organization. Former Mayor of Ra'anana. Dealt extensively with the development of relations between Israel and Jewish communities in the Diaspora as Chair of the Israeli Forum and Head of the JAFI Aliyah Department in South Africa. Holds a B.A. in Economics from the Hebrew University of Jerusalem.

Prof. **Gideon Biger** Professor of Geography at Tel Aviv University. Chairperson of the Israeli Military History Association. Served as a member of the committee to determine borders in the Israeli-Syrian and Israeli-Palestinian peace talks, as well as of the committee to determine the municipal borders of Jerusalem. He was a visiting professor at a number of universities in the United States and Australia. Published several books and articles in Israel and abroad on the subject of the historical geography of Israel. Earned a Ph.D. in Geography from the Hebrew University of Jerusalem.

**Avraham Bigger** Deputy Chair of the Caesarea Edmond Benjamin de Rothschild Foundation, owner and CEO of Bigger Investments, Chairman of Supersal, and Chair and co-owner of Kaniel Industries. Board member of several companies and organizations including Bank Leumi, the Strauss Group, and Partner Communications. Former CEO and Director of Paz Oil, Menorah Insurance, and the General Bank of Israel (Bank Clali). Before joining the private sector, he was with the Budget Division of the Ministry of Finance. Received an MBA from the Hebrew University of Jerusalem. Member of the Board of Directors, the Institute for Policy and Strategy, the Interdisciplinary Center Herzliya.

Carl Bildt Former Prime Minister of Sweden. Presently, Chairman of the Kreab Group of public affairs and strategic communication companies. Serves as non-executive director of Vostok Nafta and Lundin Petroleum. Serves on the Board of Trustees of the RAND Corporation, the Board of the Centre for European Reform, and as a member of the International Advisory Board of the Council on Foreign Relations. After his term in government, he was the European Union Special Representative to Former Yugoslavia and served as Co-Chairman of the Dayton Peace Talks. He was later appointed Special Envoy of the Secretary-General of the UN on the Balkan issues. Among other awards, he holds an honorary degree from the University of St. Andrews, where he is a Fellow at the Institute for the Study of Terrorism and Political Violence.

Maj. Gen. (res.) Ilan Biran Chairman of YES satellite broadcaster. Serves as the Prime Minister's coordinator in charge of negotiations for the release of kidnapped and missing Israelis. Former CEO of Bezeq Israeli Telecommunication Corporation Ltd., and former Director General of the Ministry of Defense. Prior to this, served as Chairman of the Board of Directors of Oil Refineries Ltd. Served in the IDF for over thirty years in a series of senior positions including GOC Central Command, Head of the IDF Technology and Logistics Directorate, Commander of the *Givati* Brigade and Commander of the Officers Training School. He was an Associate for Strategy and Political Economy Research at Georgetown University. Holds an M.A. from Tel Aviv University. Graduate of the U.S. Marine Corps Command and Staff College. Member of the Board of Directors, the Institute for Policy and Strategy, the Interdisciplinary Center Herzliya.

**Shlomo Bohbot** Mayor of Maalot-Tarshicha since 1976. Served as a Member of Knesset for the Labor party. Recipient of the Marcus Ziv Award for initiative in the improvement of Arab-Israeli relations.

Amb. **John R. Bolton** Permanent U.S. Representative to the United Nations. Prior to this appointment, served as Under Secretary of State for Arms Control and International Security. Previously, he was Senior Vice President of the American Enterprise Institute for Public Policy Research. Spent many years in public service, in positions including Assistant Secretary for International Organization Affairs at the Department of State, and Assistant Attorney General in the Department of United National Security. Department of State, and Assistant Attorney General International Organization Affairs at the Department of United Nations. Graduated with a B.A., summa cum laude, from Yale University and received J.D. from Yale Law School

Prof. **Paul Bracken** Professor of Management and Political Science at Yale University. Leading expert in the study of global competition and the strategic application of technology in business and defense. Consultant to several large corporations and private equity funds, as well as to the U.S. Government. Has taught in many parts of the world, including programs for the Israeli Defense Forces. Member of the Council on Foreign Relations. Prior to joining the Yale faculty, he was on the senior staff of the Hudson Institute for ten years, as director of the management consulting arm of the Institute. Received a Ph.D. in Operations Research from Yale University.

Prof. **Menachem Brinker** Professor Emeritus of Philosophy and Hebrew Literature at the Hebrew University of Jerusalem. Research interests include aesthetics, hermeneutics, literary theory and modern Hebrew literature. Established the program in Modern Hebrew Studies at the University of Chicago and held the first chair in the program. He has been a visiting professor at Harvard and Columbia Universities. One of the founders of the Israel Philosophical Association. Recipient of the Israel Prize for Hebrew and General Literary Research. Earned a Ph.D. in Philosophy from Tel Aviv University.

**Shraga Brosh** President of the Manufacturers Association of Israel. Former CEO of I. Brosh Marketing & Services Ltd. Member of the MAI Presidium since 1993, holding the positions of Chairman of the MAI Executive Committee, Metals Division and other positions in the organization. Also served as Chairman of the Israel Export and International Cooperation Institute. Holds a degree in Economics and Business Administration from Bar-Ilan University.

**Hermann Bünz** Director of the Friedrich Ebert Foundation in Israel. Previously served as Director of the Foundation in Poland and Brussels and as Director of its Department for European Affairs in Bonn. He was an Assistant Professor at Hamburg University, and conducted research at the universities of Moscow, Leningrad, Paris, Munich and Freiburg. Studied History, Political Science, English and Russian Language at Hamburg University.

Jimmy Carter 39th President of the United States, from 1977-81. Since leaving office, he has worked internationally for the disenfranchised, fighting hunger and poverty through a variety of non-profit organizations. In 2002 he was awarded the Nobel Peace Prize for his years of humanitarian work. Negotiated the Camp David Accords between Egyptian President Anwar al-Sadat and Israeli Prime Minister Menachem Begin. He has served as an international mediator in North Korea, Haiti, Bosnia, Venezuela, and elsewhere, and has worked to focus world attention on epidemics in Africa. Founded the Carter Center in Atlanta, which is an arena for the discussion of international affairs. He also has been deeply involved with Habitat for Humanity, a nonprofit organization that helps working-class people in North America and abroad build and finance new homes. During his term of office Carter published Why Not the Best? (1975) and A Government as Good as Its People (1977). After it, he wrote more than a dozen works of poetry and nonfiction.

Sir Ronald Cohen Chairman of the Portland Trust. Founding Partner and Chairman of Apax Partners Holdings. Chairman of the Social Investment Task Force and founder of EASDAQ, the pan-European market for growth companies, of which he was Vice Chairman. Chairman of Bridges Community Ventures Limited, Founder-Director and past Chairman of the British Venture Capital Association, Founder-Director of the European Venture Capital Association and the Quoted Companies Alliance. He has served as a member of the London Stock Exchange Working Party on Smaller Companies, CBI Wider Share Ownership Committee and the Executive Committee of The Centre for Economic Policy Research. Graduate of Oxford University and honorary Fellow of Exeter College. Holds an M.B.A. from Harvard Business School.

Dr. Robert Danin Deputy Assistant Secretary of State in the Bureau of Near Eastern Affairs, responsible for Arab-Israeli negotiations policy and strategic planning. Served at the White House/National Security Council as Director for the Levant and Israeli-Palestinian affairs and then as Acting Senior Director for Near East and North African Affairs. Served on Secretary of State Powell's Policy Planning Staff, where he was responsible for Middle East and Gulf issues. Previously served as a senior political analyst in the State Department's Bureau of Intelligence and Research. He has been a visiting scholar at Georgetown University's Institute for the Study of Diplomacy and at the Washington Institute for Near East Policy. Holds a doctorate in International Relations from Oxford University and a master's degree from Georgetown University's School of Foreign Service.

**Itsik Danziger** Chairman of Starhome Ltd and Chairman of the Education Initiative in the Galilee, IVN. Member of the Board of Directors of Comverse Technology. Held senior positions in the Comverse Group, among them COO, President, Vice President for R&D and President of the Network Systems Division. Received a B.Sc. and M.Sc., cum laude, in Electrical Engineering from the Technion Israel Institute of Technology.

Prof. Alan Dershowitz Felix Frankfurter Professor of Law at Harvard Law School and internationally renowned attorney. Areas of expertise include criminal law and human rights. Lectures on Jewish and legal issues and appears frequently in the media. Author of twenty works of fiction and non-fiction. Received LL.B. from Yale Law School. Daniel Doron Founder and Director of the Israel Center for Social and Economic Progress. One of the founders of the Shinui Party. Served on an economic advisory group for Prime Minister Binyamin Netanyahu and on the Israel Government Council for National and Economic Planning, and was a member of the Board of the Entrepreneurial Center of Tel Aviv University. Publishes regularly in the Israeli and foreign press and is a columnist for <a href="The Jerusalem Post">The Jerusalem Post</a>. Studied Sociology and Economics at the Hebrew University of Jerusalem, was a Fellow of the University of Chicago's Committee on Social Thought, and a Visiting Scholar at Columbia University.

Prof. **Yehezkel Dror** Professor Emeritus of Political Science at the Hebrew University of Jerusalem and Founding President of the Jewish People Policy Planning Institute. Former member of the Club of Rome. A former Senior Staff Member of the RAND Corporation, Senior Planning Advisor in the Defense Minister's Office, and Policy and Planning Advisor in the Prime Minister's Office. Published numerous books and articles. Recipient of the Israel Prize for Administrative Sciences, the Levi Eshkol Prize for Public Administration, the Harold Lasswell Award, and the Rosolio Prize.

**Efrat Duvdevani** Director of the Ministry for the Development of the Negev and Galilee. Served as Director-General of Shimon Peres's office during his period as Prime Minister and as Foreign Minister. Previously served as advisor to late Prime Minister Yitzhak Rabin. Graduate of Tel Aviv University in Public Administration.

Dr. **Nicholas Eberstadt** Henry Wendt Scholar in Political Economy at the American Enterprise Institute for Public Policy Research. Expert on demographics, foreign aid, Korea and East Asia. Previous positions include Visiting Fellow at the Harvard University Center for Population and Developmental Studies, and consultant to the World Bank and the U.S. State Department. Holds a Ph.D. in Political Economy and Government from Harvard University and a M.Sc. from the London School of Economics.

Rabbi **Yechiel Eckstein** Founder and President of the International Fellowship of Christians and Jews (*Hakeren L'yedidut*), a bridge building organization committed to promoting greater understanding and cooperation between

Christians and Jews and support for Israel. Ordained at Yeshiva University in New York and holds Master's degrees from Yeshiva and Columbia Universities, where he also completed studies for his doctorate. Served on the faculties of Columbia University, Chicago Theological Seminary and Northern Baptist Seminary. Author of six highly acclaimed books on Jewish-Christian relations, and considered the leading Jewish authority on Evangelical Christians.

Maj. Gen. (res.) **Giora Eiland** Head of the National Security Council and National Security Advisor to the Prime Minister. Served in the IDF for more than thirty years in several command and staff positions including Head of the Plans and Policy Directorate, Commander of the Infantry, the Paratroopers' Brigade Commander, and Commander of the Officers' Academy. Received a B.A. in Economics and an M.B.A. Graduated from an advanced infantry course in Port Benning, Georgia.

MK **Michael Eitan** Chairman of the Knesset Constitution, Law and Justice Committee and Chairman of the Parliamentary Inquiry Committee for Uncovering Corruption in the Government System of Israel. Member of Knesset for the Likud party. Previously served as Minister of Science and Technology and as Deputy Minister in the Prime Minister's Office. Studied Law at Tel Aviv University.

Dr. Israel Elad-Altman Director of Studies at the Institute for Policy and Strategy, the Interdisciplinary Center Herzliya. Served in various official positions in Israel and abroad. Formerly, a lecturer at Tel Aviv University and a Research Fellow at the Shiloah Institute for Middle East Studies. Received a Ph.D. in Islamic Studies from UCLA.

Brig. Gen. (res.) MK Prof. **Arieh Eldad** Member of Knesset for the Ichud Leumi party. Chairman of the Knesset Ethics Committee and member of the Foreign Affairs and Defense Committee. Medical doctor specializing in plastic surgery. Served as Chief Medical Officer of the IDF, and as Director of the Department of Plastic Surgery at Hadassah Hospital, Ein Kerem. Received M.D. from Tel Aviv University.

Amb. Dr. **Oded Eran** Ambassador of Israel to the European Union. Has been with the Israeli Foreign Service for over thirty years, where he has served in the Israeli embassies in London and Washington D.C. As Ambassador to Jordan, he led the Israeli-Palestinian final status negotiations. As Deputy Director-General for Economic Affairs in the Foreign Ministry, he directed negotiations on the Association Agreement with the EU (1995) and participated in the negotiations on the Paris Economic Agreement with the Palestinians. Received a Ph.D. in Political Science from the London School of Economics.

**Philippe Errera** Deputy Director of the Centre d'Analyse et de Privision at the French Ministry of Foreign Affairs. Previously, he served as counselor in charge of politico-military affairs at the French Embassy in Washington, D.C., at the U.S. Department of State's Bureau of European Affairs, and at the French Ministry of Foreign Affairs in the Office of European Common Foreign and Security Policy. Holds degrees from the Paris Institute of Political Studies and the cole National d'Administration.

Laurent Fabius Former Prime Minister of France. Member of the National Assembly for the fourth constituency of Seine Maritime. Member of the Socialist Party group. Served twice as President of the National Assembly, and additionally as Minister of Finance and Minister of Industry and Research. Graduate of the cole National d'Administration.

Prof. **Stanley Fischer** Governor of the Bank of Israel. Previously Vice Chairman and Head of the Public Sector Group at Citigroup and First Deputy Managing Director of the International Monetary Fund (IMF). Before joining the IMF, he was Head of the Department of Economics at MIT and Vice President for Development Economics and Chief Economist at the World Bank. Fellow of the Econometric Society and the American Academy of Arts and Sciences, a member of the Council on Foreign Relations, the G-30, and the Trilateral Commission, a Guggenheim Fellow, and a Research Associate of the National Bureau of Economic Research. Earned a B.Sc. and an M.Sc. at the London School of Economics and obtained his Ph.D. in Economics at MIT.

Dr. **Karnit Flug** Director of Research at the Bank of Israel. Previous positions include Assistant Director of Research, senior research economist at the Inter-American Bank and economist at the International Monetary Fund. Holds an M.A. from the Hebrew University of Jerusalem and a Ph.D. in Economics from Columbia University.

Prof. **Jacob Frenkel** Vice Chairman, American International Group (AIG). Previously served as Chairman of Merrill Lynch International Inc., and as Governor of the Bank of Israel for two consecutive terms. Prior to this, served as Economic Counselor and Director of Research at the International Monetary Fund. Former Professor of Economics at the University of Chicago and at Tel Aviv University. Additional positions have included Chairman of the Board of Governors of the Inter-American Development Bank and Vice Chairman of the Board of Governors of the European Bank for Reconstruction and Development. Earned M.A. and Ph.D. degrees in Economics from the University of Chicago.

**Diana Furchtgott-Roth** Director of the Center for Employment Policy at the Hudson Institute. Before joining Hudson, she spent two years as Chief Economist at the U.S. Department of Labor. Previously, served as chief of staff and special adviser at the President's Council of Economic Advisers, and as a resident fellow at the American Enterprise Institute. Prior to that, served as Deputy Executive Director of the Domestic Policy Council and Associate Director of the Office of Policy Planning in the White House. Received a B.A. in Economics from Swarthmore College and an M.Phil. in Economics from Oxford University.

Arcadi Gaydamak President of the Congress of Jewish Communities of Russia, philanthropist and businessman.

Yael German Mayor of Herzliya. In this capacity, chairs several public municipal companies and organizations, including the Herzliya Tourism Company, the Herzliya Development Company and the Herzliya Foundation. An Executive Board Member of Magen David Adom (Israel's National EMT Service) and the Israeli Archeological Authority. Associated with a variety of women's' rights lobby organizations. Previously, Co-CEO of Yariv Ben-Eliezer Media Consultant Company and Administrative Director of GG Electrical Industries. A professional schoolteacher and former Principal of the Herzliya "Tehilla" School for Adult Education. Earned a Teaching Diploma (English Language and Adult Education) from the Levinski Seminar and a B.A. in General History from Tel Aviv University.

Brig. Gen. (res.) **Eival Gilady** Chairman of the Western Galilee College, CEO of the Portland Trust Israel, and President of VANADIS Ltd. Served as Head of Coordination and Strategy at the Prime Minister's Office. Served in the Israel Defense Force for thirty years, his last position being Head of the IDF's Strategic Planning Division, responsible for developing the Gaza Disengagement Plan.
