#### PRESIDENT'S MESSAGE



In September 1985, former Saint Louis University President Paul C. Reinert, S.J., wrote a piece for *Momentum* magazine on "The Spiritual Dimensions of Giving and Getting." In an effort to show how philanthropy is ultimately tied to the love of God, human growth and development, Father Reinert connected two ostensibly opposing concepts: religious values and fundraising. Currently the chair of the department of surgery and the Edward R. Woodward

begin his tenure at SLU on Jan. 1. He will

oversee the educational, research, clinical and service activities of SLU's nationally ranked School of Medicine. The CEO of SLUCare, the University's physician practice, will report to Behrns, who will also serve as a key liaison with SSM Health.



#### Kenneth A. Olliff

VICE PRESIDENT FOR RESEARCH

Most recently vice president for program
development at the University of Chicago,
Olliff co-founded Arete, a research
accelerator that averages \$20 million per
year in external funding. He also created
the Big Ideas Generator, an incubator

that awards funding and support for bold, early-stage projects that have potential for growth. At SLU, he works with deans, department chairs and faculty to advance the quality, scope and impact of research across the University.



#### Dr. Michelle Sabick

DEAN OF PARKS COLLEGE OF ENGINEERING, AVIATION AND TECHNOLOGY

For the past two years, Sabick chaired the Department of Biomedical Engineering in Parks College. Prior to that, she was on the faculty of Boise State University in Idaho, where she also chaired the mechanical

and biomedical engineering department. Throughout her career, Sabick has worked to improve the ways that universities deliver engineering education. A noted researcher, she has received more than \$3 million in grants from the National Science Foundation.


# Dame Mary Bruemmer Awarded Papal Knighthood

Former dean of student affairs Mary Bruemmer (A&S '42, Grad Ed '60) was named a Dame Commander of the Order of Saint Sylvester Pope and Martyr in June.

The honor was a surprise during a retirement party for the 96-year-old who served as a full-time SLU volunteer for the past 26 years. (She first retired in 1990 after nearly 35 years in the administration.)

Archbishop Robert Carlson of St. Louis presented Bruemmer with a commemorative scroll and a cross medallion from Rome that is meant to be worn at significant archdiocesan events.

"Mary has been a role model, a guiding light and a moral compass for generations of SLU students and alumni," Carlson said. "She has also served God in so many ways, and this honor from Pope Francis tells the world how she has served him and her Church."



The new academic medical center will be located on the north side of the existing facility between Rutger and Lasalle streets, adjacent to the hospital's current location on Grand Boulevard, with plans to better integrate the hospital with the School of Medicine and SSM Health Cardinal Glennon Children's Hospital.

#### Plans Revealed for New Academic Medical Center

In June, SSM Health unveiled a master facility plan for a new \$550 million academic medical center — a 316-bed, 802,000-square-foot replacement hospital and new outpatient care center for SSM Health Saint Louis University Hospital.

The new SSM Health Saint Louis University Hospital will include all private patient rooms, larger intensive care units and an expanded emergency department. The new outpatient care center will increase services and provide additional clinical space for SLUCare practices. Dedicated educational space throughout the facility will allow the University to better train future physicians and health practitioners.

Alberici Constructors Inc. is the project's construction manager and is slated to break ground in fall 2017 with an anticipated completion date of Sept. 1, 2020. Lawrence Group, in partnership with Hammel, Green and Abrahamson, began developing the project in January, working from information provided by planning architects Frank Zilm and Associates Inc.

# Awards and Recognition

Dr. Benjamin Looker, associate professor of American studies, received the 2016 Lawrence W. Levine Award from the Organization of American Historians for the best book in American cultural history, A Nation of Neighborhoods: Imagining Cities, Communities, and Democracy in Postwar America.

Dr. Elizabeth Blake, assistant professor of Russian in the Department of Languages, Literatures and Cultures, received a Department of Education Fulbright-Hays grant from American Councils for a professional development program this summer at the Russian State Pedagogical University (Herzen) in St. Petersburg.

Dr. J.D. Bowen, associate professor of political science, received a Fulbright U.S. Scholar award to conduct research at the Universidad de los Andes in Bogotá, Colombia, this spring.

Dr. Fred P. Pestello, SLU president, is a member of the National Association of Independent Colleges and Universities board of directors and chairs the association's standing committee on tax policy.

More than 170 SLUCare physicians from a variety of specialties were recognized by St. Louis Magazine as the best doctors of 2016. The list is based on the annual "Best Doctors in America" database.



#### 2016 Spring Commencement Draws Large Crowd

n estimated 10,000 people filled Chaifetz Arena on May 14 to take part in Saint Louis University's 2016 spring commencement ceremony. Nearly 2,600 students graduated this year.

For the first time at commencement, the ceremony's music was performed by an all-student orchestra.

Another new feature this year was a student speaker from the graduating class, Hannah Vestal, a psychology major with minors in theology and public health. Vestal founded Billikens for Clean Water and was a 2016 recipient of SLU's Woman of the Year award.

This year's commencement speaker was U.S. Ambassador to Ireland Kevin F. O'Malley (A&S '70, Law '73). For more than 15 years, he taught trial advocacy courses as an adjunct professor at SLU's School



O'Malley received an honorary doctor of medical sciences from the University. Also honored during the ceremony was Sister Mary Jean Ryan (Nurs '67), a member of the Franciscan Sisters of Mary for more than 50 years and the former CEO of SSM Health. She received an honorary doctor of public service.

Travis Ford Named Men's Basketball Coach

ravis Ford is the new L head coach of the Billiken men's basketball program. In 19 seasons as a collegiate head coach, Ford has a 345-257 record. He has had head-coaching stints at Oklahoma State

(eight years, 2008-16), Massachusetts (three years, 2005-08), Eastern Kentucky (five years, 2000-05) and Campbellsville. Ford has led his team to the NCAA Tournament six times. He has coached six players who have gone on to play in the NBA and five who have been named conference player of the year.

While at Oklahoma State University he led the Cowboys to a 155-111 record and five NCAA Tournament appearances, including three in the last four years. He recruited three McDonald's All-Americans to Stillwater, Oklahoma, during his tenure.

Ford played the majority of his collegiate career at the University of Kentucky, helping the Wildcats to NCAA Tournament appearances in each of his three seasons (1992, 1993, 1994). He was a junior on the 1993 Wildcat team that advanced to the NCAA Final Four.



#### College Church Marks 175 Years

A yearlong celebration is underway to honor the 175th anniversary of the founding of St. Francis Xavier College Church.

The first English-speaking Catholic parish in St. Louis, the College Church was founded in 1841 to minister to the growing number of Irish immigrants in the city.

Today, the parish is known for its liturgical music, religious education, and social ministry work and advocacy. The church hosts nearly 100 weddings each year.

The anniversary celebration runs through July 30, 2017, and events include a concert by the College Church choir, a gala, and a Valentine's party and vow renewal for couples married at the church.

Lisch Plays for Australia in Rio Olympics

ormer Billiken Kevin Lisch (Cook '08, Grad Cook '12) played at the Rio Olympics as a member of the Australian men's basketball team. Lisch, a Belleville, Illinois, native who played for the Billikens from 2005

to 2009, recently received Australian citizenship. He has played professionally in Australia, and his wife is Australian.

He is the Billikens' sixth-leading scorer (1,687 career points) and was an Academic

After graduating from SLU, Lisch played professionally in Australia for the Perth Wildcats, winning a championship in 2010 and an MVP honor in 2012. After stints in Puerto Rico, France and Spain, Lisch returned to Australia last season as a member of the Illawarra Hawks and captured another MVP award. He is signed to play with the Sydney Kings next year.

Lisch was the first Billiken men's basketball player to compete in the Olympics since Pete McCaffrey, who won a gold medal with Team USA in the 1964 Olympic Games in Tokyo.





Thirteen strangers are chosen and instructed to live together, eat together and depend upon each other.

This isn't the next season of prime-time reality television. This is the Billiken Teacher Corps, a two-year, servicedriven master's program at Saint Louis University. Participants are not just roommates or classmates; they're treated as a community somewhere between a cohort and a family. They have shared experiences and make programmatic decisions as a group. They're young, energetic teachers who rely upon each other for prayer,

support, fellowship

and camaraderie.

"The Billiken Teacher Corps is a program with three interlocking pillars," said Dr. John James, a School of Education faculty member who helped make the program a reality. "One, teaching in a high-need, urban, Catholic school. Two, earning a tuition-remission master's degree at Saint Louis University. And three, living in an intentional faith community, which involves prayer and personal spiritual development."

The program launched in June 2015. Participants are recent college graduates, some with undergraduate degrees in education and some without, who have a drive to serve and a desire to teach. The inaugural six Billiken Teachers have started their second year in the program and welcomed a new cohort of seven this past June.

The Billiken Teacher Corps is based on the Alliance for Catholic Education at Notre Dame, but anyone familiar with service-driven programs will notice similar elements. It's like the Jesuit Volunteer Corps, but with a teaching component. It's like Teach for America, but all participants live together.


Michelle Ehrhard, a second-year Billiken Teacher Corps student who is originally from St. Louis, heard about the program during her senior year at Truman State University.

"It's like my personality was shifted into a program," Ehrhard said. "I was somewhere between being Catholic and wanting to teach, but wanting it to be more than just a career — wanting to show God through it."

## The Teaching

Each student in the program is placed in an under-resourced school in the St. Louis region to teach for two years. Elise Earley teaches middle school science at St. Cecilia School and Academy in





St. Louis. She has always wanted to effect change in the world. But because she did not decide to become a teacher until after she graduated from college, she was without the student-teaching experience that undergraduate education majors have. "The first day of school was kind of shocking," Earley said. "Nothing can prepare you for that first day. Until you get into the classroom, you have no idea what it'll be like."

She was lucky to have very sweet students in her class, she said, willing to help out as she learned the ins and outs of managing a classroom.

Sarah Staten teaches math and religion to sixth, seventh and eighth graders at St. Louis the King School at the Cathedral in St. Louis' Central West End.

"It was initially intimidating to have six classes to plan for," Staten said. "I've had to develop my own curriculum based on what the students need and what they aren't understanding."

#### The Learning

Once a week during the school year, the tables are turned and the Billiken Teachers become students. Earning a Master of Arts in teaching through the two-year program, the cohort takes one evening class during the academic year and three concurrent classes during the summer.

"The classes are mostly discussion-based," Staten said. "For a lot of it, you incorporate what you've done teaching into the class. So it's not a ton of new knowledge, but it's reinforced by what you're doing."

The program begins with three summer classes. Billiken Teachers who are not yet certified teachers take a class preparing them for classroom man-

> agement and the basics of education. Many of the classes in the master's program focus on urban education.

"The Billiken Teachers' success will be grounded in the ability to use the research-based approaches they learn at SLU to achieve real-world results," said Ronny O'Dwyer, S.J. (Grad A&S '09, Grad Ed '10), director of the Billiken Teacher Corps. "This will require our members to integrate spiritual passion and intellectual depth with their service as leaders in Catholic education."

## The Community

All Billiken Teachers live together in a renovated convent at St. John the Baptist Catholic Church in south St. Louis. The old convent has three floors: the top floor has 14 individual rooms and community bathrooms; a

main floor includes study spaces, tables, couches and a chapel; and the bottom floor has the kitchen, dining room, laundry room and television room.

Mandatory weekly events fulfill the community and faith-formation aspect of the program. One night a week O'Dwyer joins the community for Mass and dinner, and leads them through various aspects of St. Ignatius' Spiritual Exercises. On other evenings, one person cooks dinner for the group.

"We're like a family," Ehrhard said. "It's like somewhere in between really close roommates and family because they're peers — peers that you might not have chosen, but you end up loving. It's a messy, beautiful thing."

Billiken Teachers live together, eat together, pray together, learn together, laugh together. They stay up late and share classroom techniques and ideas with each other.

"I didn't expect to be super close to anybody, but I have come to love everybody in the program," Staten said. "I look forward to catching up with everybody, seeing how their days were, sharing funny stories and just getting to know each of them outside of the teacher context."

And Staten said it's been a huge blessing during the challenges brought up by the program. When someone has to miss a community event, it becomes obvious how important that time together is.

"I didn't know I'd need it," Staten said, "but God knew I would, so he gave me good people."

### The Calling

Billiken Teachers have adopted the phrase "Teach me" as their motto. "Anyone familiar with Jesuit education likely knows by heart St. Ignatius' prayer for generosity," O'Dwyer explained. "The prayer consists of seven stanzas, each beginning with the words 'teach me' — teach me to be generous, teach me to serve, teach me to give, to fight, to labor.

"It's a prayer to God, of course, but it's also a call we hear coming from our students: teach me," he continued. "But there's more. Anyone who has ever taught knows that teachers learn from their students. So to the students, too, we say teach me—teach me how to be Christ for you."

Even with this powerful motivation, joining the Billiken Teacher Corps might not be the right fit for everybody. Teaching is a job full of delayed gratification, the Billiken Teachers say, and you have to be able to rely on your community for support on the days the job is taxing. You have to put your community's needs and wants ahead of your own needs and wants. You have to share a bathroom.

But all of the Billiken Teachers agree: It's worth it.

"It has really worked out for the best," Ehrhard said. "Not just for the better, but for the best." UTAS

# IN FOCUS

he photos Cengiz Yar takes are hard to look at and even harder to look away from. Amid dusty earth tones — the rubble of fallen desert cities, crisscrossed with dark wire: camouflaged fatigues: fragments of bone out of context — he captures swaths of verdant countryside and snaps of deep red — carnations atop a casket, a kaffiyeh scarf, a smear of blood. Whether devastating or beautiful or both, the shots invite the viewer to take a closer look: This is the face of suffering. This is humanity.

A documentary photographer and freelance photojournalist, Yar (Cook '09) has focused recently on two main subjects: the ongoing conflict in the Middle East and the proliferation of gun violence in the United States.

His work takes him from Kurdistan to Ferguson and back, to places probably unfamiliar to most of his fellow Saint Louis University

But his background, at least the SLU portion of it, is certainly familiar. Like so many students,

Yar came to Saint Louis University from his hometown of Milwaukee because of a scholarship (in his case, the Martin Luther King Jr. Scholarship) and because he's a legacy (his aunt and uncle, Marge and Pete Donegan, graduated in the mid-1970s). Add in a series of good grants, and SLU was his best option, although maybe not the most obvious path to what he planned to do with his life.

Yar fell in love with photography in high school and knew it was the career for him. But Saint Louis University offered only a few photography courses.

"It didn't make sense to me to go to school for photography," Yar said. "I went to SLU knowing I'd want to run my own business someday, and that I'd be able to get a good business education there."

He studied in the John Cook School of Business while gravitating toward extracurriculars with a visual bent, including video production for SLU TV and a summer internship at a small media company in St. Louis.

Then he decided to study abroad.

"I wanted to be as far away from my comfort zone as possible," Yar said. So he chose the program farthest away, ending up at Beijing University of International Business and Economics through an exchange program sponsored by Loyola University Chicago. As soon as he got to China, his perception shifted.

"Beijing was a complete shock," he said. "I was immediately overwhelmed by how many other people there are in the world."

The frame around him was expanding, quickly. He returned to America and to SLU with a global perspective, and decided to concentrate on international business.

After graduating, Yar spent a year and a half teaching English and developing his photography skills in Thailand, and then moved to Chicago, which he still considers his home base. Since 2012, he has traveled in and out of the United States, mostly to the Middle East. At the end of October 2015, he relocated to northern Iraq.

Not affiliated with a specific news or photo agency, Yar is entirely freelance, which essentially means he's putting that business education to good use. He does all of his own pitching, marketing, fundraising and accounting. And then there's the work of photography, of course.

"Less than 5 percent of my work is actually taking photos," he estimated.

He splits his work between creating stories for nongovernmental organizations and producing material for news organizations and magazines. His work has been published and mentioned by some notable news sources, as well: BBC World News, The Guardian, The Telegraph, Maclean's Magazine and Mashable among others. In 2015, he was awarded the Online News Association's inaugural James W. Foley award for conflict freelancers.

Accepting the award, Yar said, "For a freelance journalist, specifically one that has covered the war in Syria, I can't think of a

higher honor than this. I'm incredibly grateful."

However, the award also flashed a warning: Foley was an American freelance journalist who was abducted in Syria and beheaded by ISIS in 2014. His death reminds journalists everywhere of the potential danger of their profession.

Yar definitely has been in his share of intense, life-threatening situations. He's been in combat, in ruined cities strewn with hidden explosives, at the site of massacres.

"I don't think of myself as brave," he said. "In combat situations, I'm very much afraid."

He works through those moments, though, to focus on the important job of witnessing and storytelling.

"I'm incredibly privileged and blessed to see all of this and meet all these people," he said. "I want to tell their stories because they deserve a voice in the international news cycle."

So Yar goes to the ruins of Sinjar, Iraq, to Aleppo, Syria, to even Baltimore and Chicago, looking for stories that might not get told

He is most proud of "Syria's Children," an ongoing project that documents the lives of often overlooked victims of the Syrian war: child refugees living in Turkey, Iraq, Jordan and Lebanon. With the consent of a parent or guardian, Yar interviews each child and takes his or her portrait. He uses Polaroid film, with all of its imperfections and nuances, and then scans the photo and gives one back to the child.

"I wanted to put a face to the crisis in Syria." he said. "Everyone is special and deserves respect. Many of these children don't have anything, and for me, their portrait is a simple thing to give back to them."

Except for a donation of film, the project has been funded entirely by Yar. The project was nominated for the 2014 UNICEF Photo of the Year. Since 2014, he's photographed more than 200 children.

That's just a small fraction of the stories to tell, the pictures to take. Don't look away. **UTAS**

hen John O'Leary (Cook '99) was 9 years old, he decided to experiment with fire and gasoline in his family's garage. His innocent undertaking caused an instant explosion. O'Leary was burned over 100 percent of his body; 87 percent was third-degree. His doctors and nurses did not think he would make it through the night; he was given a less than 1 percent chance of surviving.

> But survive he did. After a grueling but miraculous recovery — his doctor told him he had never seen anything like it in his

entire career — O'Leary worked to put the fire behind him. He enrolled at Saint Louis University, where he met his wife, Beth (Hittler) O'Leary (Doisy '01), who is now a SLU adjunct instructor in occupational therapy. After college, he started a real estate development business with a fellow SLU alumnus. He later pursued a chaplaincy program through SLU and worked as a hospital chaplain for three years. He and Beth began having children — they now have four. But he never talked much about the fire; even Beth and his college roommates knew few

details about how he had gotten his scars.

That changed in 2005, when his parents, Susan and Denny (Law '68), published a book, Overwhelming Odds, about that fateful day in 1987 and the journey for their family that followed.

"It was an unauthorized biography of my life," O'Leary joked, "It changed my life,"

His parents' telling of it helped him realize that the fire and its aftermath had brought out the best in everyone around him, from his sister Susan, who risked her life running into their burning house to retrieve cups of water to pour onto his face; to his hospital-room janitor, who kept it spotless and free of infection; to broadcaster Jack Buck, who sent him more than 60 autographed baseballs from St. Louis Cardinals baseball players to encourage him to learn to write again, despite having had his fingers amputated.

"Our neighbors opened up their homes to my siblings as we waited for the house to be repaired; the community raised money, donated blood, offered prayers, brought food," he wrote. "I had never before fully considered all the people who came together to make the

miracle a reality. ... As if cataracts had been cut away, I understood, 'Oh my gosh ... it was all a gift."

Three months after his parents' book was published, O'Leary was asked to give a speech about his experiences. Despite being terrified of public speaking — he said he barely scraped by in his required public speaking course at SLU — he agreed. Then he was asked to speak again and

again. Now, over a decade later, O'Leary has given more than 1,500 talks around the country and the world, describing the small acts of kindness from strangers and friends alike that contributed to his recovery and growth, and the lessons he learned that he believes can be applied to the difficult situations in everyone's lives. He encourages his audiences, from health care workers to prison inmates, to live their lives "radically inspired."

And in March of this year, O'Leary's own book, On Fire: The 7 Choices to Ignite a Radically Inspired Life, was published by Simon & Schuster. The book became a No. 1 national best-seller and is already being printed in 12 languages.

"It was very, very raw and personal to write about the experiences of being burned as a kid," he said. "It's been very therapeutic, very healing and transformative as we've gone farther and farther down the path to realize it's not an autobiography. I think it's a reflective story that inspires others to be the best version of themselves, helping them realize they can do so much more in their lives than what they had been doing, and that everything they do going forward from this moment will make a difference."

And it's working.


"I was in Dallas recently, and a woman drove two-and-a-half hours to hear me speak for the 11th time," he said. "She says that she has transformed her life spiritually, relationally and professionally as a result of these encounters, and she's going to keep driving two-and-a-half hours to keep growing. That

just blows me away, and it's proof that this story's not about the man writing it; it's about the individuals living it. It can change lives."

Is it difficult to live "radically inspired" all the time?

"The reason why the book works and why people are happy for my wife and me is because we are the same people before the book, within the book and then after the

book," he said. "It hasn't changed us, and we're not trying to put on pretenses. And, candidly, we're not the heroes in that book as much as all the other people who show up in our lives. We're celebrating them and our decision to be more like them in our own life, so we're trying to be that radically inspired life; we're not claiming that we have it.



Through it all, O'Leary said his Billiken friends continue to be some of his most enthusiastic cheerleaders.

"They celebrate the guy they knew in the quad, the guy they sat next to at Humphrey's; they've just loved me for who I was throughout it all," he said. "So I'm grateful for the friendships that were formed at SLU and

today. The success I had in my first business, becoming a hospital chaplain, finding a wife, the four children, and even today with the speaking and writing career, it's a direct result of Saint Louis University." UTAS



























Forty-eight authors in all, some of the biggest literary giants of the last half-century. Several have Pulitzer Prizes to their name. A few, Nobels.

All have St. Louis Literary Awards.

#### 'A Who's Who of Literature'

The St. Louis Literary Award started nearly 50 years ago as the Wilma and Roswell Messing Jr. Award, an honor given by the Associates of Saint Louis University Libraries.

The award was the brainchild of Henry J. Scherck, a local businessman who became special assistant to SLU President Paul Reinert, S.J., and who had been instrumental in the formation of the associates in the mid-1960s. Scherck was inspired by Columbia University's Bancroft Prizes, four annual awards to authors in the field of history. He imagined the associates could offer a similar award. The group just needed a sponsor.

Enter the Messings. After success in the printing business, Roswell "Bud" Messing and his wife, Wilma (Engel) Messing, turned to philanthropy. Knowing the couple had funded a library at an area school, the associates approached Messing about establishing its own literary award. He agreed, and Wilma Messing became an active member of the SLU Library Associates board.

In the early years, award recipients were chosen by a committee of Library Associates members, SLU faculty and the book editors of the St. Louis Post-Dispatch and St. Louis Globe-Democrat.

Today, a committee still decides, but the nomination process is open to the entire membership of the Saint Louis University Library Associates. After members suggest up to two authors, the committee chooses a handful to research.

"We read their work widely," said Patrick McCarthy (A&S '83), associate dean of University libraries and a member of the selection committee. "Then we vote by secret ballot to try to be as objective and fair as possible."

Despite personal tastes, the committee always chooses "a living writer with a substantial body of work available in English who has enriched our literary heritage by deepening our insight into the human

condition and expanding the scope of our compassion," said Philip Boehm, chairman of the selection committee.

The first couple of honorees were historians, but the list expanded to include authors of almost every kind — poets, playwrights, novelists and fiction writers, critics, philosophers — bound by their excellence.

In 1982 the name of the award changed, and over the years, the prize money increased — but the quality has remained the same.

"The list of winners is a who's who of literature," said Lana Pepper, president of the Saint Louis University Library Associates.

McCarthy concurred.

"This award has become one of the most important literary prizes in the country," he said. "Some of that has to do with the past authors, which is a list that builds on itself."

Even the winners are impressed by the company they keep.

"Richard Ford accepted the award because we'd given it to Eudora Welty," said Clarkson Joseph "Joe" Carpenter III (A&S '71), a Library Associates board member since the early 1980s.

Israeli writer and 2015 recipient David Grossman echoed: "When I saw the people who had won this award before me, I was very proud. It's very good company to be in."

Each year, the awardee comes to the University to be honored, read or lecture, and give a craft talk. The award presentation, which draws hundreds, was held in Pius XII Memorial Library until 1979 and in various campus locations after that.

#### Prologue to the Award

The presentation of the literary award is considered the highlight of the year for the Library Associates.

The group's origins harken back to fall 1963, a few years before the literary award was established, when Adelaide (Mahaffey) Schlafly (A&S '56) solicited support for the library from several University organizations.





# 2016 ST. LOUIS LITERARY AWARD WINNER Michael Ondaatje

Best known as a novelist, Michael Ondaatje is also a poet, memoirist and documentary filmmaker. His transcendent novel *The English Patient* became an Academy Award-winning film, the "Best Picture" of 1996.

Ondaatje will accept the award on campus on Thursday, Oct. 6. The event, which begins at 7 p.m. in Busch Student Center, is free and open to the public. Register online at lib.slu.edu/about/associates/literary-award/ondaatje.

The response was promising, with donations of several hundred dollars.

But the idea for a library friends group didn't spark until the next spring, when Scherck toured his great-great grandfather's library collection. Afterward, he wrote to Reinert, "Wonder how many of such collections are hidden in the attics of St. Louisans, collections which might be given to the University?"

Reinert replied, "Good idea, but why not make a long-term project to organize a Friends of the Library group to benefit the University Libraries?"

He saw an opportunity to connect Saint Louis University to the St. Louis community, one of his overarching goals as SLU president.

"Father Reinert felt strongly that this group would not only benefit the libraries, but would make the University and its purposes better known among all of the book-loving people of St. Louis," Scherck wrote in *The Story of the Associates of Saint Louis University Libraries Inc.* 

The funds Schlafly raised seeded the group, and the Associates of Saint Louis University Libraries was born. She and her husband, Daniel (the first layperson to chair SLU's board of trustees, in 1967) became the first lifetime members of the group. Associates memberships started at \$10.

At the start, the *St. Louis Post-Dispatch* penned an editorial praising the concept and encouraging "wide public support" of the programs. Prominent St. Louisans were on board, literally.

"The board of directors was a who's who of St. Louis society," McCarthy said. The associates became a valued cultural outlet, offering programming on topics ranging from the U.S. presidential libraries to the Dead Sea Scrolls. The group sponsored a literary tour of the city, highlighting T.S. Eliot and other renowned writers with St. Louis ties. Sometimes, book-loving members got the chance to view and even handle rare books.

#### Far from the End of the Story

Today, the Saint Louis University Library Associates — the group was renamed in 2001 — is "one of the best kept secrets in the area," according to Dr. Frances Pestello, a member of the Library Associates board.

In addition to its annual literary award, which will celebrate 50 years in 2017, the Library Associates continues to offer programming to invigorate the intellectual life of the region.

For several years, the group has sponsored Evenings at Home, during which authors read from their work and mingle with members of the associates in private St. Louis homes.

"It's a very intimate setting where you can spend the evening with the author, not just hear him or her read as you might at a bookstore," Pepper said.

She's noticed a younger crowd at the more recent Evenings at Home, a trend she hopes continues.

To that end, this year the board is welcoming two SLU students, the Student Government Association president (or designee), as well as a graduate student representative. The associates also created the Undergraduate Writing Award in 2014.

The overall goal is to further connect the Library Associates with the University.


For years, the associates operated relatively independently, even though activities were held on campus and the group supported the University libraries with frequent, generous gifts. Then as now, the mission of the Library Associates is to enhance SLU libraries and the development of their world-renowned collections

"The Library Associates was established as an independent nonprofit association," McCarthy said. "About three years ago, the group realized it made sense to bring it into the University." Now, SLU provides support in terms of administration, fundraising and development.

By all accounts, the Library Associates are ready for the next chapter.

"The Library Associates have always been a framework for bringing people together in a conversation through the arts," McCarthy said. "Now more than ever, it is a means to celebrate the humane values of Saint Louis University and the aesthetic components of a Jesuit education, and to share this with our students, alumni and the greater community." UTAS


Natalicio graduated from Cleveland High School at a time when



Natalicio became president of UTEP, the only U.S. doctoral/research university that serves a predominantly Mexican-American student population. She is UTEP's first female president and the longest serving president at a major U.S. public research university.

"When I arrived in 1971, a majority of UTEP students were non-Hispanic. The Hispanic population, which

was the majority population of the region, was seldom considered 'college material. I knew that talent was being squandered. My goal was to see UTEP's student body reflect the demographics of El Paso County."

During her tenure, UTEP's enrollment has increased from nearly 15,000 to more than 23,000. Doctoral programs have grown from one to 21. More than 80 percent of UTEP's students are Mexican-American. An additional five percent come from nearby Ciudad Juárez, Mexico. Most UTEP students work while enrolled.

"I've always had a good deal of sensitivity to our students because, as a first-generation and commuter student juggling academic and job responsibilities, I was very much 2011



She lives in St. Louis. espite her mother's urging to wait until she was older, Rosemary Connelly (Grad Ed '63) joined the Sisters of Mercy at 18. After spending four hot summers in full habit studying at Saint Louis University, she found her place in teaching and

social work before being called in 1969 to lead Misericordia (Latin for "heart of mercy"). Her order transformed the facility — once a Chicago residence for unwed mothers — into a home for 132 children with developmental and intellectual disabilities, many of whom had Down syndrome.

Connelly said staff members provided beautiful care for the children — they fed them, bathed them, clothed them, put ribbons in the girls' hair and put them back in bed.

"Custodial care was typical at the time," she said. "Staff members felt the children were safe if they spent all day in bed, but I felt strongly that custodial care was not enough. The children not only had a right to life, but one worth living."

Connelly had no background in working with children with developmental disabilities, so she called area hospitals and universities for help.

"They told me there were no programs for these children," she said. "They said if I wanted something I'd have to create it myself, and that's what I set out to do."

Connelly bought a swimming pool, bicycles and other sports equipment for the children. She had classrooms built for primary education and developed programs for self-help skills, speech and physical therapy.

Misericordia and the children thrived. Connelly was developing a reputation as a pioneer in improving the standard of care for children with disabilities.

In 1976, when the Chicago Archdiocese shuttered an orphanage, it offered a portion of the 31-acre campus to Connelly, who had been looking to build home-like residences for her more independent children.

Over the next four decades, Misericordia grew to consume the entire campus. The facility began accepting adults with developmental disabilities in 1983. The campus includes nine homes. A staff of nearly 1,000 serves the 600 children and adults who live there. Misericordia offers speech, occupational and physical therapies, yoga and dance classes. There's a fitness center with an Olympic-sized pool, and residents work at a campus bakery and restaurant. Last month, Misericordia opened four multiunit homes on campus for its aging population. Misericordia is the first facility in the country to offer this continuum of care — from childhood to adulthood.

"When I started at Misericordia, the average life span for a person with Down syndrome was 15," noted Connelly, selected by *Chicago* magazine as a Chicagoan of the Year in 2014. "Today they are living full, long lives, and they are developing issues with memory, dementia and Alzheimer's disease. We want to walk with them on their journey until God calls them home."

Now in her eighties, Connelly plans to remain executive director for as long as she feels useful.

"I get an awful lot of credit for Misericordia's success, but I'm only successful through the loving friendships and support of others," Connelly said. "The greatest gift God gave me is to surround me with the most compassionate, generous people in the world." — By Marie Dilg


