HISTORICAL AND BIOGRAPHICAL NOTES

Quoted from Finding Aid 3.46 as written by SB:

"Warren Eastman Hearnes was born on July 24, 1923 in Moline, Illinois to Earle B. and Edna Mae Eastman Hearnes. Educated in Charleston (Mississippi County) public schools, Hearnes graduated in 1946 from the U. S. Military Academy at West Point, New York. He served with the 35th Division, U. S. Army during World War II, leaving military service in 1949. Hearnes

received a law degree in 1952 from the University of Missouri and practiced law in East Prairie until 1961. He married Betty Cooper on July 2, 1947, and the couple raised three daughters.

"Elected to the Missouri House of Representatives as a Democrat from Mississippi County in 1950, Hearnes retained that office until elected as Missouri Secretary of State in 1960, a position he held until 1965. Warren Eastman Hearnes defeated Ethan A. H. Shepley in the 1964 gubernatorial election and was sworn in as Missouri's 46th governor on January 11, 1965. He was re-elected in 1968, the first governor to serve two terms.

"During his tenure, Hearnes signed a Public Accommodations Law ending housing segregation, strengthened the Fair Employment Practices Act, and increased the staff of the Human Rights Commission. Funding for public education was doubled, state aid to higher education tripled, and aid to vocational education increased from \$856,000 to \$8.8 million.

"Also during the Hearnes administrations, 350 miles of four-lane highways were constructed, the Missouri Division of Highway Safety was created, the Missouri State Highway Patrol added 250 new officers, and he signed legislation providing for mandatory breath tests of suspected drunken drivers.

"After leaving office, Hearnes mounted an unsuccessful campaign for the U. S. Senate in 1976, losing to John Danforth and in 1978 was defeated by James F. Antonio for State Auditor. He was appointed Circuit Court Judge for the 33rd District (Mississippi and Scott Counties) in 1980, thereby becoming the only Missourian to hold office in all three branches of state government. Hearnes worked for the Southeast Missouri Legal Services as executive director from 1981 to 1997. Warren Eastman Hearnes died on August 16, 2009 in Charleston and is interred in the International Order of Odd Fellows Cemetery."
