I represent the respondents (The Presbytery of Seattle, The First Presbyterian Church of Seattle, Robert Wallace, and William Longbrake) in No. 20-261. Petitioners Jeff Schulz, et al. filed their petition for a writ of certiorari on August 28, 2020, and our response is due October 2, 2020.

In accordance with Rule 30.4, we respectfully request a 31-day extension of the current October 2 deadline, which would make our brief in opposition due on or before Monday, November 2, 2020. We have been asked for (and have granted) consent to the filing of an amicus curiae brief in support of petitioners. We inquired of counsel for the prospective amicus when we should expect to receive that brief, and we were told that it would be filed on or before October 2.
