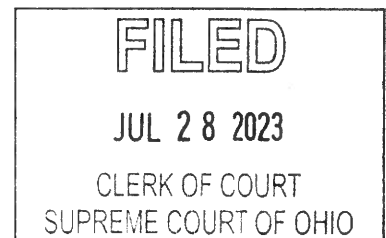
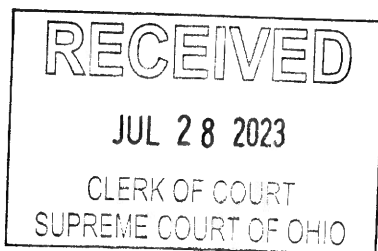
INTERSTATE BUILDING MAINTENANCE (ET/AL)
