Couple embarks on renovation of Main St. buildings in Wappingers Falls

Angela and Anthony Hardisty, with Sam's Realty in Beacon, have big plans for the buildings they are renovating on West Main St. in the Village of Wappingers Falls.

At 2701 West Main St. Anthony said they plan for a boutique shopping center with eight or nine boutique shops. They are currently seeing how much room each interested business will need, he said.

So, what made them start this undertaking?

"We wanted long-term income and we wanted to build it ourselves," responded Anthony. "We thought this was a good way to go."

As for why they chose the Wappingers Falls, Anthony explained, "We think Wappingers Falls will be the next beautiful place to visit."

Though they are from the City of Beacon, Anthony said he and Angela "wanted to try and help the Village out and to have more of an impact."

Anthony explained with the renovations, "You need somebody that is motivated and can pull the trigger and do it."

Anthony said the feedback he has been receiving has been positive. "Ninety percent of people have been saying 'We needed this,'" Anthony said about the updates to the buildings.

The work though, at times, "has been much more difficult than I thought; it's been a learning process," he said. The Wappingers Falls officials have been easy to get along with he remarked.

Upstairs at 2701 W. Main there are 13 apartments. There are 11 one-bedroom apartments. Two apartments have two bedrooms.

Howland Public Library vote set for April 27

Kristen Salierno, Howland Public Library Director reminds registered voters who live in the Beacon City School District that the upcoming library budget and trustee election vote will be from noon – 8 p.m. on April 27. This year the vote will be held in the Community Room of the library. Absentee ballot applications can be obtained at the library or on the library website at beaconlibrary.org. Absentee ballots applications must be returned by 5 p.m. on April 26th, said Salierno. The official completed ballot must be returned to the library no later than 5 p.m. on the day of the election/vote, April 27.

Budget

The proposed increase this year is 7%, said Salierno. "As always, the Board of Trustees is committed to keeping proposed increases reasonable while making progress to expand staff and services to meet community needs," according to Salierno. For a full detailed look at the proposal please see the proposed budget document.

"If the budget passes, it will enable the library to once again increase the number of e-books available to patrons, which continue to be in high demand," stated Salierno. "It will increase the budget for Hoopla, which supplies patrons with e-books, e-audiobooks, e-comics, movies, and music. Finally, it will allow for a salary reconfiguration, that would allow for staff members who hold a 4-year degree or higher to earn what is considered a livable wage in Dutchess County, based on the MIT Living Wage Calculator. The Board of Trustees is committed to the Library's ability to attract and retain outstanding staff members," remarked the director.

Trustee Election

For the trustee election there are two five-year terms open. Four community members will be running at-large for the two open seats. The candidates are listed below along with their statements.

Renegades rout Ironbirds to win first series of season

The series was practically over before it began.

The Hudson Valley Renegades won their six-game series against Aberdeen by sweeping the first four games at Heritage Financial Park, including a 4-1 win on Friday night.

The winning streak was snapped on Saturday and Sunday when the Ironbirds won by scores of 2-1 and 5-4 respectively.

On Friday, both teams had to endure an 85-minute rain delay just before the first pitch when a storm rolled through. Both squads received great starts from their starting pitchers. For Aberdeen, Jake Lyons allowed just a walk and two hits in four scoreless innings. He retired the final seven batters in his outing.

Zach Messinger fired his second quality start of the season in his second outing of the season for the Renegades. The right-handed pitcher allowed just three hits and struck out seven across 6.0 innings. He worked around traffic on

the base paths throughout his night, stranding runners on base in each of the first five innings, including four in scoring position.

Hudson Valley put together a two-out rally off Daniel Federman in the seventh. After he recorded the first two outs of the frame, the next five men reached base. Kyle Battle walked and stole second to place himself in scoring position, and Caleb Durbin punched a ball through the left side of the infield to score Battle with the game's first run. After Ben Rice was hit by a pitch, Dylan Heid entered the contest for Aberdeen to face Spencer Henson, who doubled to plate two runs and push the lead to 3-0. Henson later scored on a Luis Valdez error to grow the advantage to 4-0.

Hudson Valley's Harold Cortijo (2-0) fired 1.1 scoreless innings of relief before giving way to Jack Neely in the eighth with a man on first. Neely allowed a double to Dylan Beavers, but stranded both men in scoring position.



Anthony stated that every one of the apartments is different. "Some have mountain views. Some have waterfall views." The apartments have walk-in closets. Angela, he noted, is a designer and "literally each one is designed differently."

The process of working on the buildings with his wife has been "very good," he said. "She designs. I build," he noted.

Kate Baumann, with Rooted Yoga, which is located at 2701 W. Main St., said, "I moved into the village about [three] years ago now and I immediately knew I wanted to be part of the community. You could see the potential to be great, but it needed that loving touch to help create that. That's exactly what Anthony and Angela are bringing to the Village. They're bringing life back and they're allowing it to thrive even more than it is

now. Their visions for the village have allowed me to open my dream yoga studio, and I can imagine they'll be making a lot of other small business owners dreams come true too."

Across the street, at 2692 West Main St. the couple plan of building a "row bar or sushi bar," explained Anthony. It will be two floors of restaurants. They will not run the restaurants, he said. The couple will just own the building.

Then at 2695 West Main, Anthony talked about having three small apartments with a storefront on the bottom.

The buildings should be completed within the next few months, he said.

"I just enjoy changing it to something really nice," he said.

Asked about if he and his wife plan to renovate any other buildings in the Village, Anthony replied, "I'm sticking to this side for now."

As for the future of the Village, Anthony said, "I hope it stays a nice and quaint village."


During the gala Nancy Belok, a founding member of the Medical Advisory Board, and Dr. Gueslin Joassainvil, founding director of the clinic, will be honored.

"For 21 years, I've watched the Vassar students be completely engaged in supporting the projects they've helped to create. Their commitment and enthusiasm has truly been an inspiration," said Belok.

Dr. Gueslin stated that "The Haiti Project is more than an organization but a family of people with great hearts. I send my appreciation to all of you through the magical words "I love you".

Isabel explained what the funds will be used for that are raised from the gala. "The proceeds from this event will be used to fund the clinic for another year. The annual expenses include paying our doctor and nurse's salaries, covering the cost of medications (we have a free pharmacy for patients), and ensuring that the clinic physically is kept in the best condition possible. The funds also are used to expand the care that can be provided to patients. For instance, we are in the final stage of building a solar lab which will mean that specimen testing can now be held on site as well as the storage of vaccines. With this lab, in the future patients will be able to get the life-saving vaccines that we so often take for granted here in the U.S.," said Isabel.

Lila Meade, who co-founded the Vassar Haiti Project with her husband Andrew Meade, said, "The ability to serve thousands of patients who normally would not have access to medical care through this fundraiser is a joy! Watching Vassar students take on the millions of details that compose putting on an event like this is transformative to them and to the outcome of the event. While we've planned the Art & Soul Gala eleven times over the past, this year's planning is special because we will be able to return to being



County announces resurfacing, reconstruction projects

The Dutchess County Legislature unanimously approved a resolution authorizing the issuance of \$9,447,724 in bonds that will be used to pay for a portion of bridge, culvert, and highway improvements in the County. The total cost estimated to complete the proposed projects is \$14,643,542 and the remaining balance will be paid using funds received from New York State through the Consolidated Highway Improvement Program (CHIP), PaveNY, and Extreme Winter Recovery Aid.

"I applaud the Dutchess County Department of Public Works efforts in getting these dollars on the ground to ensure that our public highways are as safe and drivable as they can be," said Dutchess County Legislature Chairman Gregg Pulver. "In an effort to prevent our local roads and bridges from deteriorating, it is one of the Legislature's top priorities to ensure that these roadways are safe and dependable so that our neighbors have roads that they can rely on."

"As Chair of the Public Works Committee, I know that investing in our infrastructure needs to be a top priority of the Dutchess County Legislature, and I am proud to support this measure that will help ensure our transportation systems are dependable for our county's residents," said Legislator John Metzger. "Having safer roads and bridges paves the way for future economic development, and I thank the Department of Public Works for their efforts in ensuring our public roadways are second to none. Dutchess County has a proven record of getting funds out the

door that protect our infrastructure, and this is another clear example."

Included in the proposed projects include the resurfacing or reconstruction of 12-15 miles of County highways. Other projects include:

- Bridge WP-34 replacement on CR 110 (Jackson Road) over Greens Pond Outlet in the Town of Wappinger

- Bridge M-20 replacement on Salisbury Turnpike over Little Wappinger Creek in the Town of Milan

- Bridge S-13 replacement on CR 53 (Cold Spring Road) over Wappinger Creek in the Town of Stanford

- Bridge D-34 replacement on Ridge Road over the Mill River in the Town of Dover

- Bridge D-66 replacement on CR 6 (Old Route 22) over Swamp River in the Town of Dover

- Bridge W-21 replacement on Stanford Road over East Branch Wappinger Creek in the Town of Washington

- Culverts PA-37 and PA-40 replacement on CR 69 (Harmony Hill Road) over an unnamed creek in the Town of Pawling

- Culverts D-6 and D-7 replacement on CR 23 (Little Rest Road) over an unnamed creek and CR 24 (Chestnut Ridge Road) over an unnamed creek in the Town of Dover

- Culvert M-29 replacement on CR 52 (Round Lake Road) over an unnamed creek in the Town of Milan

- Culverts PA-1 and PA-4 replacement on CR 68 (North Quaker Hill Road) over an unnamed creek in the Town of Pawling.


Mental Health America to inaugurate new Veterans One Stop Facility in Pleasant Valley

Officials from MHA and Dutchess County, including County Executive William F.X. O'Neil and Veterans' Services Director Adam Roche, will be available to discuss the new facility.



The Roosevelts before Eleanor and Franklin

Although the photograph is faded from age, it gives us personal insight into the so-called "Gilded Age," and the kind of jostling for greater social, political and economic standing that could go on through strategic marrying. The words "Sally Delano" scribbled on the back of an old photograph caught our eye.

When we think of the Roosevelts, especially through the lens of Dutchess County, we think of President Franklin Delano Roosevelt of Hyde Park, and his wife (and cousin) Eleanor Roosevelt.

But this photograph takes us back a generation to Sarah Delano (the woman seated to the left in a lighter dress) who was known by family and friends as "Sally," and who became known to the world as FDR's mother. At the time of the photograph, which we believe to be around 1878, Delano was a few years away from marrying the much older James Roosevelt of Hyde Park in 1880, which led to the birth of their only child, Franklin Delano Roosevelt, in 1882.

Printed on the back we learn that the photographer is named "C.W. Pach" at 841 Broadway, New York City. Its branches are listed as "Harvard, Yale, Poughkeepsie" and the elite summer ocean resort towns of "Long Branch and Ocean Grove, New Jersey."

We can tell by the clothing, and a few holding whips that would be used in horse riding, that the words on the back that say, "an excursion," refer to an excursion to a horse-riding park.

The two young women standing at the back, who appear to wear hats that are similar to a man's top hat, are actually wearing outfits that ladies would wear when riding a horse. They would sit side saddle. The dress had to be configured in just the right way to accommodate this. Her hat had to be firmly fixed. And the lady rider would need to rely on a gentleman to help her be properly

seated on the horse.

Those two women stand out for other reasons that relate to the drama of the Roosevelts. The woman to the left is (as is indicated on the back of the photograph) "Bamie Roosevelt." Bamie was a nickname for Anna Roosevelt, the older sister of siblings U.S. President Theodore Roosevelt, and Eliot Roosevelt, the father of the better-known Eleanor Roosevelt who was both FDR's cousin, and wife.

Bamie was known as a pillar of strength in the family, stepping in when her younger brother, Theodore, lost his mother, and his wife in childbirth within 24 hours. Bamie took responsibility for the newborn Alice Roosevelt until Theodore could get back on his feet. Bamie also stepped in when her youngest brother, Eliot, was committed to an asylum, leaving a six-year-old daughter, Eleanor who we mentioned earlier, needing guidance and guardianship. Although Bamie was helpful to a young Eleanor, over the years their relationship grew strained as the Theodore Roosevelt branch of the family struggled to regain the upper hand in national politics.

President Theodore Roosevelt's son, Theodore Roosevelt, III, launched a political career at the exact time that Franklin Roosevelt did. The former was a Republican, and the latter was a Democrat. Franklin was clearly having more success. This put a strain between Bamie and Eleanor.

Standing to the right of Bamie is Kassie Delano, the younger sister of Sarah Delano. Although Sarah Delano Roosevelt disapproved of at least the timing of Franklin and Eleanor's conjugal plans, Kassie was, in part, responsible for it happening when she was loose in her role as chaperone of the two. While she left them alone, it was then that FDR proposed to Eleanor.

Sarah married James Roosevelt in 1880 and FDR was born in 1882. The

age difference between James and Sarah Delano Roosevelt is revealed when we understand that James Roosevelt had two grandchildren through his first wife born just before his son FDR was born through his second wife. James had two grandchildren, and a son, close in age.

The gentleman standing at the left behind Sally Delano is Homer Ramsdell of Newburgh, whose father founded the Ramsdell transportation corporation and was involved with the Erie Railroad.

At the far right, seated, is Mr. Julian Weir. He was the son of West Point head of art and Hudson Valley landscape painter Robert Weir, and became a well-known artist in his own right.

The gentleman second from the right is Henry Sayre Van Duzer. Like the Roosevelts, he descended from the earliest Dutch settlers in the Hudson Valley and came from generations of successful business dealing. The gentleman third in from the right is George Wallace Forsyth, another successful

Newburgh businessman. The woman seated, in dark clothing, just to the right of Sarah Delano is Miss Katherine Sayre Van Duzer, seated and in dark clothing, is the sister of Henry Sayre Van Duzer.

The photograph is from the Wing family (of Millbrook) Collection. The Wing family estate was known as Sandanona in Millbrook. Although we do not yet understand the exact connection, one of the last generations of Wings to live there was Henry Van Duzer Wing (1913 to 1983). Through marriage or high regard (we are not sure which) we have seen another connection or alliance or allegiances of two great Hudson River Valley families.

Renegades rout Ironbirds to win first series of season

The IronBirds threatened in the ninth by loading the bases and scoring their lone run on a wild pitch by Neely. After Jud Fabian walked to load the bases once again and bring the tying run to the plate, Bailey Dees entered and struck out Beavers to end the contest and earn his first save of the year.

The Renegades have run out the bats and the pitching so far in this series with victories by the scores of 15-1, 12-5, 6-4 and 4-1.

In Sunday's series finale, both sides stormed out of the gates with three runs in the first inning. Drew Thorpe walked Frederick Bencosme to open up the contest before a pickoff error by Thorpe allowed Bencosme to advance to second. He would later reach third on a passed ball and score on a wild pitch. The next batter, Max Wagner, would walk, and Adam Retzbach crushed a two-run home run to finish off a three-run top of the first.

Hudson Valley responded immediately with three runs of their own in the bottom of the first. Leadoff hitter Spencer Jones walked, stole second, and advanced to third base on a pickoff error by Kyle Virbitsky. With runners on second and Jones at third, Caleb Durbin laced a two-run single to left-center to cut the IronBirds lead to 3-2. Durbin then stole

second and advanced to third on a Retzbach throwing error. Antonio Gómez brought in Durbin with a groundout to shortstop to tie the game at 3-3.

Both pitchers settled in until Aberdeen struck in the top of the fifth. Luis Valdez led off the inning with a single and advanced to third on a throwing error on a pickoff attempt by Gómez. Thorpe then uncorked a wild pitch to score Valdez and put the IronBirds back in front 4-3.

The Renegades rallied back in the sixth on an Aldenis Sánchez sacrifice fly. Gómez notched a one-out double, and reached third on a Spencer Henson single, setting the stage for Sánchez' sac fly to tie the game at 4-4.

For the second straight day, the game's decisive run came in the top of the ninth for Aberdeen. Ryan Higgins bunted his way aboard with a single, followed up by an Isaac Bellony single off Ryan Anderson (0-1). Back-to-back flyouts by Noelberth Romero and Luis Valdez scored Higgins to hand Aberdeen the 5-4 advantage.

Hudson Valley goes on the road for 12 games to end the month, including six against Rome and six against Greenville.

'I'm only in competition with myself.' Renegades' Jones shrugs off early comparisons to Judge

Spencer Jones dismisses all of the comparisons.

Yes, he also bats right-handed and is known for hitting titanic home runs.

Yes, he also is a strong defensive performer in the outfield.

Yes, he stands well over 6 foot, comes in just three inches shorter than the 6'9" Aaron Judge.

And yes, he bears an uncanny resemblance to the New York Yankees captain and superstar.

But that's where the comparisons end. Or that where Jones wants them to end.

"He is an incredible player obviously," Jones said of the reigning American League Most Valuable Player. "But I just have to be me and not get caught up in comparisons."

Jones, who won't turn 22 until mid-May, was hitting .379 to begin the season with the Renegades. He is the next logical person to move through the Yankees farm system, much as shortstop Anthony Volpe did. Volpe played in 55 games for the Renegades as recently as two years ago, and found

himself the starting short stop of the Yankees on opening day last month. He set a Yankees team record for most stolen bases by a Rookie in a game with three on Saturday.

"Again, I try not to compare myself to anybody else," Jones said. "I'm only in competition with myself."

Jones is one of the top prospects for the Yankees and was the 25th overall selection in the 2022 amateur player draft. Jones, who, like Judge, is from California, originally committed to Vanderbilt University. He decided to pursue his dream instead after being drafted by the Yankees. Judge hails from Sacramento, Ca., while Jones grew up near San Diego in Encinitas, Ca.

"My role here?" Jones said. "I don't think I have a role here other than to drive in runs and get better and progress through the system."

"He's definitely a special kid," Renegades manager Sergio Santos said. "He can definitely do some special things."



TYSON'S TIDBITS! Dealing with the super-early start and engaging fans in fun environment



Every week, new Renegades general manager Tyson Jeffers will sit down with reporter Rich Thomaselli and talk about the team in particular, and minor league baseball in general.

You started the season with a nine-game homestand. Was that a good thing?

I think we would have liked an extra week, like some teams had, just to get the ballpark ready. But we are pretty happy and pleased with the way things came out. I mean, we got lucky with some great April weather. In future years, if we base it on this, I don't think it comes off very well. But we're happy that we had 60-70- and even 80-degree days. Historically, you just don't get

that in April.

What about you in particular? You have a background with the Renegades, so you kind of knew how things ran. But is it different when you are the one making the final decisions?

I try to get out of the office and talk to our fans, and talk to our staff. I always tell people, 'if you want to work here and you want to work in baseball, that's great. But you can be the biggest baseball fan in the world, and you're never going to see a game from start to finish.' There's obviously some pressure there as we try to take care of our customers. We want to continue to have a customer-first centric. Our staff and I, we are never on the defen-

sive. I mean, you try to be perfect, but nobody is perfect.

Did you learn anything from the first home stand?

Just to be detail oriented, and see things from a fan's perspective. Make notes. See what works and what doesn't, and then regroup and try to put it all together with our staff. We've already been getting good feedback from our fans. Whether it's operationally or the ballpark experience, people have brought up some great things. We have been collecting our own data, so when the team is on the road for the next couple of weeks, we can implement some things - and go

100 miles an hour by the time they get back. We want to be in mid-season form by the time the team gets back.

Steve (longtime GM Steve Gliner) said he rarely, if ever, was able to watch a game from start to finish. Have you found that to be true?

There's never going to be a time when I sit down and watch the game from start to finish. Steve learned that early in his career. And that's just the nature of the beast. Too many things to tend to, and too many things that pop up during the course of a game that you just didn't think about. We're really just engaged with our fans. It's a fun environment to be around.

Learning how to swim

I put on my giant orange life vest in no time and jumped into the pool. Proudly I paddled my way around the pool, showing off how I could swim with my giant orange life vest. Looking, I am sure, like a proud little poodle. Arms and legs frantically churning under water. My head sticking out from my giant orange life vest.

My uncle, seeing how well I was doing, reached down and grabbed me by my

giant orange life vest and pulled me out.

"Ima gonna teach you how to swim sensa (without) the vesta," he told me. I was so excited that I was quickly graduating to the next level. I was sure that no one ever advanced so quickly. I was sure that I was going to be an Olympic swimmer. I quickly took off my vest ready for the next step in my swimming education.

"Youa ready?" he asked me. I just nodded my head, ready for my lesson. I turned around to see all of my cousins looking at me with smiles on their faces.

Wait, that wasn't a smile. They were all holding in laughter. Why were they all looking at me that way? I was going to be the next great Olympic swimmer! They shouldn't laugh at me.

I turned back to my uncle with a look of anger. I looked up to him as he reached out and grabbed me by the arms. It was in that split second that I realized that all my cousins were taught to swim the same way. It was also in that split second that I realized how my lesson was going to be conducted. I also realized that I was flying in the air into the deep end. Somehow I knew enough to hold my nose and my breath as I hit the water.

It's funny how when you're underwater how quiet and still everything is. It's rather peaceful. I could see everyone's legs and all the different colored swim suits. As I started to float up, my legs and

arms started paddling just like they did with my life vest on. When I broke the surface of that water, I had that feeling of fear, excitement, relief and pride all at once. I started to laugh and cry at the same time and everyone started to cheer. I was swimming all by myself.

I looked up to my uncle and he was cheering louder than everyone else. He was yelling "Forza, forza!"

It's funny, today you go to swimming lessons, skiing lessons, riding lessons, karate lessons, bicycle lessons, dance lessons, etc. When we were kids we were just thrown into the pool. Enjoy this recipe for grilled lemon mint chicken. Buon Appetit!

Lemon Mint Chicken

Ingredients

8-10 pieces of chicken drums and thighs

- 1 cup olive oil
- zest from one lemon
- 1 cup lemon juice
- 10 fresh mint leaves
- 5 garlic cloves
- 1 tablespoon brown sugar
- 1/2 teaspoon salt
- 1/4 teaspoon pepper
- 1/4 teaspoon oregano
- 1/4 teaspoon ground rosemary
- 1 cup white wine

Method

- In a food processor or blender place

the olive oil, lemon zest, lemon juice, mint leaves, garlic cloves and sugar and blend till creamy.

- In a small bowl mix the salt, pepper, oregano, and rosemary.

- Rub each piece of chicken with the spice mixture and place in a roasting pan.

- Pour the marinade over the chicken, wrap in plastic, and let sit over night or at least 12 hours.

- Light your grill and close the lid to make sure it reaches a high temperature. 500 degrees if you are checking.

- Place the chicken skin side down and let it grill for 5 minutes. Remove and place in the marinade and grill the other side for 5 more minutes.

- Repeat the process for each side again.

- Turn off the grill and let sit for another 5 minutes on the grill before serving.

Serve with a nice Pinot Grigio.

Luigi Coppola is one of five brothers born to Francesca and Antonio Coppola. The Coppola family came to America from Naples, Italy in 1954. Antonio and his brothers opened their first restaurant in Poughkeepsie in 1961. 


