

MEMBERSHIP CATEGORIES

Voting Members:

**Lawn Care
\$150/year** Any company engaged in the commercial application of fertilizers and pesticides to trees and turf which meets all federal, state, and local licensing requirements.

**Individual
\$30/year** Any employee of a lawn care member organization. (Company must also be a member).

**Sponsor
\$225/year** Any company engaged in selling products or services, wholesale or to the tree and lawn care industry.

**Associate
\$200/year** Any organization or city, other than lawn care companies, interested in the care and maintenance of trees and turf.

**Educator/
Alumni
\$30/year** Person(s) involved in teaching horticulture and green industry practices, including extension agents & alums who have been regular members.

Non-Voting Members:

**Student
\$30/year** Any person currently enrolled full-time in a course relating to the care and maintenance of turf.

PRIVILEGES OF MEMBERSHIP:

Voting Members are eligible to participate in the Association by holding elective office, receiving mailings, attending meetings, receiving research results at no charge, including the Association logo in their advertising, and benefiting from any advertising or promotion done by the Association.

Non-Voting Members have the same privileges except the right to vote.

CALCP CODE OF ETHICS

This Code of Ethics is adopted by the Colorado Arborists and Lawn Care Professionals (CALCP) to promote and maintain high standards of public service and conduct within our membership and the turf care industry.

Each member agrees to:

1. Conduct services first and foremost with regard to the safety, health and welfare of the general public.
2. Provide services, recommendations and information based upon honest, scientific, accurate, and factual knowledge.
3. Be responsible for the protection and preservation of our most valuable resource — the environment.
4. Operate in a safe manner in handling all products, and monitor safety and environmental factors relating to services performed.
5. Abide by all laws and regulations affecting lawn and landscape companies, and support the enforcement of these laws.
6. Refrain from the use of false, misleading or deceptive marketing or advertising practices that may result in the degradation of the professional industry image, or injure the professional image of fellow lawn and landscape professionals.
7. Utilize sound professional management practices and encourage associates/employees to respond to their peers in a like manner.
8. Recognize the importance of a strong relationship with vendors (suppliers, manufacturers, distributors, and business service providers). Members shall follow all directions and recommendations of products and equipment. In turn, product testing and use results must be reported accurately by all vendors. Both vendor and user obligations must be met in a timely manner.
9. Help customers, non-member industry representatives, suppliers and fellow lawn and landscape companies become aware of the standards set forth in this Code of Ethics.
10. Participate in Association activities and events to help further the profession.
