The past few years have brought immense challenges, and 2023 was no exception. We've been called to respond to pervasive poverty and hunger. Continued ramifications of the mental health epidemic. Escalating antisemitism and struggles in Israel that threaten to tear apart the country's social fabric. It can feel daunting, but we've been able to meet these challenges head-on thanks to your incredible generosity and determination to help those most in need.

How you helped us help others.

You helped us fight antisemitism. Our Community Security Initiative (CSI) — launched in 2019 with your support — helped thwart a potential terror attack on New York City synagogues in November. We funded an initiative to train public school teachers in how to educate their students about contemporary antisemitism and Israel.

You helped us continue to be there for Ukrainian refugees more than a year after the violence broke out. We're helping them acclimate to new lives in Europe, in Israel, and in New York.

Your leadership helped usher in a new era for Israel with the Jerusalem Arts Campus — a center for culture, diversity, and inclusion in the heart of Israel's largest city.

Your generosity helped transform our Henry Kaufmann Campgrounds to welcome thousands of children of all ages, abilities, and backgrounds this past summer. And it's helping build the Brooklyn Hub — opening early in 2024 — to uplift the lives of those entrenched in poverty, just as our Jack and Shirley Silver Hub in Queens, and satellite hubs in New York neighborhoods, are doing so successfully.
