#### **Field Trips**

The FMA takes two educational field trips per year. This past year, the FMA visited both Cincinnati and Chicago. The field trips provide an opportunity for the members to meet prospective employers, get a feel for what an average workday is like in different industries, and see new cities.

#### Cincinnati Field Trip

On September 22, 2000, the FMA took a field trip to Cincinnati, Ohio. Fifteen students attended the daylong field trip to Cincinnati. The students visited the Procter and Gamble Company, Chiquita Brands International, and General Electric.

#### Chicago Field Trip

The Financial Management Association International National Honor Society recognizes scholastic achievement through induction of students whom have demonstrated superior scholarship. Individuals accepted for membership in the Honor Society have the distinction of belonging to the ONLY international honorary which specifically recognizes the achievement of finance majors and demonstrates their expertise in areas such as financial economics and decision making. To be eligible, a student must possess a GPA of 3.25 or higher overall or in 300+ business courses in addition to the successful completion of a minimum of six hours in **finance**. #### FMA Awards 2000-2001


