<u>Description of Supplies/Services Required to Meet the Agency's Needs</u>: Furnish and install Audi-Video Conferencing equipment, to include a Polycom HDX8000 with an Eagle Eye Camera, and related Software, to upgrade the video teleconferencing equipment in the Learning Exchange at VAPHS, Heinz Division. The cost of the service is \$42,307

Scope of Work:

- The VA will supply a Polycom HDX8000 with an Eagle Eye Camera. The system codec will be installed in the rack. The codec will be configured for IP network only. The codec will support People and Content
- Install VA supplied Eagle Eye Camera on the front wall
- Provide and install an Eagle Eye Camera on the rear wall
- Provide and install camera shelves for both cameras
- The AMX programming will be changed to support the new VTC system in the LEX and to remove the tie from the Annex Room for VTC capabilities
- Programming to support audio reconfiguration of the existing system
- On-Site Training: 1 session for up to 2 hours for 5 participants
- Ceiling Modifications to allow for cable installations
- Cutting, Patching, and Painting
- All necessary electrical requirements
- All necessary data requirements
- Daily Clean Up and Supervision

FAR 6.302-1. Equipment is being integrated into an existing conference room system designed and installed by Hi-Def. Because of the complexity of the existing system and Hi-Def being the original installer and designer, will save the government time and money with using the vendor that provided the original system. Hi-Def has designed the standard for VAPHS.

All of the video teleconferencing work within the HZ Learning Exchange has been completed by Hi-Def so they have specific, technical knowledge of the building, the ductwork layout and any network issues that may be present within the building. Using another vendor at this point, would degrade the quality and functionality of the equipment.

Hi-Def Contracting has completed several projects at VAPHS. They consistently perform at a high level completing each project within budget and on time. Hi-Def is a local company which will enable them to complete the requested service within the timeframe required as to not delay this work requested for the HZ Learning Exchange.

<u>Determination by the Contracting Officer that the Anticipated Cost to the Government will be</u> Fair and Reasonable:

The Contracting Officer has obtained information from Hi-Def Contracting that verifies that they are charging the VA \$3,332 for the Camera for this proposed contract, and that they had charged the VA \$2,990 for the same Camera on a previous VA Contract VA244-13-C-0197. In addition, the information obtained also verified that Hi-Def Contracting is charging the same labor to install the Camera for this proposed contract, as they did to install the same Camera, under the above mentioned previous VA Contract. In addition, the COR of the previous above mentioned VA Contract, has indicated the overall price for equipment and services is fair and reasonable. (See emails from Hi-Def and VA COR Jeff Vuiller under S23, in the Solicitation Action Briefcase of the Contract File. In addition, the current COR Kimberly Toland has indicated that the price being charged by Hi-Def Contracting, is known to be typically low in price (lower than previous IGE and competitor's quotes, when competed).

<u>Description of the Market Research Conducted and the Results, or a Statement of the Reasons</u> Market Research Was Not Conducted:

Contracting Officer queried the GSA Federal Supply Schedule (FSS), only to verify that Hi-Def Contracting does not have a GSA FSS Contract. No other Market Research was conducted on the FSS, since all of the video teleconferencing work within the HZ Learning Exchange has been completed by Hi-Def Contracting, that has allowed them to have specific, technical knowledge of the building, the ductwork layout and any network issues that may be present within the building, thus making them the only responsible source, for this acquisition. Using another vendor at this point, would degrade the quality and functionality of the equipment. For this reason, the Contracting Officer has justified not using Federal Supply Schedule Contracts for this acquisition, and has obtained an Open Market Quote from Hi-Def Contracting, who is a local SDVOSB and is able to mobilize ASAP in order to meet the VA's tight time-frame for project completion.

The Sole Source to Hi-Def Contracting, as Service Disabled Veteran Owned Small Business in the open market, is based on the need to achieve continuity of the equipment/system design already installed in other VAPHS facilities by Hi-Def. Seamless connectivity and integration with existing VTC conference room systems already in place is important.

The items and services have been performed by Hi-Def Contracting in the commercial market and for the Federal Government, and therefore are considered commercial items.
