# 1. GENERAL DESCRIPTION

Poly Processing's SAFE-Tank® is a "tank-within-a-tank" system. These tanks provide secondary containment to avoid the damaging of equipment or property, loss of chemical, or injury to employees in the event of a spill.

Double wall (Safe-Tank®), flat bottom tanks are manufactured of high density cross-linked polyethylene (XLPE). The assembly consists of one cylindrical, closed top inner primary tank and one cylindrical, open top containment outer tank. Each tank is a rotationally molded one-piece seamless constructed tank. The SAFE-Tank® tanks are designed for above-ground, vertical installation.

The SAFE Tank® is manufactured for Viking by Poly Processing to Viking's specifications. The original manufacturer's documentation supersedes this document in any circumstance. Always refer to the original manufacturer's documentation for the most current information.

# 7. INSTALLATION

Place the tank in the desired level location and if necessary, anchor to the floor. Leave an area around the tank free from any walls or obstacles for a working space for connecting the foam system piping to the tank. When all piping is completed, using the drop tube fill connection off the top of the tank, fill to desired level. The top suction and fill connections are drop tubes into the tank and are supported at 6' maximum intervals. Drop tubes are of PVC material. A Pressure Vacuum Vent is provided off the top of the tank for venting.

The SAFE-Tank® polyethylene tanks are provided with inspection hatches and must be adequately vented as shown in Table 4.1. Tank shall be provided with ancillary mechanical fittings and accessories as required.

#### **Footnotes**

When using 3% XMAX type foam concentrate in any atmospheric type storage tank, it is recommended that a thin layer (approximately 1/4 inch) of a quality mineral oil be placed on the surface of the foam concentrate after filling the tank with the correct quantity. This alleviates the problem associated with evaporation of the foam concentrate.

Stainless steel pipe is suitable for use with Viking manufactured 3% XMAX types of foam concentrates. Galvanized pipe should not be used with any 3% XMAX concentrate. Foam concentrates have a solvent in their formulation, which may dissolve standard pipe joint compound (pipe dope) normally used with plain water sprinkler systems. When installing a foam water fire protection system using foam concentrates, it is recommended where the concentrate or the solution is in contact with any pipe joints etc., a quality PTFE tape in accordance with MIL-T-27730 and a PTFE based pipe joining compound be used on all threaded fittings.

If any foam concentrate spills on any painted surface during any filling of the storage tank(s), immediately wash the area with water. The solvents in the concentrate may cause streaking of any painted surface. It is recommended that when using non-freeze protected foam concentrates, that the foam tanks be located in an area that is kept between 35 °F - 120 °F (2 °C - 49 °C). All tanks offered by Viking are suitable for use with Viking manufactured and supplied foam concentrates.

## 9. INSPECTIONS, TESTS AND MAINTENANCE

### **A** WARNING

Any system maintenance or testing that involves placing a control valve or detection system out of service may eliminate the fire protection capabilities of that system. Prior to proceeding, notify all Authorities Having Jurisdiction. Consideration should be given to employment of a fire patrol in the affected area.

### **NOTICE**

The owner is responsible for maintaining the fire protection system and devices in proper operating condition. For minimum maintenance and inspection requirements, refer to recognized standards such as those produced by NFPA, LPC, and VdS, which describe care and maintenance of sprinkler systems. In addition, the "Authority Having Jurisdiction" may have additional maintenance, testing, and inspection requirements that must be followed.
