MISSION: To support and empower young people on their journey to self-reliance.


You helped us focus on what really matters.


With the reimagining and redesign of our building, we took a step back to reflect on how we were delivering services to ensure that all young people have equal access. Through focused discussions with young people, the community, and our partners, we complemented the changes in our building by also redesigning our services with a focus on transformative partnerships. Drop-in time remains easily accessible, but we now have focused periods during which young people can receive one-on-one time with Transition Coaches to discuss future-focused topics like financial planning, education goals, and housing needs. We also use this time for community dinners, family reunification, and specialized gatherings, such as meetings of our men's group and independent living instruction—providing access to skills that can get overlooked during the rush to get basic needs met.

Our ultimate goal is to help youth be more successful through intentional, one-on-one time. When they walk through the doors it should be easy for them to access the services they need as individuals.

You helped us protect the most vulnerable during the Super Bowl.

Your support put YouthLink at the forefront of confronting sexual exploitation during the biggest event in Minnesota in 2018: the Super Bowl.

Working with social service providers from around the city, as well as the Minneapolis Police Department,
YouthLink's Intervention Transition Coach helped develop a working plan to keep vulnerable people
safe from the risk of sexual exploitation during the festivities surrounding the Super Bowl.

In fact, our Intervention Transition Coach was the only service provider to work directly with law enforcement
at the Super Bowl Command Central, helping to provide services to sexually exploited youth
during the lead up to game day, the playing of, and following the Super Bowl.

You helped us care for the whole person.

Young people visiting YouthLink seek out services because they are in crisis. YouthLink works to meet young people where they are and provide short-term solutions to bridge gaps during their crisis, but we know that long-term solutions and holistic care can change the trajectory of a young person's journey.

Thanks to significant support from the Medica Foundation, YouthLink has developed an Integrative Health and Wellness Service Model that supports both staff and young people, and is designed to reduce the likelihood of further trauma, simultaneously providing young people with the ability to get their basic needs met, while also addressing their mental, physical, emotional, and spiritual needs. The Medica Foundation has helped us develop more than just a service model—the Medica Foundation Calming Room gives young people a space to relax, center themselves, and continue doing the hard work of moving forward.

Medica is excited to support YouthLink in its effort to improve client health and wellness. That work depends on having informed staff with actual experience of the healing model. We are proud of the progress YouthLink has made in staff wellness training which will prepare the organization to further support and heal the youth that rely on their services.

You helped make our dreams a reality, too.

In 2018, not only did YouthLink complete construction of Downtown View, but we also reached our \$6 million fundraising goal for our *Ignite Change in the Lives of Youth Campaign* thanks to you and members of our community. In May, we announced a challenge grant for \$100,000 from the Richard M. Schulze Family Foundation—which we were able to claim thanks to your generosity.

YouthLink's defining moment, and dream of a lifetime, came in September 2018, when the Peter J. King Family Foundation selected us to receive a \$1.4 million gift for capital costs associated with the renovation of YouthLink's building.

The Peter J. King Foundation provides brick and mortar funding to organizations whose activities are dedicated to the improvement of children's health, education and welfare, and to building a stronger family environment.

This prestigious gift positions YouthLink to impact young people as they move forward on their journey for generations to come.

You helped us create a brighter future.

A safe, warm place to call home where a good night's sleep is common is a critical step toward self-reliance.

With financial support and advocacy from the community, we partnered with Project for Pride in Living
to open 46 units of permanent, supportive housing in February 2018
for 18- to 24-year-old young people who have experienced long-term homelessness.

When the keys were handed out to the first 17 residents, all of whom had previously been living on trains and buses, these young people could start to turn their thoughts of surviving to dreaming of a future—a future of their own making.



You helped us expand education's reach.

Safe and stable housing provides the foundation for young people to continue their journey out of homelessness.

Long-term earning and learning opportunities will—and do—help young people experiencing homelessness get on the path to self-reliance. Because of that, we've worked to put tutors in each of our housing sites.

These devoted tutors don't just teach math and writing skills, they instill confidence and create bonds of trust that help young people succeed.

I love seeing the moments of accomplishment when students realize they can figure out the problem and answer the question on their own. I get to see them gain confidence in their abilities and in themselves, and that's very rewarding as a tutor.




