Subject: New Use Sites for Thiamethoxam Cruiser® Insecticide EPA Reg. No. 100-941 Your Submission Dated April 15, 2003

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following provisions:

- 1) Submit an acceptable Field Test for Pollinators. A complete worker bee life cycle study must be conducted, as well as an evaluation of exposure and effects to the queen. Please refer to the attachment to this letter for specific details regarding the information that should be included in this test and the submission dates required.
- 2) The following statement must be added in reference to the information regarding treated seed bags:
 - Treated seed must be labeled in accordance with the requirements of the Federal Seed Act.
- 3) The following information must be added to the list of specific statements that are required to be printed on the treated seed bags:
 - Treated seeds exposed on soil surface may be hazardous to wildlife. Cover or collect treated seeds spilled during loading.
 - Treated areas may be replanted immediately following harvest or as soon as practical following the last application with any crop on this label or to cucurbit vegetables, fruiting vegetables, tuberous and corm vegetables, and tobacco. For all other crops, a 120-day plantback interval must be observed.

- In order to Protect the Preble's Meadow Jumping Mouse, sunflower seed treated with Cruiser may not be planted in Elbert and Weld Counties in Colorado.
- Treated sunflower seeds must be planted at a minimum of one inch in depth.
- Wear long-sleeved shirt, long pants, and chemical-resistant gloves when applying seed treatment or handling treated seed.
- Dispose of all excess treated seed. Do not contaminate water bodies when disposing of planting equipment washwaters.
- Dispose of seed packaging in accordance with local requirements.

A stamped copy is enclosed for your records. Please submit one (1) final printed copy for the referenced label, incorporating the above changes, before releasing the product for shipment. If there are questions, please call me at (703) 305-5409.

MIXING PROCEDURES


