# Cotton (Delinted Only)

To provide early season protection of seedlings against injury by cotton aphid, tobacco thrips, western flower thrips, wireworm, and the suppression of cotton fleahopper and plant bugs, apply Cruiser 5FS at a rate to achieve between 0.300 and 0.375 milligrams thiamethoxam per seed (each fluid ounce of Cruiser 5FS contains 17.7 grams thiamethoxam).

Plant Cruiser 5FS-treated cotton seed based on specified planting dates and soil temperatures made by your state agricultural extension agent. In areas that have a history of high thrips pressure or when cotton is grown in North Carolina or Virginia, use Cruiser 5FS seed treatment followed by a foliar insecticide spray when cotton is between the 1<sup>st</sup> and 3<sup>rd</sup> leaf stage.

Do not apply a neonicotinoid insecticide within 45 days of planting seed treated with Cruiser 5FS.
