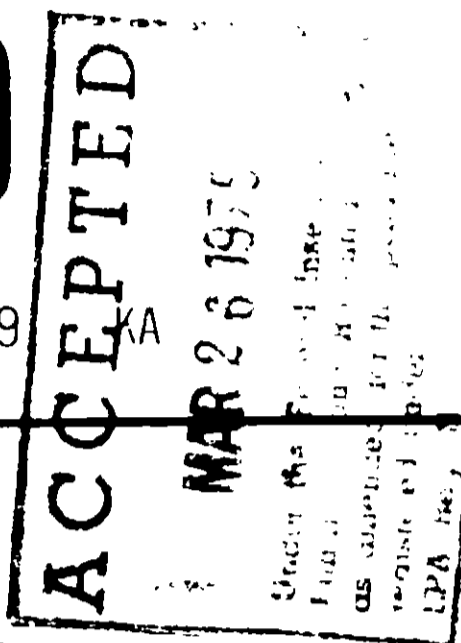

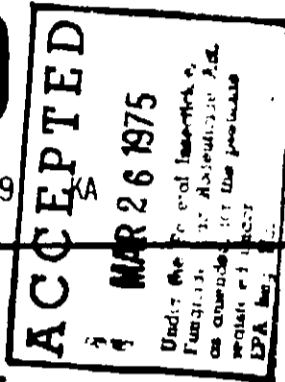

DIRECTIONS

This product is formulated for application by ground or air equipment. Begin application at first sign of insects or diseases. Repeat as necessary. Apply for thorough coverage. When disease control or to harvest is required, use a suitable fungicide also.

GRAPES. Downy Mildew, Powdery Mildew, Black Rot, Leafhoppers, Fruit Flies (*Drosophila*), Spider Mites—40 lbs. per acre. Make first application before bloom or at first sign of insects or diseases. Repeat as necessary. **Note:** During extended periods of hot, dry weather, it is injurious to several varieties of grapes may occur. Do not apply within 7 days of harvest.

MELONS, SQUASH, CUCUMBERS. Downy Mildew, Powdery Mildew, Anthracnose, Twospotted Mites, Pacific Mite, Cabbage Loopers, Armyworms, Leafhoppers—40 lbs. per acre. Make first application when first true leaves appear or when insects or diseases first appear and repeat at weekly intervals as necessary. Do not apply to cucumbers within 4 days of harvest. Do not apply to Melons and Squash within 2 days of harvest. Do not feed crop residues to dairy animals or meat animals being finished for slaughter.

STRAWBERRIES: Leaf Spot, Fruit Rot, Twospotted Mite, Red Spider Mites—40 lbs. per acre. Make first application before bloom or when insects or diseases first appear and repeat at 7 day intervals as necessary. Apply for thorough coverage. Do not apply within 4 days of harvest.

TOMATOES. Anthracnose, Tomato Fruitworms, Hornworms, Leafminers, Aphids, Red Spider Mites, Flea Beetles, Blister Beetles—40 lbs. per acre. Make first application during first bloom or when insects or diseases first appear and repeat at 7 to 10 day intervals as necessary. Do not apply within 2 days of harvest.
