# PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS CAUTION

Causes moderate eye and skin irritation. Harmful if swallowed, inhaled or absorbed through skin. Do not get in eyes, on skin or on clothing. Because of possible unpleasant side effects, avoid alcoholic beverages for 24 hours before and after working with VITAFLO-280C or treated seed.

#### PERSONAL PROTECTIVE EQUIPMENT (PPE):

Some materials that are chemical-resistant to this product are made of barrier laminate, butyl rubber, nitrile rubber, neoprene rubber, polyvinyl chloride or Viton. If you want more options, follow the instructions for Category C on an EPA chemical-resistance category selection chart.

All Mixers, Loader, Applicators and Other Handlers Must Wear: Long-sleeved shirt and long pants, shoes plus socks, chemical-resistant gloves, and chemical-resistant apron when mixing, loading, cleaning up spills, or cleaning equipment.

NOTE: Persons involved in bagging treated seed, sewing or moving bags of treated seed, or cleaning up bagging areas or seed treatment equipment are pesticide handlers and must wear the PPE required on this label for pesticide handlers.

#### AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR Part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. After seeds have been planted, do not enter or allow worker entry into treated areas during the restricted entry interval (REI) of 24 hours.

Exception: Once treated seeds are planted in soil, or other planting media, the Worker Protection Standard allows workers to enter the treated area without restriction if there will be no worker contact with treated seed or soil/media subsurface. PPE required for early entry to treated areas that is permitted under the Worker Protection Standard and that involves contact with anything that has been treated, or treated seed is: coveralls, chemical-resistant gloves made of any waterproof material, shoes plus socks.

#### **GENERAL INFORMATION**

VITAFLO™-280C Flowable Fungicide combines a systemic fungicide (carboxin) and a contact fungicide (thiram) to provide plant protection against seed and soil borne seedling diseases. VITAFLO-280C has no vapor action. Thorough seed coverage is required.

VITAFLO-280C Flowable Fungicide can be tank mixed with a metalaxyl seed treatment product (such as MetaStar™ ST) for increased *Pythium* protection and *Phytophthora* rot protection for soybeans. The low rates provided on the metalaxyl product label for application in combination with other EPA-registered fungicides to aid in control of *Pythium* may be used with VITAFLO-280C. When using combinations of products, the most restrictive of label limitations and precautions must be followed. On highly *Pythium* susceptible crops, such as sweet corn, processing peas and chickpeas, tank mixing of VITAFLO-280C with a metalaxyl product is a recommended practice.

#### SEED TREATING INFORMATION

VITAFLO-280C Flowable Fungicide is formulated both for on-farm and commercial use. DO NOT apply VITAFLO-280C as a planter box or hopper box treatment. VITAFLO-280C may be applied with mechanical, slurry, or mist-type seed treating equipment, provided that the equipment can be calibrated to accurately and uniformly apply the product to seed. Uniform application to seed is necessary to ensure best disease protection and optimum performance. Seed should be sound and well-cured before treatment.

#### ALWAYS SHAKE, STIR OR OTHERWISE MIX THIS PRODUCT WELL BEFORE USING.

VITAFLO-280C is ready to use and may be applied to seed as-is. However, dilution with water may help to achieve more uniform seed coverage when using some types of treaters and/or when treating under dry and/or hot conditions. VITAFLO-280C and water should be mixed thoroughly into a slurry before attempting to treat seed. Recalibrate the treating equipment to compensate for the addition of any water. Addition of more than 6% water is not recommended if treating seed at temperatures below 32°F. The appropriate amount of dilution water depends on the seed, the treater type and the temperature and humidity at treatment. Contact your local Chemtura representative or supplier for specific recommendations.

Treated seed may not flow as freely as untreated seed in your planter or drill. Check seeding rates and make adjustments if necessary to obtain desired seeding rate.

Any dye or colorant added to treated seed must be cleared for use under 40CFR, Part 153.155.
- 3. Plant wheat, barley and oats seed a minimum of 1 inch deep.
- 4. Do not graze or feed livestock on treated areas for six weeks after planting.
- 5. Do not graze or feed livestock on vines grown from treated bean, pea or soybean seed.
- 6. Rape green grown and harvested from VITAFLO-280C treated seed must not be used for human and feed consumption. Rapeseed grown and harvested from VITAFLO-280C treated seed is only for industrial uses and cannot be used for edible oil or any other human/feed consumption.

#### COMPATIBILITY

Do not tank mix VITAFLO-280C with any other product unless adequate physical compatibility and phytotoxicity tests have been completed and proven to be satisfactory. Do not tank mix with any product that contains a label prohibition against tank mixing.

#### TREATED SEED LABELING

Seed that is treated with this product and then packaged or bagged for future use must contain the following labeling on the outside of the package or bag:

"Treated Seed - Do Not Use for Food, Feed or Oil Purposes. This bag contains seed treated with

thiram and carboxin."

"When opening this bag or loading/pouring the treated seed, wear long- sleeved shirt, long pants, shoes, socks, and chemical resistant gloves."

"Restricted-Entry Interval (REI) After seeds have been planted, do not enter or allow worker entry into treated areas during the **restricted entry interval (REI) of 24 hours.** Exception: Once the seeds are planted in soil or other planting media, the Worker Protection Standard allows workers to enter the treated area without restriction if there will be no worker contact with treated seed or soil/media subsurface."

"Treated seeds are hazardous to fish, birds and mammals. Do not plant seeds by broadcasting to the soil surface. Ensure that all seeds are thoroughly covered with soil, especially in turn areas. If seeds are not thoroughly incorporated by the planter during planting, additional incorporation may be required to thoroughly cover exposed seeds. **PESTICIDE STORAGE:** Store in original container only. Do not store near food or feed. After partial use, replace lid and close tightly. Keep container closed when not in use. Store in a secure place that is dry, temperate and out of direct sunlight. Do not store VITAFLO-280C at temperatures above 95° F. ALWAYS SHAKE OR STIR PRODUCT WELL BEFORE USE.

**PESTICIDE DISPOSAL**: Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of Federal law. #### **CONTAINER DISPOSAL:**

#### Nonrefillable container

**Plastic Containers:** Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. Then offer container for recycling if available, reconditioning if appropriate, or puncture and dispose of in a sanitary landfill, by incineration, or if allowed by State and local authorities, by burning. If burned, stay out of smoke.

**Triple rinse** as follows: For containers with capacity equal to or less than 5 gallons: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Add water - at least 2% of the container volume, and up to 1/3 of the volume of water needed to make the proper slurry composition with a maximum of 1/4 of the container volume - and recap. Shake for 30 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. If used in application equipment, adjust the slurry volume application rate to account for any added rinsate water.

For containers with capacities greater than 5 gallons: Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Add water - at least 2% of the container volume, and up to 1/3 of the volume of water needed to make the proper slurry composition with a maximum of 1/4 of the container volume. Replace and tighten closures. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 60 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. If used in application equipment, adjust the slurry volume application rate to account for any added rinsate water.

#### Refillable container

Refill this container with pesticide only. Do not reuse this container for any other purpose. Cleaning the container before final disposal is the responsibility of the person disposing of the container. Cleaning before refilling is the responsibility of the refiller.

To clean the container before final disposal, empty the remaining contents into application equipment or mix tank. Add water - at least 2% of the container volume, and up to 1/3 of the volume of water needed to make the proper slurry composition with a maximum of 1/4 of the container volume. Replace and tighten closure. Agitate vigorously or recirculate the rinsate with a pump for at least 2 minutes, ensuring that the rinsate rinses the walls of the container. Empty the rinsate into application equipment or rinsate collection system, for later use or disposal. Repeat this procedure two more times. If used in application equipment, adjust the slurry volume application rate to account for any added rinsate water.

**Recycling**: Once cleaned, some agricultural plastic pesticide containers can be taken to a container collection site or picked up for recycling.
