For best results use as a preventive application before diseases appear, or apply at the first sign of the infection. If heavy rainfall or flooding occurs after treatment or if disease is severe or reappears, treat area again. Follow the rates and comments as listed below for control of turfgrass diseases. NOTE: Apply the high rate when disease is severe and use low rate when disease pressure is light. Treated area should be watered lightly as soon as possible after the application to wash the fungicide down to the soil level.




