Sealed Tenders are invited from the interested parties registered with Food Corporation of India for purchase of 268 MT Non-issuable(damaged) belonging to Raw Rice Gr.A variety foodgrains lying at various depot/Centre under NEF region on “AS IS WHERE IS BASIS.” State Departments and Agencies having registered/licensed feed stocks manufacturing plants and/or poultry feed manufacturing plants are eligible to participate in this tender enquiry.
